Trustee Report

The Trustees are pleased to present this report and accounts for the year ending 30 June 2017.

Structure, Governance and Management

The Believe & Achieve Trust ("the Charity") is a registered charity with the Charity Commission (Number 1157173). The Charity is governed by the Trust Deed of 8th May 2014.

The Trustees are responsible for the administration of the Charity. The Board of Trustees meets at least 4 times a year. The Charity is operated by volunteers with no paid staff. Alison Williams is Chief Executive Officer.

The charitable objects are:

- (1) To promote and protect the physical and mental health of sufferers of meningitis in Tameside through the provision of financial assistance, support, education and practical advice.
- (2) To advance the education of the general public in all areas relating to Meningitis.
- (3) To promote the participation and inclusion of disabled (but not exclusively) children and young people in Tameside in healthy recreation through the provision of financial assistance, support, education and practical advice.

Activities

2016/17 was our third year of operation and another very busy one. We:

- made 20 grant awards totaling nearly £10,000. These grants included specialist equipment to enable involvement in sport, and kit to enable young people to participate fully in their chosen sport.
- raised awareness of meningitis through talks and distribution of signs & symptoms cards (provided through our partnership with Meningitis Now).
- organised our own fundraising events and supported others with their fundraising

Finances

As a Charity dependent on voluntary donations to continue our work, we are very grateful to everyone who helps us to raise the vital funds we need to continue our work. During the year our income was £30,088. This came from our own events, supporter fundraising and donations from individuals and organisations. Our own events included our special Christmas Concert and our Ball. These events also help to raise awareness of meningitis.

Our expenditure in the year was £26,579. Nearly 60% of our expenditure was on grant awards and raising awareness, with the remainder on raising the funds we needed.

The surplus in the year was £3,509. Our closing cash balance was £14,096.
