Chairman's Report 2016-2017

To new members a very warm welcome. Do please join in our activities as much as you can, your participation will be appreciated.

Time passes and this is my 13th year as chairman. Highlights of the year to the 31st of March 2017 were: a successful excavation at Clitterhouse Farm, a great HADAS holiday at Bradford-on-Avon, and an excellent Christmas party. Our dwindling number of active committee members worked very hard to bring you these events as well as carrying out all the normal routine tasks.

The key activists were **Jo** and **Jim Nelhams** (Secretary and Treasurer respectively) who organised and ran the HADAS holiday at Bradford-on-Avon. They also ran the Christmas party with help from **Vicki Baldwin** and **Liz Gapp**, which this year featured a hot sit-down meal rather than a buffet as previously. **Bill Bass** managed the excavation side of HADAS's activities. The Sunday group, under Bill's supervision, ensure that we carry out the post-excavation work on our digs up to Museum of London standards. **Stephen Brunning** (Membership Secretary) organised an excellent series of lectures. **Roger Chapman** (Publicity) tackled the thorny problem of the HADAS web site and it is hoped to have a new site during 2017. **Peter Pickering** (Vice-chairman) checked Barnet planning applications for the need to apply archaeological conditions and passed any perceived requirements on to Historic England, he also kept me abreast of other heritage-relevant legislation. **Sue Willetts** and **Mary Rawitzer** ensured that the HADAS monthly newsletter was produced, printed and distributed on time. Each monthly newsletter is edited by a different HADAS member from articles submitted mainly by members. The members' articles are probably the main interaction they have with the Society. We are very grateful for their contributions. **Eric Morgan** kept us up-to-date on other societies' activities. My thanks are due to all of them for their hard work.

The HADAS Finds Course tutored by Jacqui Pierce had 15 members and this year started processing the finds from a Birkbeck excavation in 1999 at Lant Street in Southwark. The excavation was project managed by Harvey Sheldon, our President. The course is concentrating on identifying and recording the artefacts from the dig and re-labelling the packaging up to Museum of London standards before depositing them at the London Archive and Research Centre (LAARC). The project is expected to take a couple of years.

All-in-all the HADAS year to the end of March 2017 was a successful one. I mentioned the dwindling number of activists above and they and I are getting older, it is important for the future of your society that more members participate in the running of the organisation. This report represents the membership year 01/04/16 to 31/03/17.

HADAS AGM Fieldwork Report 2016-2017

Claremont School Assembly Talk

On June 20th 2016 members of the HADAS Fieldwork Team gave a talk to the gathered assembly of the school which is located opposite Clitterhouse Farm. The talk explained some of what archaeology was and how it related to the local area. A number of finds were passed around for inspection.

Clitterhouse Farm Excavation 2016

This was held Weds 20th July to Weds 27th July.

Clitterhouse Farm, Claremont Road, Cricklewood, NW2 1PH

Site code: CTH16, NGR: TQ 23689 86819. **Fieldwork Report 2016-2017 (continued)**

Clitterhouse Farm, a moated manor site has a long documented history. Archaeological research work is being carried out to try and establish the possible Saxon/medieval and later layout of the site.

Following on from work here in 2015 HADAS members conducted a resistivity survey and a further 3 trenches were excavated outside the northern corner of the main building complex. In two of the trenches a pair of brick built wall foundations were seen and are thought to be possibly the 'wheat-barn' or 'cow-shed' originally erected c1600-1700 (seen on a map of 1715) and demolished c1900. Above this was much mixed clay and demolition rubble. Finds included a small amount of 11th to 14th century pottery through to 19th century material.

Also seen were accumulated build-up of gravel layers provisionally interpreted as the former farmyard make-up, containing ceramic and other finds from the former occupation of the site. Natural London Clay was reached in some of the excavation, elsewhere it had been truncated by the 'wheat-barn' construction described above. A report will appear in a forthcoming Newsletter.

Hendon Baptist Church Display

On the 3rd Sept HADAS took part in a day event on local history and archaeology in the Hendon area organised by Jacqui Pearce. HADAS members displayed various finds from our collection and gave some of the talks and presentations, others were on hand to chat with members of the public.

Clitterhouse Farm 'Fete'

Held on the 17th Sept in slightly windy conditions, HADAS members gave a display of recent work, finds and excavations conducted at the farm to members of the public.

RAF Museum, Hendon

During Feb 2017 HADAS member Andy Simpson undertook some site watching at his place of employment. The museum is currently being partly redeveloped as part of a HLF funded project. A selection of Victorian and later finds were found and reported in the March 2017 HADAS Newsletter.

The Basement Room

The nerve centre of the HADAS Fieldwork Team at Avenue/Stephens House continues to be used for processing finds, archiving material and drinking coffee (not always in that order), mostly on a Sunday morning. Currently finds from the latest Clitterhouse Farm dig are being washed, marked, identified and listed.

Planning Applications

HADAS continue to monitor planning applications throughout the borough and comment on them where necessary. A meeting was held with Barnet Council to clarify procedures within the planning system.

Battle of Barnet

Although HADAS are not directly involved, a large ranging metal-detecting survey led on the ground by Sam Wilson of Huddersfield University continued in summer 2016 on farmland to the west and north of Kitts End and Wrotham Park. A series of 'test-pits' were dug in the Kitts End area which found some medieval pottery. At some point there may be a dig to identify the location of the 'chantry' chapel which might indicate where burials from the battle are to be found.

The finds are being processed at Barnet Museum. There were a number of lectures related to the battle during the summer of 2016 and Sam is due to give a talk to HADAS later in 2017. The project appeared on a recent edition of the 'Digging for Britain' TV series.

LAMAS Conference 2017

HADAS members attended the conference with this year's mixture of talks on recent archaeological work in London. HADAS had a table of books for sale along the work of other societies.

Many thanks to the Fieldwork Team and members for their effort over the last year in these projects.

The Society is fortunate in the large legacy received from the late Ted Sammes. Some of this has been invested in charitable funds managed by Mercantile and General. It is understood that this should be used to continue Ted's work, in particular to document the digs which took place under his leadership.

These investments have performed well, and enabled us to maintain our reserves though we must understand the warning that "investments can fall as well as rise". Nevertheless, it must be repeated that our subscriptions do not cover our annual costs of newsletters, lectures and rents. Our net outlay of £2761 equates to around £18.50 per member.

As always, the annual accounts show a snapshot at a point in time. The receipts and payments show the movements since the previous snapshot. Thus what is included can depend very much on timing.

Notes on statement.

- 1. We have not yet claimed the Gift Aid for the previous year.
- 2. The bills and contributions for outings straddle the financial year end. Hotels are increasingly asking for early deposits on room bookings.
- 3. CAFBANK have found it necessary to impose a monthly charge of £5 since November 2016, since they are not making interest on our deposits. Effectively, we are now receiving a negative interest rate.
- 4. Lectures now cost us £110 for the room plus the lecturer's fee. We also required a new projector during the year.
- 5. We took advantage of a change with the insurance market breaking the previous monopoly to use a new insurer.
- 6. I have restructured the presentation of the sales of our investments. In 2016, the realisation of Charifund was shown under **income** rather than a transfer of assets.

At the time of writing, the accounts have not been inspected by our Independent Examiner, Stewart Wild, who kindly carries out this duty on behalf of the membership.

Examiners Report

Basis of examiners report
