# DIRECTOR'S REPORT FOR THE YEAR ENDED 31 MARCH 2017

Theatre Absolute Limited is registered as a charity.

# Objectives and activities

The charity is a company limited by guarantee and is therefore governed by its Memorandum and Articles of Association. The charity's aims are to encourage and advance the education of the public in the appreciation and practice of the arts, by increasing access to the arts, in particular through the production and provision of contemporary theatre plays, and associated participatory performance, literacy and educational activities delivered principally for the benefit of, but not limited to, young people and other persons who require help with literacy, communication, behaviour or self-help skills, social development, self-esteem and confidence building, with a view to empowering and educating them in such areas and integrating them into the community and assisting their development as full members of society.

The charity's main objectives for the year April 2016 to March 2017 were:

To continue to increase the awareness and profile of Theatre Absolute and its work within the City of Coventry (where the company is based), as well as throughout the West Midlands region

- Provide access to high quality theatre events and participatory arts activities to the community at an affordable price.

- Provide opportunities for young people and the general public to participate and volunteer in theatre events and live arts activities

- Support local organisations, and artists with development space at the Shop Front Theatre

As well as setting out the above objectives for this year, the company has actively achieved the following:

April 2016 saw Theatre Absolute hosting Rideout, a regional arts organisation dedicated to ideas of creative rehabilitation, in the Shop Front Theatre (SFT). They ran their live installation 'Go To Jail'. It was targeted at all age groups, with an emphasis on difficult to reach young adults. Following on in May, we continued our support for Charles Ingram who is an emerging and Coventry based theatre director. Utilising the SFT space, he staged his first production with his newly formed Project Theatre Company. The month also saw Theatre Absolute continue its long standing relationship with Coventry University by hosting the latter's 3<sup>rd</sup> year performing arts students as they produced their own shows at the SFT.

In June, exploring new ways to use the SFT, city based digital artists Random String hosted their annual festival of creative technology. July saw a dedicated week of The Challenge, a nationally based charity committed to creating projects that bring people together to develop confidence and skills. They used the SFT to work locally with Coventry schools and colleges. Within the same month, Theatre Absolute brought together six diverse artists to explore a new work called ARC, via an ensemble approach, and through its @38 programme also supported the development of 'Baby Daddy, a new play by local writer and actress Ellinor Coleman.

September brought about two collaborations for Theatre Absolute. At the beginning of the month, the company created 'Montague's Song' with Talking Birds, in tribute to a fallen soldier from Coventry who died in the Battle of the Somme, in 1916. It was performed at St. John's Church, Coventry to over 500 people. The end of the month saw the company working in residency with Imagineer Productions to develop ideas towards new work for the Festival of Imagineers which celebrates art, science and engineering.

Building on the company's central importance to Coventry's City of Culture bid for 2021, in October, Theatre Absolute were asked to perform an extract of its piece TRAUM for Darren Henley, CEO of Arts Council, England. In November, the company was commissioned by the Rising Global Peace forum to perform its play BREATHE for national and international delegates in partnership with the Cathedral and Coventry University. In the same month, support continued for Coventry University's students as the Shop Front Theatre was used to host We Have A Situation Coventry! a multimedia interaction addressing cross cultural issues.

December saw the return of Late Night Shopper at the SFT, which was first piloted in 2016. It staged the premiere of 'Instrumental', a collaboration between local actors Rishard Beckett and Richard Walls, and a new piece by break dancer Andrei Roman.

In January 2017, the company revived its collaboration with Moving Spaces to showcase TRAUM at Deda Arts in Derby, and in March the company hosted Shoot! Festival for a third year running. The latter has grown to become an important festival for emerging artists in Coventry, and Theatre Absolute is proud of its continuing success, having supported its producers from the very beginning giving them space and mentoring support to develop their festival ideas.

### **Public Benefit**

Theatre Absolute maintains the offer of access to high quality live theatre and participatory arts activities to the general public at an affordable price.

In January 2017, the company secured a two year Grant for The Arts from Arts Council England which means it will create 9 new pieces of work to commission with at least 6 of the works being by female writers. This will offer a wide range of high quality new work and participatory opportunities for audiences, extensive employment opportunities for artists, and paid internships for students local to Coventry and the region.

Theatre Absolute also continues to offer voluntary opportunities at the Shop Front to the local community. The 'Shop Keepers' are recruited from 16 to retirement age, to support the Shop Front Theatre during events and shows, working on box office, ushering, collecting information and the opportunity to engage themselves with professional artists, actors and directors.

As described above, the company operates its @38 programme, which offers access to artists and participants of all abilities and ages, in writing for theatre, mentoring and development of new work.

Additionally, the company has undergone a period of support toward sustainability, supported by Coventry City council, and mentored by Alun Bond. It was a significant period of consultation as it has laid the foundation for increased good practice and increased financial sustainability for the company.

### Summary

The year was a very fruitful one for the company. It enjoyed several new collaborations with local arts organisations and partners, and continued to extend the breadth of its support to the community for the use of the Shop Front Theatre. This in turn is a strong signifier of the need for such a space in the city. As mentioned above, via financial support from Coventry City council, the company underwent a period of consultation which it believes places it on a firmer footing for the future both artistically and in its infrastructure. The company also continued to make strides providing one to one mentoring to beginning, emerging and established artists via its @38 programme, funded by the Esmee Fairbairn Foundation, with the prospect of an exciting collaboration via @38 with Coventry University through late 2017 and into 2018.
