The advancement of education of Iranian and Middle Eastern arts, culture and heritage for the benefit of the public, the Iranian and Middle Eastern community in London, England.

Summary of the main achievements of the charity during the year.

Since March 2008 the charity managed to stage four cultural events to educate Iranian, Middle Eastern and non Iranian people about the history of different culture and art in different parts of Iran and Middle East.

We invited artists from different countries to participate in our programmes. So far in our last four programmes we invite artists from America, Germany, Turkey, France, Japan and Austria to achieve this purpose.

The first two events were free to the public but in last two events the minimum charge of tickets were £30.00 and £10.00. more than 40% of tickets were given complementary to the guests from different communities.

From time to time our organization also pays donations to other organizations to help them. We also consider if we get the genuine request from the students for the higher education.

The 8^{th} programme of the Toos Foundation is titled The Silk Road and is presented as A Tribute to Amir Khosrow, the renowned Persian-Indian musician and Sufi-poet of the 13^{th} -Tribute to Amir Khosrow, the renowned Persian-Indian musician and Sufi-poet of the 13^{th} linked the Chinese and Persian Empires to Europe and the Roman world – was the most significant international trade route. This route not only brought the largest volume of goods and services to people everywhere but was instrumental in the global exchange of art and culture and the general broadening of human knowledge and understanding. These exchanges influence us even today.

Many thousands of arts and craftsmen from the many differing nations along its routes not only learnt from each other through trade but also helped reduce religious an dnational tensions and increase international peace and harmony through art and culture. Amir Khosrow, born into a Turkish family from North Khorasan living in Delhi, India, typifies this so well. He was a Persian speaking Suff poet and a renowned musician of the 13^{th} century. He was instrumental in bringing Iranian and Arabic musical traditions to India. Through his efforts, many of the ancient Iranian musical compositions now extinct in Iran itself are still preserved and replayed within the North Indian classical music.

The event is, therefore, devoted to Amir Khosrow, deservedly so well loved and respected by peoples of different nations Along the Silk Road. Inspired by the stories of Marco Polo's travels, the programme will take the audience to a few of the main countries and cities Along the Silk Road and bring to light, through poetry, prose, music and dance, a few reminders of this rich history of artistic exchange. We are planning to have another concert in Los Angeles in 2015 but so far we haven't decided the name yet.

This film is under the banner of Toos Foundation which will be fully funded by Toos.

This film is about a girl who left Iran/her birth country to England when she was very young. Her father a writer and producer was in Iran when the Islamic revolution happened, he was imprisoned many times and left a numerous letters to his daughter, explained the political situation and reasons, only after his death on 2015, she returned to Iran and discovered all the letters.

The arch of the story is about the revolution in Iran, why & how it happened. But the effect of the revolution is seen through the personal costs to individuals. The human rights of children affected and displaced, the lives of families displaced, disoriented and disenfranchised from the host communities which they have to establish as 2^{nd} homes as refugees. The human rights of this vast body of people are seen as the small stitches that make up the grand tapestries of wars and revolutions that make for News headlines.

The Islamic Revolution of Iran was the first in modern history to be a complete overthrow of an established regime in the Middle East. Since then, in the last 37 years, we have seen a number of other countries fall and disintegrate to wars, 'regime change' or internal strife. Across the region, millions from Kurdistan to Afghanistan, Syria and Iraq the story is the same for the people, even if the reasons, conditions and political rhetoric are different.

So far we have not decided about our next concert, the trustees are going to decide about the country and the date. We are trying to negotiate with the artists from India, Pakistan and Bangladesh. We have already seen some artists in India but still could not finalize due to the date and the country.

Toos Foundations also donated \$15,000 to the International Council Yong Loo Lin School of Medicine in Singapore.

We are trying to negotiate with artist in USA, after we finalize this the dates then we will decide about our next concert after the success of our last concert in Los Angeles we are very much interested to have another concert in Los Angeles. We can only decide to stage our next

concert in LA after we finalize the date. We will also try to take dancers and one or two singers from London.

We further invested money in Phoolan Devi to complete the project which is on final stages and soon will be finished to release the film.
