STRUCTURE, GOVERNANCE & MANAGEMENT

The Belvoir Cricket & Countryside Trust (BCCT) is a company limited by guarantee, registered in England and Wales on 21st January 2009 (company number 06798047). It is a registered charity in England and Wales (1131442) whose purpose is to advance the education of children through cricket and the countryside. The Charity is governed by its Memorandum and Articles of Association. The Trustees are also directors of the Company for the purposes of company law.

A panel comprising existing Trustees selects any new Trustees. Trustees are elected and retire in accordance with the Memorandum and Articles of Association. The Trustees hold regular meetings.

Risk Management

The Trustees have assessed the major risks to which the Trust is exposed, in particular - those related to the operations and finances of the Trust and are satisfied that the systems are in place to manage the Trust's exposure to the major risks. In particular - those who are likely to be involved with children are required to pass DBS checks (formerly CRB checks).

OBJECTIVES AND ACTIVITIES

Our main Charitable Objectives are;

- ✓ to provide or assist in providing facilities for the playing and development of the game of cricket and other games or sports on a recreational basis for the leisure time occupation of such persons who have need for such facilities by reason of their youth, age, infirmity or disablement, poverty or social and economic circumstances or for the public at large in the interests of social welfare and with the object of improving their conditions of life;
- ✓ to advance the education of children and young people through such means as the Directors think fit in accordance with the law of charity;
- ✓ to further such other exclusively charitable purposes as the Directors may from time to time decide

BCCT's aim is to encourage participation in cricket in rural communities and to create access to cricket and the countryside for disadvantaged young people. Our target groups are young people who want to play cricket and enjoy the countryside, adults who want to develop their coaching skills, and families that want to strengthen their community ties through sport.

More specifically Belvoir Cricket & Countryside Trust has three clear aims:

1. Engaging young people and families living in rural communities in regularly playing and watching cricket; putting sport at the heart of the community.

Our 'cricket in rural communities' programme, based on the successful Belvoir Bees' model, delivers first class cricket coaching to young people. The programme is equally supportive of those seeking to develop sporting excellence and of those who want to just 'have a go' in a friendly, family orientated environment.

2. Creating access for disadvantaged young people to cricket and countryside activities.

Our Cricket and Countryside School Days combine opportunities for disadvantaged school children to participate in sports such as cricket and orienteering with educational activities that introduce them to the working life of the countryside.

3. Encouraging adults to regularly participate in sport as volunteer cricket coaches.

Our training programme for our volunteer coaches not only develops their cricket skills but equips them also with the coaching skills to deliver first class cricket coaching to young people.

ACHIEVEMENTS AND PERFORMANCE

In our ninth year we have continued with our core projects – Belvoir Bees, Cricket & Countryside School Days, Special Needs in School and Days at Belvoir Castle, the Teach Cricket in School Coaching programme and the Volunteers programmes. These projects are supported by 61 coaching and educational volunteers from the local community. In particular;

Belvoir Bees

- 265 children enjoying 130 hours of Community Coaching
- ✓ giving children, 4-11 years, the opportunity to play sport and learn skills on a regular basis
- ✓ encouraging involvement of adult volunteers in sports activities
- ✓ involving all members of the family in the activities through social interaction in a rural community

The Trust continues to offer "Belvoir Bees" sessions at a number of rural / small town venues (typically a small cricket ground). These sessions provide a taster, not only for children to participate in sport and learn skills, but also provide a focussed way for local families to meet and generally become more involved in developing their community. This project is cricket based but encourages participation at all levels of skill. It is NOT a Cricket Club – and there are no team selections. It promotes inclusion and regular 90 minutes activity on a weekly basis through the summer months.

During 2017 the Belvoir Bees model was delivered in 7 rural / small county town communities, with the support of 24 local volunteers. Through the introduction and running of the Belvoir Bees the Trust has been instrumental in the regeneration of small, rural and in some cases failing cricket clubs by working with them to develop sustainable junior cricket sections and enabling a pathway for youngsters to access competitive junior cricket:

Our 2017 venues:

Harlaxton Cricket Club

- 5 children registered
- 1 regular volunteers

Great Dalby Cricket Club

- 28 children registered
- 6 regular volunteers

Huntingtower Academy, Grantham

- 19 children registered
- 2 regular volunteers

Hose Village Hall

- 29 children registered
- 3 regular volunteers

Belvoir Cricket Club, Knipton

- 98 children registered
- 6 regular volunteers

Barrowby Cricket Club

- 37 children registered
- 4 regular volunteers

Asfordby Village Hall

- 49 children registered
- 2 volunteers

Belvoir Bees has totally exceeded our expectations. Our 5-year-old absolutely loves going to cricket. The children are totally engaged and eager to take part which is testament to the coaches and programme as a whole. It has been a delight to be involved in such a brilliant activity. Thank you. I can heartily recommended Belvoir Bees cricket coaching. The atmosphere is just lovely for children and parents. The coaches are so welcoming and make a huge effort to include all the little ones, no matter where they are starting from. In 2018, the Belvoir Bees project will continue at at least 7 venues – We plan to introduce grading, assessments and records of achievement. The sessions will also be used to further encourage volunteer engagement and community integration through the introduction of friendly competitive cricket across the venues i.e. Bees Tournament.

To continue the development of junior cricket for 11+ the Trust will continue to work closely with local clubs in supporting them until they become self-sufficient in running their own junior cricket. The Trust will also support Belvoir Bees venues in working with the English and Wales Cricket Board (ECB) and nurturing relationships with the regional ECB Boards to develop and grow these Cricket Clubs.

Cricket and Countryside School Days

- ✓ 1,585 children and 100 school staff attending.
- ✓ giving the opportunity for primary school children and youngsters with special needs to visit the countryside
- ✓ giving children aged 6-11 years the opportunity to partake in sporting activities and get a feel for the countryside
- ✓ introducing children to the game of cricket

The Trust aims to help the education of primary age children (and older children with special needs or disabilities). This is delivered by bringing children to the countryside and offering them multi-activity days which will include cricket, healthy lifestyle choices, countryside pursuits and farming/rural issues.

In the summer of 2017, a total of 24 schools visited Belvoir giving 1,585 children access to cricket and countryside activities. With the support of Her Grace the Duchess of Rutland and the Belvoir Estate staff and local volunteers – both sport coaches and those involved in the local countryside – over 280 hours of volunteer time was spent with the children. The days typically included 2 hours sporting activities/coaching and 2.5 hours of 'education' - learning about the countryside from local people such as the farmer, woodman, fisherman, gamekeeper, huntsman etc.

In 2018, we will continue to extend the reach of the Trust to include schools from within Leicestershire, Lincolnshire, Nottinghamshire and Rutland where the school days will be used to promote all the Bees venues. We will also look to partner with other similar organisations that deliver 'outside' education. We will also be working closely with the Schools to enhance the educational and lifestyle messages that are delivered and where possible look to twin schools from different backgrounds (i.e. small rural schools with larger, multi-cultural inner-city schools).

In 2017 we introduced a learning resource for schools which provided a project for teachers prior to their visit and also a follow up after their visit. The aim of this is to support our schools and provide longer exposure of countryside learning to all children involved with the BCCT. It has been very well received by teachers and children alike and we will review the results with a view to improving it and keeping it relevant year on year

Special Needs Programme

- ✓ 424 youngsters from 16 different schools taking part in Kwik and Table Cricket sessions
- ✓ 105 hours of curriculum coaching delivered
- ✓ 40 volunteer hours given
- ✓ Kwik cricket delivered to 90 children in 5 different schools
- ✓ Table cricket delivered to 195 children in 16 different schools
- ✓ Cricket & Countryside day delivered to 64 children from 5 schools
- ✓ Table Cricket Tournament delivered to 75 children and 8 different schools
- ✓ giving youngsters with special needs the opportunity to play sport and learn skills on a regular basis
- ✓ supporting Special Needs schools to facilitate and provide active sport for their young people
- ✓ providing Continuous Personal Development (CPD) opportunities for school staff
- ✓ enhancing the school's curriculum delivery

Our Special Needs school days and in-school cricket coaching throughout the winter were again supplemented with a project of Table Cricket that enabled children with severe physical disabilities to participate in cricket.

The Table Cricket element was complimented by a 'Finals Day' held at the Lee Westwood Sports Centre at Nottingham University which was supported by 8 schools. This was delivered in partnership with the Nottinghamshire County Cricket Board and the Lord's Taverners – and was a huge success. Our winners the Beech Academy went on to represent the Midlands in the finals day at Lords where they performed creditably. We aim to repeat it in 2018.

Over a 5-week period (February - March), 16 schools each received weekly cricket coaching from Trust Director Darren Bicknell and Trust staff with on average 27 children taking part at each school. This programme is supplemented by giving these children the opportunity of taking part in a Cricket and Countryside School Day at the Belvoir Estate during the summer.

Teach Cricket Programme

- Providing 550 children across 13 schools with 57 hours of professional coaching
- Enhancing school's sports curriculum delivery and after-school club provision
- Providing exit routes for children to continue with out of school sport.
- Providing CPD opportunities for school staff.
- Delivered a new Teach Cricket Tournament which involved 5 schools playing a Kwik cricket tournament at the Knipton cricket ground.

Our, in-school programme works with rural schools to enhance their sports curriculum provision providing cricket opportunities for children.

Cricket is all-inclusive and not only provides physical education but can also contribute to the curriculum in many ways:

- ✓ Physical education (playing cricket, learning skills)
- ✓ English (match reports, verbal communication)
- ✓ ICT (scoring, scorecards / books)
- ✓ Mathematics (scoring, run rates, strategy)
- ✓ Citizenship (rules, responsibility, teamwork and individual contribution, etiquette, strategy, diplomacy)
- ✓ Personal, social and health education (role models, active and healthy lifestyle)

During 2017 the programme was delivered in 13 Vale of Belvoir Primary Schools, all of which were outside the boundaries / catchment for the well-known Chance to Shine project. Our programme was over a 3-week period where each school received weekly cricket coaching sessions.

Volunteers

- ✓ 61 Volunteers who delivered 825 hours of support
 - Involving adults in volunteering enabling them to actively contribute to their local community.
 - giving focused skills training for specific needs of the Trust projects – without getting hindered by administration/qualifications
 - giving volunteers clear responsibility to help coach – without the administrative or responsibility burden associated with helping at a sports club (e.g. can you join the committee; will you ring around the parents; can you organise the fixtures; can you buy the cricket balls; etc.)

The scheme continues to be hugely successful with 61 volunteers (both coaching and education) from the local communities working in the Trust's projects in 2017.

The Trust's Chief Executive delivers training workshops for our cricket volunteers to not only develop their knowledge of cricket but their communication and teaching skills & techniques.

The Trust ensures that these volunteer hours are spent on direct contact hours with the children and not on administrative tasks.

Additional volunteers have also come forward to help with fundraising and administration such as child registration at sessions.

In 2018 we will continue to increase our volunteer network through communication and actively engaging with the parents and local community, whilst continuing to develop lead coaches at each of the venues. We will also assist in developing and nurturing members of the local cricket clubs to enable those clubs to continue in the development of junior cricket.

PUBLIC BENEFIT

The Trustees have had regard to the guidance issued by the Charity Commission concerning public benefit. They are satisfied that the information given in various sections of this report demonstrates that the requirements to identify public benefit have been met.

PLANS FOR FUTURE PERIODS

The Trust needs to generate income to cover its core administration costs – and provide funding for development of its youth based projects as set out in this report.

During 2018 the Trust will work towards consolidating and improving the established projects and continue with roll-out of the pilot projects through measured and sustainable growth:

The Trust is also working to develop the facilities at the Knipton Cricket Ground, to provide an indoor base with which we could deliver our activities all year-round. It is early days but we have undertaken a scoping study with the support of Focus Consultants, drawn up a Business plan and have begun applications for funding. It will take a significant investment to achieve our goal in developing our charity further, but we are determined to look at ways in which we can grow.

Belvoir Bees

- ✓ introduce grading, records of achievement and assessment
- ✓ work more closely with local clubs to encourage and nurture junior talent ensuring a pathway to hard-ball and competitive cricket
- ✓ recruit professional coaches to manage the coaching delivery of the Belvoir Bees project
- ✓ ensure the legacy of junior cricket is shared by the whole community, encouraging active involvement of all parents, families and community members
- ✓ facilitate a series of friendly, competitive matches between the different venues to encourage development of junior teams at the Clubs

Cricket and Countryside School Days

- ✓ develop links with other like-minded organisations who deliver countryside messages
- ✓ extend children engagement through linking the school days to a Belvoir Bees venue
- ✓ develop a new learning resource to provide further engagement with the Trust
- ✓ consider twinning rural / urban and inner-city schools to enhance the cultural and learning experience

Volunteers

- ✓ work to find and train more like-minded people
- ✓ aim to establish a support network for our volunteers to improve their own skills
- ✓ maintain enthusiasm and provide a clear picture of our aims and goals
- ✓ Continue to look for personal development opportunities for volunteers – like the Cricket without Boundaries trips to Africa.

Special Needs Project

- ✓ partner with both Nottinghamshire and Leicestershire County Cricket Boards to deliver Table Cricket to 16 schools
- ✓ continue to establish links with regional LEA special needs co-ordinators, regional cricket boards and directly with the schools
- ✓ establish and aid development for all children, aiming to develop links with local special needs clubs providing a clear pathway for those interested and able to progress

Teach Cricket Project

- ✓ run the project at 15 rural schools
- ✓ work more closely with the schools to develop the cross-curricular activities
- ✓ Providing an initial interest for these children to progress to our Bees Sessions
- ✓ Assist teachers to develop their own 'Teach Cricket Skills'
- ✓ Deliver a school tournament day and a BCCT Trophy for the school doing the most to promote the game of cricket in the school and its local community.

The Trust is actively engaged in the search for Grant awards and private donations, with some funding already in place for 2018. Trust Chief Executive, Darren Bicknell, will continue with the 'ambassadorial' work and the fundraising events will be planned strategically to maximise return and engagement with Stakeholders - raising the profile of the Trust and ensuring the message is communicated to the 'larger' cricketing community.

Many events are planned for the year to September 2018 not only to generate funds but also, to raise the Trust's profile within the East Midlands business community and the Cricket Community at large. Such events include:

- ✓ The Duchess of Rutland XI vs. MCC and other major matches
- ✓ Corporate Golf day
- ✓ Charity Dinner in the Long Room at the Lords Cricket Ground
- ✓ Cricket Bat Willow
- ✓ Friends Scheme
- ✓ Belvoir Castle Charity Clay Shoot Event

- Prepare the accounts on a going concern basis unless it is inappropriate to presume that the charitable company will continue in business.



FINANCIAL REVIEW FOR THE YEAR ENDED 30 SEPTEMBER 2017

The accounts, which follow on pages 11 to 17, show net income of £6,242 for the year compared with net expenditure of £18,267 in 2016. The latter figure includes extraordinary payments of £17,820 in respect of the proposed development of the new centre to which reference is made on page 7 of the Trustees' Report.

Income for the year saw an 18% increase in donations and grants from £82,250 to £97,264. This outweighed the fall in fundraising income from £12,753 to £4,658 resulting from the Lord's Dinner event in taking place in October 2017 and thus falling in the 2018 financial year.

The Lord's event has raised anticipated net funds of £15,000. Any amounts received or paid in advance of 30 September 2017 in respect of that event are included on the balance sheet, explaining the increase in debtors and creditors in the accounts at that date.

The net cost of running our charitable activities increased from £14,677 to £30,398, mainly due to a drop in restricted funding from £44,842 to £28,788.

Our overhead expenditure, including marketing and promotion, showed a slight decrease from £26,201 to £25,914.

Future Liabilities

During the next year it is expected that the Trust will enter into a lease with the Belvoir Estate under which an annual amount of £1,000 will become payable for the rental of a cricket ground at Knipton. However, a similar amount will be received by the Trust from Belvoir Cricket Club for the use of the ground.

Reserves Policy

It is the aim of the Trustees to build sufficient reserves to enable the Trust to undertake longer term projects in addition to ensuring that all liabilities, both current and future, can be met as and when they become due.

At 30 September 2017 there were unspent restricted funds received for Cricket and Countryside Days of £1,782. The unrestricted funds of £57,515 are considered by the Trustees to be adequate and in line with the stated policy above.


