Minutes of Annual General Meeting

Held on 7th December 2016

1. Welcome and Apologies

Chairman, Gary Colby, welcomed those who attended - Ian Wells (Centre Manager), Max Griffiths (Norwich City Council), Karen Browes-Walker (Cttee), Lynda Thain (Cttee, Dance Exercise), Nicole Hensham (NLNLI), Mary Almey and June Kidney (Petanque), Ann Minter (U3A Needlecraft), Audrey Elliott (Tuckswood Youths, Ipswich Road URC), Michele Neave and Paul Williams (Norwich Best for Pets), Sarah Wells.

Apologies were received from - Cllr Chris Herries, Cllr Sue Whitaker, Kate Price (Norwich CC), Kay Hall (Dance Exercise), Pearl Cooper, Janet & David Harradine & Janet Alborough (Tea Dance), Jack Woods (Norwich Veterans Association).

2. Minutes of 2015 AGM

The minutes of last AGM (25 11 15) were accepted.

3. Annual Report

G Colby read his Annual Report. He thanked Centre Manager, Ian Wells, the Committee, and cleaning staff who contributed to the successful running of the Centre, achieving the top 5-star rating for efficiency awarded by the City Council.

4. Accounts & Treasurer's Report

I Wells said that there was no Treasurer's Report, but the Balance Sheet and Income & Expenditure were presented to the meeting. The Accounts have been independently verified. Income was down due to the loss of several groups, including the Social Club, but the bank balance was still healthy.

5. User Group Reports

Dance Exercise Class - L Thain read the report from Kay Hall (Elizabeth Kay School of Dance) who said that the class had done well and they had gained many new members through recommendation and local advertising. The class was now full due to lack of space and it is hoped that the new centre will be able to accommodate more. The class is very sociable with new friendships being formed.

Friday Youth Drop-In - Audrey Elliott read the report from the Ipswich Road United Reformed Church. The numbers attending vary each week, but there is a regular attendance of 10-15, mostly male. They have two main groups as they now welcome younger people, who integrate well with the older group. They employ 3 youth workers and there is always a representative of the church who takes responsibility for the evening. The most popular activities are x-box (loaned by ENYP), snooker, table tennis, board/card games and a chill-out zone. The URC are extremely grateful to the staff and committee of Harford Community Centre for their support, without which they would be unable to run the club.

U3A Needlecrafts Group - Ann Minter read their report. This group is new to the Centre who had needed to relocate and had come on recommendation from the U3A Bridge Group. They were very grateful for the assistance given by the Centre Manager and have felt very much at home. They are hoping to have a little more storage space in the new Centre.

Harford Petanque - Mary Almey said that she had just heard that the terrain was going to be made longer. She felt that netting would help keep out the stones which were getting on the terrain. The group meet every Tuesday morning at 10am and they would welcome new members.

Cycle Speedway - Gary Colby read their report. The Club had made the difficult decision to switch to Eaton Park for their main racing in 2016 due to lack of riders, but have still been training at Harford Park and held go-ride racing events. The move has resulted in an increase of 10 riders. There will still be some winter racing at Harford. The Club will be involved with a project called Lakenham Sport for Change by delivering coaching sessions with Lakenham Primary School. The aim is to get more children actively involved with sport in the area.

Reports were also received from - Dog Agility Exercise (Julie Guymer), Portuguese Academy of Norfolk, Afternoon Tea Dance, Norwich Best for Pets.

6. Election of General Committee

The Committee stood down and Max Griffiths took the Chair. He thanked the Committee for their hard work and said that it had been a good year for the Centre. The year ahead promised to be an interesting one for the Committee, with big decisions to be made about the move and an opportunity to have a say in day-to-day running of the Centre.

He asked for volunteers to be elected onto the Committee. Ian Wells, Gary Colby, Lynda Thain, K Browes-Walker, Mary Almey, Michele Neave and Paul Williams came forward and were elected.

7. Election of Honorary Officers

The posts for election were - Chairman, Treasurer, Secretary (Minutes).

Chairman - Gary Colby (nominated by M Neave).
Minutes Secretary - Lynda Thain (nominated by Ann Minter).

The above were elected. There were no nominations for Treasurer; Ian Wells carries out this role.

Trustees remain as before (Gary Colby, Michele Neave, Lynda Thain).

8. Appointment of Independent Examiner

Jennifer Burns (Freed of London) will continue as Independent Examiner.

9. Amendment of Constitution - No amendments received.

10. Centre Update

M Griffiths gave an update on where we stood with discussions and negotiations with ASDA. The Certificate of Completion had been issued on 9 November and we had now started a process of negotiations in connection with the fit-out of the building. We had provided ASDA with a standard specification for community centres. The plans that they had sent us were in no way adequate or acceptable to us. There would be no disabled toilet, no heating, no flooring, no ceiling, no cupboards, no insulation. Our estimate of the necessary work had been £162,000 and theirs was £70,000, and they were not willing to budge on that. In this situation, the next process was that we go to Arbitration to negotiate a resolution. A meeting was to be held with City Council and Head of Planning the next day.

Ian Wells suggested that we had a Committee meeting to decide what action we want to take. Audrey Elliott said that we should ask for input from User Groups; however, time was of the essence as the deadline was Friday.

It was decided to end the AGM, have refreshments, and then have a special Committee meeting (to which all were invited).

After refreshments, the meeting discussed suggestions and plans to settle the difficulties with ASDA with regard to the New Centre fit-out. Max Griffiths said that our best allies would be Councillors as they would be entirely behind us as representatives of the community. Our local MP should also be contacted. It was suggested that we needed to send an official email from the Trustees of the Community Centre. Emails could also go to the Chief Executive of ASDA saying that they had failed to undertake a commitment they made to provide a Community Centre which was fit for purpose. This could also be sent to the Chief Executive of Walmart in America. We would need to put together a high-profile campaign, including the Press, Radio and Facebook. Max Griffiths warned that we should be careful what we said on the radio; we needed to go through the documents and make sure what we were saying was correct.

(Max Griffiths left the meeting at about this time.)

After further discussion, it was agreed that Michele Neave and Paul Williams would liaise with Ian Wells to put all this into practice. Audrey Elliott would also put it on the URC website.

The meeting closed at about 9.30pm.

The account is still in a healthy position, which you are all welcome to look through; we will be spending some of it on new equipment and furnishings.

I hope all the user groups are enjoying the new surroundings.

Ashby Art Group

The Group has enjoyed another successful year, despite having two venue changes and a change of meeting day. A nucleus of around a dozen regular members now meet every other Tuesday afternoon to enjoy a sociable get -together, learning new skills or extending previous experience in painting, drawing or lino-cutting and so on, while enjoying the excellent facilities provided by the new Community Centre.

New members are always welcome to join a group of like-minded people and have some fun. The Group, organised by AgeUK Norwich, and led by Valerie Chambers, is open to people of all grades of experience - or none! "I haven't touched a paint brush since I was at school" a typical comment from new members, but they are soon on their way to discovering their inner Rembrandt!

Friday Youths' Drop-In

run by Ipswich Road United Reformed Church

Ipswich Road URC has been running a youth drop in at Harford Community Centre since October 2010. During that time we have got to know many of the young people in the area. The "Drop In" has changed in character over the years, but still offers the same support for the young people of the area-a place to be safe, cared for and respected with activities to promote these values to each other.

The move to the new centre has led to a new feel and a change of name we are now called "Friday Youths". During the last 12 months over 50 young people have come to the 'Drop In' with anything

between 4 and 20 per week. We regularly now have between 7 and 14 young people who are coming regularly, but the difference is that they are now coming for the whole 2 hours (often arriving early to help us set up and some offer to help clear away afterwards), and they are mainly boys who are in the 12-14 age group. This has presented us with new challenges and a more structured approach to parts of the evening is now being trialed, along with the regular activities of pool, table tennis, board games, a craft activity and x-boxes. During the year we have also introduced irregular real life skills experiences eg wood work-at Easter they made a cross to go outside the church and in the summer a table for the xbox, using old pallets. We are much indebted to Dominic from ENYP for introducing these skills.

We do not charge for the club-it is entirely financed by the church, but we do sell refreshments and have discovered that cheese toasties are extremely popular!

The Drop In is staffed by at least one volunteer from the church plus one qualified youth leader, who we employ through ENYP and one sessional support worker who we employ, usually from UEA. All staff are Christians and are DBS checked.

We are extremely grateful to the staff and committee of Harford Community Centre for their support for the group and for allowing us to store our equipment on the premises. (The ability to store everything here now has made a huge difference) Without this support, we would be unable to run the club.
