Structure, governance and management

The charity is a charitable incorporated organisation (CIO) and governed by a constitution adopted on 27 July 2013. The charity's only voting members are its charity trustees.

The charity is managed by a committee of at least 7 and no more than 12 trustees, of which between 6 and 10 are appointed by the trustees at a properly convened meeting and a further 1 or 2 are nominated by Robin Lane Medical Centre. Members serve for 3 years before seeking re-appointment or nomination.

Objectives and activities

The charity's objects

1) To advance health in Pudsey, both physical and mental, by providing a range of health related activities and interventions to enable people to live longer and healthier lives that are full and meaningful.

2) To promote for the benefit of the inhabitants of Pudsey and the surrounding area the provision of facilities for recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disablement, financial hardship or social and economic circumstances or for the public at large in the interests of social welfare and with the object of improving the condition of life of the said inhabitants.

The charity's main activities

The main activities undertaken for the public benefit in relation to the charity's objects are:

1) The provision of space within Pudsey Wellbeing Centre for a range of free, volunteer led activities.

2) A range of activities, services and community events offered through the social, health and volunteering sector.

The Pudsey Wellbeing Centre on Robin Lane is a place for our community to come together, meet new people and try new activities. Love Pudsey is the name of our charity and we want to make Pudsey a better place to live where residents live longer and healthier lives that are full, active and meaningful.

Through our volunteer programme the local community can be inspired to get involved and engage with our town. It is an opportunity for people to be creative and enables our volunteers to share their skills or life experiences, as well as being part of a friendly and supportive group. All money raised at our events and from charity fundraising is used to provide free activities for the local community.

Public benefit statement

In setting our objectives and planning our activities our Trustees have given serious consideration to the Charity Commission's general guidance on public benefit.

Achievements and performance

2016-17 has been a fantastic year for Love Pudsey, with six new volunteer led groups running at the centre alongside fifteen established groups. We would like to say a huge thank you to all our wonderful volunteers who have made this possible; without our team of volunteers the charity simply would not be able to function! We would also like to thank Robin Lane Health and Wellbeing Centre and Café Lux for their continued financial and "on the ground" support.

We have had a number of fantastic fundraisers this year, our main fundraising events were our annual Summer Fair and Christmas Craft Market! Both events were well attended and helped raise awareness of the charity in the local community.

We raised over £350 at our Summer Fair in 2016 thanks to the efforts of our wonderful volunteers! This year's raffle was especially successful and the staff in the Café kindly helped us to sell tickets!

The Christmas Craft Market was a great success with £570 raised for Love Pudsey which is a £200 increase on the previous year. We had performances from two of the Love Pudsey groups "Raise Your Voice" Community Choir and "Luxulele" ukulele group.

The charity also produced a calendar for 2016-2017. We held a photography competition with the theme of "Pudsey and Surrounding Areas" and received entries from local people in Pudsey.

The competition winners had their photographs featured in the calendar. The final product features some beautiful shots of local scenes. We received donations from local businesses which went towards the printing costs of the calendar. Thank you to all the local businesses that supported us.

Achievements and performance (continued)

The Arts programme which was funded by Leeds City Council through the Leeds Inspired fund continued to run throughout the year. The funding was used to pay a facilitator for our Community Choir and is one of the most popular groups running at Love Pudsey. There were also Poetry and a Pint evenings which run once a month in the café and consist of an open mic section where local people can perform their poems followed by a head liner performance. We had live music in the surgery waiting room and the café once a month, and received really positive feedback from these performances with many patients saying that it made them feel less anxious while waiting for an appointment. Finally we had performances in the café from Eduardo Niebla who is a virtuoso Spanish guitarist and a Cabaret Show. There are plans for more art events in 2017 – 2018.

The Youth Café has been an especially successful group, starting in January it already has twenty two members with 15-20 young people attending each week. We decided to open the Youth Café after identifying a gap in the age groups using the wellbeing centre. We had groups for babies, toddlers and new parents and also had groups for working age and retired people but only one group for young people, our Youth Choir. The charity applied for some funding from Leeds City Council through the Youth Activity Fund which was granted; the council have also provided the Youth Cafe with two trained Youth Workers who run the Youth Cafe alongside Love Pudsey staff and volunteers.

Six new volunteer led groups have started in 2016-2017, these groups are the Pudsey Lux Beaders, which is a jewellery making group; Invisible Pain Drama Workshop which is open to all but especially focussed on people with mental health issues; a Yoga group; Knit, Natter and Chit Chat Crochet in the Café; IT courses; and the Youth Café which now runs every Wednesday evening.

At the year end, the following 24 volunteer led groups were meeting regularly in the Wellbeing Centre, providing activities, stimulation, interest and a welcoming meeting place for the many local people who benefit from them.

Financial review

The net receipts for the year were £7,696, including net receipts of £6,158 on unrestricted funds and net receipts of £1,538 on restricted funds.

Reserves policy

The charity's free cash reserves at the year end were £13,747.

The charity's current reserves policy is to maintain a contingency fund as a reserve against potential cash-flow issues of approximately £5,000. However, trustees are currently reviewing that policy in the context of the charity's increased activity and income.

Funds in deficit

Leeds City Council Wellbeing and Youth Activity Funds showed deficits at year-end as these grants are paid in arrears to the charity.

1 Accounting policies

Basis of accounting

The trustees have taken advantage of section 133 of the Charities Act 2011 and have prepared the accounts on a receipts and payments basis.

Restricted funds are subjected to restrictions on their expenditure imposed by the donor or through the terms of an appeal.
