Additional details of objectives and activities (Optional information)

All our volunteers work extremely hard to help the dogs both already in our care and for those needing saving. The day to day work load is mostly shoulder by the founder of the charity Diana Brusi and Hilary Delaney. Both work hard at ensuring communications with the perreras and kennels are maintained, and the dogs are safely evacuated from danger quickly and carefully.

Diana negotiates the veterinary treatment both in Europe and in the UK together with ensuring transport is organised and all the necessary documentation that goes with it.

Hilary is the UK kennel coordinator who organises safe housing for dogs before being transferred to foster homes or adoptive homes.

The secretarial work is carried out by Jennifer Moseley who ensures minutes are recorded of the committee meetings held monthly. Petlog updates are done registering the dog to Terrier SOS once the dogs have arrived in the UK and updated again once the dog has settled into its new permanent home. Once a dog is adopted, Jenny ensures that each dog's microchip record is up to date on PetLog and then sends confirmation of the PetLog record to the adopters. Terrier SOS information is also kept on file by Petlog as backup.

This year's accounts are prepared by the charity's accountant (Paul and Maundrel, Helston) to collate and submit on the charity's behalf by Fiona Lickorish, the treasurer.

Our supporters are generous and all funds raised are spent solely on the

Still in the care of Terrier SOS were Chouquette, Cassie, Ziggy, Alfie, Kika, Lolo, Mr Darcy, Princess Georgina, Prince George with more on their way.

Sadly, we said goodbye to two of our precious Terrier SOS dogs, Elvis and Japi each with their own story, including the sad and tragic circumstances that brought them to us. We are very thankful for the love and care given in their adoptive homes. They are not forgotten by their adopters and by the TSOS Committee and friends.

Our amazing supporters continued to run, walk, sew, craft, and hold raffles and coffee mornings to raise funds for us. We held online auctions where our supporters kindly offered donations, which were won by bidders. The successful 'Treasure and Borlee hunt' continued to entertain us and help with our fundraising.

We are so very grateful to our fosterers who make such a difference to dogs; helping them to adapt from pound dogs to loving companions. Thanks also go to our home checkers and to those who help with transport who provide much appreciated support to the charity.

We cannot thank our volunteers enough for the donations and help we receive, we are truly grateful. We see these desperate dogs in need and because of your help we continue to be able to help save and change their lives. Sadly, there will always be more in need of rescue.
