To date, the majority of its charitable activities focus on older people and are undertaken to further Levenshulme Inspire Foundation's charitable purposes for the public benefit.

According to an independent evaluation carried out at the end of 3-year BIG Lottery project, the Inspired People Project achieved the following:
- 751 older people reported making new friendships, and improvements

in their confidence and wellbeing. Of those 163 are classified as 'hard to

reach'.
- 176 older people had grown in confidence in relation to using ICT,

choosing healthy lifestyles (251), accessing welfare rights (87) and employment support (39).

- 97 older people had taken part in activities such as consultations or activities to build an Age-Friendly neighbourhood and 217 have had their views and opinions forwarded to service providers.

- 153 older people have improved confidence and skills in using new technologies.

Most importantly though for future work, the evaluation showed that:

The trustees present their report and the unaudited financial statements for the year ended 31st March 2017.

Reference and administrative information set out on page 1 forms part of this report.

Objectives and activities

The objects of the Inspire Foundation are:

- a. The promotion and provision of community capacity building, including developing the capacity and skills of the members of the socially and economically disadvantaged community in such a way that they are better able to identify, and help meet, their needs and to participate more fully in wider society.
- b. The relief and prevention of poverty including financial hardship in the locality by providing or assisting in the provision of education, training, and referral with all the necessary support designed to enable individuals to generate or access a sustainable income and be self-sufficient.
- c. The advancement of education in those otherwise disadvantaged by providing and assisting training in social and physical skills of people of all ages but particularly young people, the elderly, people with mental health needs, refugees and asylum seekers. In addition the charity will assist in the provision of education for those preparing for entry to any occupation, trade or profession.

The trustees review the aims, objectives and activities of the charity each year. This report looks at what the charity has achieved and the outcomes of its work in the reporting period. The trustees report the success of each key activity and the benefits the charity has brought to those groups of people that it is set up to help. The review also helps the trustees ensure the charity's aims, objectives and activities remained focused on its stated purposes.

The trustees have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charity's aims and objectives and in planning its future activities. In particular, the trustees consider how planned activities will contribute to the aims and objectives that have been set.

The primary activities carried out by the Inspire Foundation concern the Inspired People's Project – a project to support and empower older people living in the Levenshulme area. Throughout the year over 300 older people took part in different activities including 'Exercise and Eat' sessions; 'Discussion Circle' where people receive advice and guidance; and 'Computer Buddies' where people learn IT skills. Financial review

The Foundation was privileged to receive an anonymous donation of £200,000 during the financial year to continue its work with older people in Levenshulme. The Foundation set out a three year budget for the donation which was approved by the donor before funding was released. The donation has meant that staff and activities connected with the project continued once the Lottery funding ceased last January 2017 and has meant that activities for older people can continue up to 2020.

At 31 March 2017 the balance of bank and cash was £157,273.

The Foundation also received donations for other projects, such as the Levenshulme Women's Group, which has been meeting at the Inspire centre.

At present the trustees have decided that holding reserves is unnecessary. Current staff are funded through restricted income and have contracts which come to an end when the funding ends. This matter remains under regular review and small-scale fundraising activities are being developed in order to create a small pot of unrestricted funding.

Structure, governance and management

At present the charity trustees are those appointed as the 'first trustees' when the charity was established. These trustees reserve the right to appoint further trustees for a period of three years by the passing of a resolution at a properly convened meeting of the trustee body with regard for the effective administration of the charity. This could include up to two nominated trustees from the Inspire Forum and two from Levenshulme Inspire United Reformed Church.

The organisation is a charitable incorporated organisation registered on 14 September 2015.

The trustees have no beneficial interest in the charity.

All trustees give their time voluntarily and receive no benefits from the charity.

Statement of responsibilities of the trustees

The trustees are responsible for preparing the trustees' annual report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Charity law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources, including the income and expenditure, of the charity for that period. In preparing these financial statements, the trustees are required to:

- Select suitable accounting policies and then apply them consistently
- Observe the methods and principles in the Charities SORP
- Make judgements and estimates that are reasonable and prudent
- State whether applicable UK Accounting Standards and statements of recommended practice have been followed, subject to any material departures disclosed and explained in the financial statements
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act 2011. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Notes

- 1 The financial statements have been prepared in accordance with the Charities Act 2011. As a lower-income charity under section 133 of the 2011 Act, the trustees have elected to prepare the charity's financial statements using the Receipts & Payments basis.
- 2 Related parties: The charity works alongside a company, Levenshulme Inspire Community Enterprise CIC (company registration no. 0652795). Edward Cox and Anne Priest are trustees of the charity and directors of the company. The Inspired Peoples Project (IPP) is run by the company; it was the stipulation of an external anonymous donor of £200,000 that the monies be applied to this project by the charity over the next 1 to 3 years. Amounts donated by the charity to IPP through Levenshulme Inspire CIC are £43,027. The trustees ensure that there any conflict of interest is dealt with by consultation between the CIC Directors, Foundation trustees and funders as appropriate.
