Bill Rice

It was with sadness that the trustees learned of the death of Bill Rice in January. Bill had been a trustee for many years. He had held the position of secretary and his enthusiasm and energy were infectious. His wisdom and wit were always appreciated at meetings and we were fortunate to have the benefit of his expertise and knowledge.

Property

The two properties owned by the Trust and located at 200 and 202 Holdenhurst Road, Bournemouth are occupied at commercial rates. The properties are in a good state of repair and well maintained. The use of the properties is frequently reviewed and the trustees are keen to ensure that they are always occupied.

Grants and Donations:

During the year the Trust made grants available to the following projects. Grant applications were completed and duly considered. Presentations were requested at intervals during the year so that the Trustees might gain a clear insight into the work of the organizations and the expected impact as a result of funding by the Trust. It also facilitated a question and answer interaction between the trustees and the organisations which resulted in a far deeper understanding of the work being carried out together with an appreciation of the difficulties encountered by both staff and clients. An understanding of the training needs of volunteers and staff was also gained by trustees.

This year the Trust funded fewer organisations, but with amounts of funding guaranteed over a longer period. It was decided that this action enabled the receiving organisations to be more effective and enabled them to plan initiatives over a longer period of time.

1. NOW – Night Outreach Work

This organisation works within the centre of Bournemouth particularly with the young people who are affected by drugs or alcohol by launching street groups of specifically trained volunteers who counsel and ensure the youngsters are safely returned home. They have wider implications for their work in building relationships of confidence and trust within the community. The organisation has a long term vision of ensuring the town centre is a safe place for the communities who live or visit the town. The pastor regularly provides the Trustees with updates and reports of his work.

Grant: £15,000.00

2. Teen Challenge

This organisation works to help young people who have developed life controlling problems, especially drug and alcohol addictions and also to offer preventative help to those who may be in danger of doing so. The goal of Teen Challenge is to help people to become mentally sound, physically well, emotionally balanced, socially adjusted and spiritually alive. The charity is built on and driven by Christian values and beliefs, which clearly show how precious and loved each individual is. The George Temperance Trust is funding support for the local team that works in the Bournemouth area.

Grant: £10,000

During the year Trustees met on three occasions in addition to the Annual Meeting.
