STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a constitution adopted on 14th August 2004 and constitutes an unincorporated registered charity.

Recruitment and appointment of new trustees

The Vicar is appointed by the Diocese Bishop and his term will be until further order from the Diocese Bishop.

The Secretary, Treasurer and Committee Members are elected at the Annual General Meeting of the charity.

Risk Management

The Trustee have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

OBJECTIVES AND ACTIVITIES

Objectives and aims:

The main objective of the church is to promote the Indian Orthodox faith.

The main activities of the church are conducting Holy Mass on every Sunday in the month and special Holy Mass on New Year day, during Holy Week, Christmas and on other occasions. Also to arrange educational tours for the members of the church, especially for the youths and conduct visits to hospitals, provide small financial helps to the poor and needy. The church is run by volunteers who are not entitled to any remuneration, except the Vicar's

The church is run by volunteers who are not entitled to any remuneration, except the Vicar's allowances paid to the priest for his pastoral duties.

ACHIEVEMENTS AND PERFORMANCE

Charitable activities:

Regular Holy Mass were conducted on every Sunday of the month and special Holy Mass were conducted on New Year day, during Holy Week, Christmas Day and on other occasions The Holy Week services were conducted during the Holy Week in March 2016.

The Annual Parish Day and Harvest Festival of the church were celebrated in August 2015. The Remembrance Day of St Mary and others Saints were conducted as usual in the year. Sunday School Study classes were conducted regularly and the Annual Sunday School Competition was held in April 2016. The competition is mainly aimed to provide children a platform to perform their talents.

The Orthodox Vacation Bible School for the children was conducted in the month of May. The cottage prayers were arranged in church member's houses on a regularly basis. Visit to member's houses were arranged as usual every year to deliver the Christmas message and New Year wishes. Most of our members, including children took part in this activity. The Christmas Holy Mass and celebrations were conducted on the eve of Christmas.

As an Orthodox church our primary aim is to worship and under the dynamic leadership of our vicar, Fr. Mathew Abraham we had Holy Mass on every Sunday except two and on all canonical feast days (exceptions: family conference week and Christmas Day which fell on a Sunday last year with our Holy Massa on Christmas eve). We remembered and celebrated all our Festivals and refreshed ourselves with retreats, devotional messages and attending spiritual conferences. We had evening prayers on most Saturdays and every so often Priest held evening prayers in the church for the sick, those about to embark for hospital treatments, for the repose of departed souls and for the comfort and solace of their relatives. Our Priest also visited the sick at home and in hospital. In addition all spiritual organisations in our church met after service under Priest's leadership for a spiritual chat as well as to formulate and schedule various organisational activities.

At present there are 73 families on our membership register. One family was added during the year.

Election general body meeting was held on 3/4/2016

Annual General Body meeting was held on the 26/06/2016 and passed the accounts for the previous year and approved the budget for 2016-2017

Election general body meeting for selection of the current office bearers was held on 19/02/2017

Officially, the church committee met 9 times during their term 2016-2017.

In May 2016 we obtained the certificate of registration as a place of religious worship and Superintendents Registrars certificate to conduct the sacrament of marriage.

We celebrated our Patrons day and Church Festivals on the 21st of August 2016

Sunday school progressed from strength to strength under Headmistress. The New Year in 2016 started with 62 children registered to attend. Our children took part in the many talent competitions winning a lot of prizes. Our Sunday school won the first prize at the district level and second prize at the diocese level.

God is my greatest joy was the theme of our On Vacation Bible Sunday School (OVBS) conducted from 02/06/2016 to 05/06/2016.

Our youth and church members attended the 7th Annual family conference themed "The essence of orthodox spirituality in the contemporary world" from 24-28th, August 2016 at York

We are indebted to Youth and MGOCSM members for all their enthusiasm in working for the church.

Members of our Ladies Group Martha Mariam Samajam are the pillars of our church. We recognise and are very grateful for their immense dedication under the leadership of various Ladies. They organised all the tea / food for all the church members, visiting priests and dignitaries on Sundays and all other church events.

We had regular prayer group meetings in Bristol, Reading and the South west under the leadership of our Priest and Secretary.

Our church hosted our summer barbecue on the 24th of July in our church lawn.

The much anticipated door to door Christmas carol singing in Bristol took place last year on two consecutive Saturdays (10th and 17th) in December.

We maintain cordial relations with our sister churches in Bristol. Our church hosted 4 of them for the Christmas Ecumenical program on the 26th of December 2016

Our annual Family get-together (Snehaspandhanam) programme coordinated was held on January 7th 2017 at Patchway Community College Almondsbury. The chief guest was Fr. Giurgios El Makary, priest of the Coptic Orthodox church in Bristol

We supported local and international charities/charitable causes in 2016-2017

Operation Christmas to support a child in Africa (MGOCSM)

University fees for the education of a poor student in Kerala, India (MGOCSM)

Education of a child in Kerala through the Ted Foundation Trust (MOMS)

Funds towards building a house for a poor family in Kerala.

We also financially supported the family of a lung cancer patient, a patient with kidney disease, a differently abled person and the family of a sick person

Locally we supported homes for the aged in Easter Compton, Bristol.

1. ACCOUNTING POLICIES

Accounting convention

The financial statement have been prepared under historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008), the Charities Act 2011 and the requirements of the Statement of Recommended Practice, Accounting and Reporting by Charities.

Incoming Resources

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be qualified with reasonable accuracy.

Resources expended

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings, they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Plant & Machinery

- 15% on reducing balance basis

Fixtures and Fittings

-15% on reducing balance basis

Computer equipment

-25% on reducing balance basis

Freehold property

-Not Provided

(The Trustees have carried out a full impairment review in accordance with FRS 11, as a result of which no depreciation is made in respect of freehold property on the grounds that the estimated residual value is not materially different from its carrying value in the Balance Sheet)

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
