Suffolk Accident Rescue Service is governed by a constitution adopted in August 2016

Organisational structure

The Board of Trustees has overall responsibility for the governance of the charity and for ensuring that all activities and expenditure are in line with the agreed Aims and Objectives of the charity. The Board of Trustees meet a minimum of four times per year and receive monthly reports from key personnel, including financial statements, and clinical operations updates for the purpose of monitoring the day-to-day activity of the charity.

Risk Management

The Trustees have a duty to identify and review the risks to which the charity is exposed and to ensure that appropriate controls are in place to provide reasonable assurance against fraud and error.

Objects of the Charity

The object of the Service is to provide immediate medical treatment and care to persons in need by reason of accident or other emergency in the geographical county of Suffolk and adjoining areas.

Public benefit statement

The Trustees have taken due regard of the guidance published by the Charity Commission on public benefit. The Charity's objectives are "The advancement of health or the saving of lives". Suffolk Accident Rescue Service provides public benefit through its volunteer doctors, volunteer critical care paramedics and critical care teams to the populations of Suffolk, Norfolk, Cambridgeshire & Essex, to whom no charge is made.

During 2016, Suffolk Accident Rescue Service changed its status with the Charity Commission, becoming a Charitable Incorporated Organisation with a new charity number and a strengthened infrastructure to support the Board of Trustees with effect from 16th August 2016.
