REPORT OF THE TRUSTEES

The Trustees present their report and accounts for the year 31 December 2017. The objectives are the relief of suffering and distress of retired and unwanted greyhounds.

Principal Goals and Activities of Wimbledon Greyhound Welfare

Wimbledon Greyhound Welfare exists to care for and find suitable homes for former racing greyhounds.

Our objectives are specifically restricted to the following:

- The relief of suffering and distress of retired and unwanted greyhounds, including, but not limited to, the following:
 - a) providing medical attention and treatment for those greyhounds that require it;
 - b) providing sanctuary for those greyhounds with medical or behavioural issues;
 - c) arranging careful and responsible re-homing of greyhounds.
- The advancement of education of the general public in matters relating to greyhounds and by this means to prevent cruelty and suffering.

ACHIEVEMENTS AND PERFORMANCE

Review of Activities

2017 was the sixth full year for Wimbledon Greyhound Welfare. For the 12 months ending December 2017, WGW found homes for 102 greyhounds - compared to 77 the previous year. This marks a 25% increase on the total homed for the year ending December 2016.

Fundraising and promotional activities

Having previously approached the various owners of the kennel blocks at Burhill Kennels to see if any of them were interested in selling their kennels to WGW, we have recognised the difficulties in purchasing land and obtaining permission to build kennels. It is also our preference to stay in the charity's established location if possible. Discussions with the trainers interested in selling their kennels are still ongoing. It has always been important for us to keep our volunteers and supporters aware of what has been happening in terms of approaching other kennel block owners and any possible impact on the charity.

We inform and update our supporters with quarterly newsletters, videos, website and Facebook pages and this in turn has led to us reaching a wider audience and also being able to share views. Additionally, we have continued to promote our charity locally and this has resulted in more requests for us to attend local events, including the After Eight Club (where we did a talk about WGW as a local charity and took a hound along for members to meet), Chestnut Sunday at Bushy Park (where we had a stall and took along hounds to meet people and go on the official Park parade) and the Nonsuch Park Awareness day organised by the Park Wardens (we had a stall and gazebo pitch and promoted greyhounds as great pets and the park as having some lovely walks). We also applied for and succeeded in being awarded a £500 grant from the National Air Traffic Services who wanted to know our aims and objectives as a local charity and our recent achievements. The grant was to be spent on infrastructure for the kennels and we were able to replace some dilapidated paddock fence panels with it.

June 2017 saw a change of Manager and the summer, autumn and winter period saw an increase in visitors to the kennels. This has led to more hounds finding suitable homes and more visitors taking kennel hounds to local parks more frequently. We have also seen a significant increase in dogs being taken for short periods on foster which has also resulted in valuable home-stay reports which can be displayed on our website and/or Facebook pages.

We rely on a wide range of helpful volunteers, some of whom are elderly and cannot now have a hound of their own; some are community support workers and their clients, volunteering to help walk the greyhounds; also, young adults who are participating in the Duke of Edinburgh scheme at various levels. We are very fortunate that we are able to invite people to fundraising and PR events at our kennels and although we recognise that it creates an additional workload for the kennel staff, it is a very effective way to showcase our charity and promote greyhounds as good pets in the home. It also allows people to sponsor an older or infirm hound that may have associated veterinary bills for medication or a health condition or to take that first tentative step of considering offering a greyhound home without any pressure.

We have been fortunate in that our dedicated supporters have continued to tirelessly raise funds by attending various events on our behalf, including the Wimbledon tennis championships and numerous Meet & Greets in cooperation with local supermarkets, an agricultural show (Chertsey) or local councils for high street collections. We were also fortunate to receive notification some legacies, funeral and wedding donations which we are intending to use towards the purchase of our kennels which will help secure the long-term future of WGW.

In summary, 2017 was a busy year for homing with positive changes at operational level and behind the scenes, and an ever increasing number of hounds being homed, with an increased number of volunteers for walking and helping out at the kennels. A successful PR programme of events and walks involved more of our volunteers and promoted what we do as a charity to potential homers, supporters and fundraisers.

Finance and reserves

The sixth full year as an independent charity has been successful with a closing balance of reserves of £670,729. The charity has a policy of maintaining 6 months costs in reserves. This totals approximately £130,000. The balance carried forward will allow discretionary spending on facilities for the kennels on due course, as well as assisting us in our long-term goal of owning a kennel site outright.

Public Benefit

The trustees have considered the guidance provided by the Charity Commission in relation to public benefit and the activities of the charity.

Summary

The sixth full year of operation as an independent charity has continued to be beneficial to the operational and financial aspects of Wimbledon Greyhound Welfare. Our supporters have continued to be incredible in their generosity in supporting our efforts and further improvements have already been made in the amenities at the kennels which will continue to provide a stable financial future.

Notes to the Accounts

For the year ended 31 December 2017

1.1 Basis of accounting These accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts. The accounts have been prepared in accordance with:

• the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 105) issued on 16 July 2014

• the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) • and with the Charities Act 2011. The charity constitutes a public benefit entity as defined by FRS 102.

1.3 Change of accounting policy The accounts present a true and fair view and the accounting policies adopted are those outlined above.

1.4 Changes to accounting estimates No changes to accounting estimates have occurred in the reporting period.

1.5 Material prior year errors No material prior year error have been identified in the reporting period.

1.6. Recognition of income -These are included in the Statement of Financial Activities (SoFA) when:

- the charity becomes entitled to the resources;
- · it is more likely than not that the trustees will receive the resources; and
- the monetary value can be measured with sufficient reliability.

1.7. Offsetting - There has been no offsetting of assets and liabilities, or income and expenses, unless required or permitted by the FRS 105 SORP or FRS 105.

1.8. Grants and donations - Grants and donations are only included in the SoFA when the general income recognition criteria are met . In the case of performance related grants, income must only be recognised to the extent that the charity has provided the specified goods or services as entitlement to the grant only occurs when the performance related conditions are met .

1.9. Legacies - Legacies are included in the SOFA when receipt is probable, that is, when there has been grant of probate, the executors have established that there are sufficient assets in the estate and any conditions attached to the legacy are either within the control of the charity or have been met.

2.1. Tax reclaims on donations and gifts Gift Aid receivable is included in income when there is a valid declaration from the donor. Any Gift Aid amount recovered on a donation is considered to be part of that gift and is treated as an addition to the same fund as the initial donation unless the donor or the terms of the appeal have specified otherwise.
