The PCC met 6 times during the year (average attendance of 15).

### **Subsidiary Groups**

This year has seen the Benefice designated as a Ministry area, and the establishment of the Ministry Area Leadership Team (MALT) – consisting (pro-tem) of the Rector and Benefice Wardens. This team meets weekly to review urgent matters requiring action, including general administration related to the Ministry Area and the PCC meetings.

The PCC operates through groups that have delegated authority to perform specific tasks, and which report to the PCC at agreed intervals – see "structure and governance" below:-

### **Parish Share**

There are no arrears of parish share or quota due to the Diocesan Board of Finance.

### Treasurer's Report - Financial review - Deryn McAndrew, Benefice treasurer

A report on the financial activities of the Parochial Church Council, including the ways in which the activities of the parish have been funded and the funding proposals for the future

These financial statements have been prepared in accordance with the Statement of Recommended Practice for Charities (SORP FRS102), as amended in February 2016 with Update bulletin 1, and effective from 1/1/16. This benefice is defined as a "smaller charity", because income does not exceed £500,000.

The PCC policy on reserves is to hold 2 months' worth of operating costs and a prudent amount to address any serious building issues that may arise as an emergency - hence aiming to hold £60k unrestricted funds. The year-end value of this fund is £64,391 - hence well-provisioned.

The main sources of income are "direct giving" from our congregations and associated tax refunds. This covers the main expenditure - namely the Diocesan quota, and the running costs of priests and services. However, fundraising is required to meet both the running costs of the buildings, and any required repairs or enhancements. Fundraising comes in several forms: –

- Occasional donations from individuals and local organizations
- Small regular repeating initiatives, such as sale of diaries, weekly coffee mornings/clubs, monthly car wash, monthly 100 club and lunchtime recitals.
- "One-off events", such as fetes, large concerts, the annual Gift Day appeal, and the six-monthly draw.
- Applications for grants for specific projects being undertaken this year, for example, from the Welsh Church Fund, the Representative Body of the Church in Wales the Listed Places of Worship scheme, and from local community councils etc.
- Detail of events/grants/donations over £500 is included in the financial statements.

The policy of the benefice is that major works to the individual churches are resourced through restricted fundraising, and by seeking grant funding. The year-end position on all the restricted and designated funds held by the benefice is shown in detail in Note 9 of the financial statements. It will be noted that:-

- although there have been large amounts expended during the year, this has been balanced by income, so that the net end position is positive.
- Some funds reported as "restricted" in previous years have been re-titled as "unrestricted" (namely the churchyards and the "Missions" funds) because they are always "over-expended" in the year so having them in the restricted fund makes control of that fund easier through the year.
- Some funds from last year have been closed church designated funds have been incorporated in church restricted funds (because in fact they were built up from restricted fundraising), and some funds (Mini-bus, and Clergy housing) were closed because they were fully expended and no longer required.
- A separate new restricted fund was created for the Food Coop, which has made accounting easier.
- The opening balance for 2017 on all funds was adjusted to reflect the changes made.
- Details of individual expenditure amounts over £1000 are shown in the financial statements

The "Benefice Fund for Mission Action" is used to manage several small areas of mission in the benefice. These include the Night Shelter, Messy Church, Archives office etc. Each of these is expected to be self-sustaining - e.g. to acquire income to cover the running costs of these ventures - either by donations or grants. This is working very well. The one area which is not self-sustaining is the matter of resources purchased for discipleship and or benefice communication/consolidation - which this year has shown a net cost of £356. In the context of the £50,000 originally set aside for this fund, this is minimal consumption.

Monthly reporting to the PCC and CAT meetings has continued this year with spreadsheets automatically extracted from the SAGE system to separate unrestricted from restricted/designated fund reporting. This gives each church family a view of its maintenance and running cost (unrestricted account), separated from its restricted savings accounts, and encourages the practice of budgetary control, using "last year's figures" as a measure of relative position through the year.

During the year a "finance workshop" was held to explore detailed questions that had been raised from various sources in the benefice, and in particular at the Easter Vestry. All questions were answered and a document produced which was made available in all churches. As a result of the debate within this workshop and the later review of the document, the allocation of the parish share between the churches was altered to reflect not only the number of communicants, but also the clergy cover at each church, to better reflect the "fairer share" calculation.

During the year there have also been 17 new/amended procedures approved by the PCC - covering matters including rules for authorization/payment of bills, the process for production of accounts (with responsibilities), handling of legacies, and improved financial controls. Whilst many of these are just documenting "what we do" - some have been created to align with "best practice" under charity commission guidelines – e.g. tightening up procedures for expenses and paying bills.

As ever, team working is the key to success, and the benefice treasury team includes Mary Duggan on book-keeping, Lesley Owens on checking the allocation of payments before input and Andy Hall, in checking expenses and supporting the automated monthly reporting from SAGE. We continue our close links with the diocese for advice and guidance. My very grateful thanks go to them and to all our advisors, including our auditor and our Finance advisory group, and also to the teams of people in each church who count and bank the money, and produce banking analyses and bank statements for input to SAGE. Many thanks to all for a job very well done.

### **Public Benefit**

The Trustees have been made aware of the charity commission guidance on public benefit.

### Structure, Governance and Management

The **governing document** is the constitution of the Church in Wales which is available online at ..... http://www.churchinwales.org.uk/structure/representative-body/publications/downloads/the-constitution/

The Trustees are appointed according to the rules in the constitution, each for a term of one year. One churchwarden and one sub-warden for each church are appointed by the Rector, and the other warden, sub-wardens and PCC members are appointed by nomination and then by vote. All members of the electoral roll are able to stand for appointments, to nominate candidates, and to vote in the elections which are held in the Annual Vestry meeting each year. The electoral roll is updated annually, and made available for checking by the congregation for at least 2 weeks before the Annual Vestry meeting.

The Benefice was created in January 2015 by combining the previous parishes of Eglwysilan and Caerphilly. The Trustees and Clergy and all other key people involved in the administration of the Charity are listed above. Together, they make up the Parochial Church Council (PCC), which is the body with legal responsibility for the running of the charity.

The structure of the benefice reporting to the PCC is as follows:-

- The Rector and Benefice Wardens meet weekly to oversee all matters in the benefice, and to liaise with Diocesan and Church in Wales officers to obtain assistance and guidance as required to take new initiatives forward.
- Sub-wardens in each church hold delegated responsibilities from the benefice wardens, as described in the
  constitution these include care of the buildings, the electoral roll, the Mission Action Plan, and the Log Book,
  Inventory and Terrier.
- The Sub-wardens are supported by Church Action Teams (CATs) one for each church family. These teams assist the "traditional" role of the sub-wardens in overseeing in particular the care of buildings and inventory, as well as implementation of agreed procedures in their areas of responsibility.
- There is a set of working groups covering all the key areas of legal responsibility such as Health and Safety, Disability, Governance, Stewardship, Protection of Vulnerable people, Churchyard, etc. etc. All these typically include representatives from each of the four church families. They all report to the PCC as required normally in the form of a summary report developed by the Benefice Wardens in consultation with the groups themselves.
- This year we have established a set of "task and finish" groups which report directly to the PCC with the purpose of
  progressing key elements of the "Mission Action Plan (MAP)" for forward strategic development of the Ministry
  area, namely
  - Evangelism initially focussing on "Holy Baptism", and developing the process to aid deeper understanding of the purpose of this sacrament, and to encourage more frequent interaction between the church and parents/children
  - Communication initially focussing on the requirements of a new Benefice web site for both internal and external communication
  - Physical resources includes building work highlighted by the Quinquennial and other inspections, as well as
    projects established to take forward strategic decisions about future use of the buildings. This incorporates the
    long-standing project team which has been managing the St Martin's re-ordering project, aimed at providing
    facilities for greater community use of the church.

Meetings were held to drive forward the business of the benefice, namely:-

 The normal business schedule of PCC meeting – meeting 6 times during the year with an average attendance of 15 people.

- Church Action team meetings each meeting a similar number of times to the PCC through the year attendances normally good.
- Pre-vestry and Vestry meetings resulting in the appointment of the PCC for 2017/8.
- Working group meetings as required, albeit most of them operate informally by e-mail.
  - o The magazine meeting is the most regular as we discuss the content of each monthly publication.
  - The planning group, which liaises across the four church families, keeping track of all bookings and activities to avoid clashes of dates. Details included in the "Benefice Planner" are: special services, study groups, meetings, weddings, and external bookings of the churches, as well as social and fundraising events (see more details below).
  - The Archives team are seeking to get all registers down to in Glamorganshire Records office, with digital copies available within the benefice for family research. The number of searches on baptisms, wedding and burials have expanded through the year
  - The "Green teams" did further work on the gardens in St Martin's and St Andrew's and entered their gardens into "Wales in Bloom" and RHS "Its your neighbourhood", They were both rewarded with certificates of achievement. They also promote recycling and wildlife activities.
  - The churchyard team continues faithfully to record inscriptions, as well as problems in St Martin's Churchyard – excellent progress has been made on the "new" garden of remembrance.
  - o The safeguarding team has being progressing with getting up to date with DBS checks.
  - The Health and Safety team undertook a major exercise to implement new Fire Safety and Health and Safety policies and procedures, in accordance with Church in Wales/Ecclesiastical Insurance advice
- Task and finish group meetings as required to progress the MAP initiatives meetings held as required to take
  forward the purposes outlined above. This has required establishment of terms of reference and membership
  for each.

This has been a year of significant change - both in terms of people and reporting structures, as follows:-

- Changes in the clergy team Father Tom left in the summer, after only one year with us to take up a post of team vicar in Abergavenny. Revd Sue Pratten reached the end of her time as a curate, and has been seeking placement as a team vicar this will take effect in 2018, after which she will be replaced by a new team vicar. So we move into 2018 with a team of only two full time Clergy and an NSM ......and what seems to be an ever-increasing workload in one of the biggest benefices in the diocese.
- Changes in lay pastoral activities the pastoral visiting team continues under a new coordinator. Three new people have been licensed for Eucharistic ministry, and a team of worship leaders have almost completed their training and have started to lead the "Welcome and Worship" services across the benefice.
- The introduction of the new Task and Finish groups, as already mentioned
- To support the developing Ministry Area, a set of volunteer lay administration staff/teams have been set up to assist the clergy examples are the administration of banns, baptisms, confirmations, weddings, weekly sheet, benefice planner etc. This concept continues to develop.

### **Objectives and Activities**

The declared purposes in our charity registration are:-

## The provision of regular public worship

Services given on a regular basis were as follows:-

#### St Martins

- Sunday 8.30am Holy Eucharist.
- Sunday 10.30am 1st Sunday "All-Age", 2nd "Welcome and Worship", 3rd through 5th Sung Eucharist and Junior church.
- Sunday 6pm United Parish Service Eucharist on 2nd Sunday, Evensong on every other week, choral evensong on last week.
- Tuesday 10.30am and Thursday 9am Holy Eucharist.

### St Catherine's

- Sunday 9.30am 1st Sunday "All-Age", 3rd Sunday "Welcome and Worship", all other Sung Mass.
- Tuesday 7.00pm Mass.

#### St Andrew's

- Sunday 11am 1st Sunday "All-Age", 4th "Welcome and Worship", all others Sung Eucharist and Sunday School.
- Wednesday 7pm Holy Eucharist.

Eglwysilan – (at Ss Peter and Cenydd until Palm Sunday, St llan after that)

• Sunday 10am- 1st Sunday "Welcome and Worship", others all Sung Eucharist.

Compline and Healing services are offered every month – alternating between St Andrew's and St Catherine's. Weddings, Baptism and Funerals are offered to all parishioners, in all churches, under the rules set out by the Church in Wales. Holy Baptism is no longer required before Holy Matrimony, but Godparents at Holy Baptism must themselves be baptized. Indicative numbers for the benefice, based on 2016 figures, are:-

- o Funerals 89, including those held in the chapels of rest.
- Weddings -34, plus several blessings and renewal of vows.
- o Baptisms 34.

Special services are held to mark Saints days, the various seasons of the church, and other appropriate occasions – see "Highlights" below.

## 2 Sacred space for personal prayer and contemplation

This is provided for quiet private prayer and contemplation in each church with side chapels and votive stands with candles and prayer cards/books.

We took part in a "retreat" at Llangasty, and the South Wales pilgrimage to Walsingham.

### Pastoral work, including visiting the sick and bereaved –

Pastoral visiting and home communions, plus bereavement counselling, is offered by the clergy and three teams of lay ministers. Eucharist services are held in three care homes in Caerphilly on a regular basis, and in several others at key times such as Easter and Christmas.

### 4 Teaching of Christianity through sermons, small groups and assemblies in local schools

Study groups are offered - during the year we held regular weekly Bible Study, a Lent course, three Open days of prayer, and continuing worship leaders training,

We ran confirmation classes, and seven people were confirmed by the archbishop at St Martin's. Several Local Schools are visited regularly for assemblies, where schools are willing to accept this service.

# 5 Promoting the mission of the Church in Wales in aiding community cohesions through provision of activities for older people, children and other specific groups

- The Food Co-op has been running since late 2013, offering low cost high quality fruit and vegetables plus
  a meal and fellowship to people of all ages the elderly and young mothers in particular. Food vouchers
  are accepted.
- The Night shelter ran for 3 months through the early part of the year an initiative through Caerphilly County Borough council to offer a warm bed and evening meal/breakfast to homeless people referred through social services.
- St Teilo Café, Cup'n'Chat, Lunchtime concerts, craft and hobbies clubs all provide opportunities for meeting other people, over a "cup of tea" popular with older people in particular.
- St Martin's now has an "Open church" attended by a rota of volunteers from 10am to 12noon every day of the week. This is in addition to the occasional "Open Doors" days we arrange through the year
- ST Ilan's church continues to be open all day, unattended through the year the visitors book provides a testament to the use made of this.
- The Contact the Elderly charity started in one of our churches in 2015 giving a tea-time treat to older people suffering from isolation through age/ infirmity. This proved a huge success and continues to run twice a year looking to increase frequency in 2018.
- For Children, we ran monthly "Messy Church" with Junior Church and "Shooting Stars" continuing weekly on Sundays during morning services.
- Many local schools hold carol concerts at Christmas in our churches, and we attend several care homes taking carols out to the community.
- Some of our members belong to Club 707, which is an ecumenical initiative working in local schools, and some also to Street pastors, helping on the streets on Saturday evenings.
- The "Children's corners" in St Martin's and St Catherine's for small children to play with toys during church services has proved very popular not only with the young families now attending regularly, but also with visitors at baptisms, weddings and funerals.
- The Benefice Choir sings monthly at united services, and at fundraising concerts
- The Family Orchestra in St Martin's has continued to perform at "All-Age Eucharist" and has supported "Taize" services held twice during the year. We look to see this developing further in 2018 into a Benefice Orchestra, working together with the Junior church and Benefice choir
- Community use of buildings. We host meetings of Beavers, Rainbows, Brownies and Guides, Cubs and Beavers, an Aikido club, Yoga, Dance classes, fitness dance, slimming world, Toddlers group, etc. Our intent going forward is to increase this usage of our buildings within the limitations of available space and services
- Another community service we offer is to provide access to our parish registers, archives and records for local history/family history purposes.
- The St Martin's re-ordering to provide community space in the rear of the church was started in November 2011, with one of the key triggers being the demise of the parish hall, and the need to replace this community space. In 2017, this was split into two parts:-
  - Phase 3 re-named "SMART community centre development". The new Business Plan was completed, but not progressed further, because the team was deployed on other urgent priorities.
  - Phase 4 re-named "Worship Area development" work included in the re-ordering plan that was relevant to the worship area rather than the community area was separated out as far as possible – this to be funded from a legacy received in late 2016. The first work package will be taken forward in early 2018

## <u>Highlights of the year</u> Special Services

These often open up our worship to a wider congregation than the normal Sunday and weekday services. There was the whole range of wonderful services during Holy week and Easter, including "Son-rise" up at St Ilan, "Stations of the Cross", Chrism Mass at the Cathedral, the Good Friday Vigil, and, of course, hot cross buns and eggs on Easter Sunday. There were several ecumenical services held and/or attended through the year, and we joined the other churches in both Caerphilly and the Aber Valley for the world women's day of prayer, the Mothers Union wave of prayer, and for worship at the Big Cheese Festival. Then there was Remembrance Day when we welcomed the Royal British Legion to lay a wreath in St Martin's, and joined the town of Caerphilly at the cenotaph in the afternoon. And there were the Senghenydd memorial services — both for the mining disaster and for the war. We had "In Loving Memory" for people who have been bereaved during the year, "Picnic and Praise" out of doors, and Pentecost, All Saints, All Souls, Candlemass, Christingle, Advent, Mothering Sunday, Pentecost, Advent to Christmas, Service of Light, Christmas Eve Services for families, and Midnight Mass.

Weddings, funerals and baptisms continue to play an important part in the work of the benefice – and we provide additional support for people seeking these services - through a "benefice surgery" for people seeking baptism and weddings, an annual "wedding couples evening" to welcome people planning to get married during the year, and an annual "In loving memory" service for the bereaved.

This year at Christmas we joined with "Love Caerphilly" for a new and different type of Carol service, which was much enjoyed by all

# Mission and Ministry in the community

Ministry activities in the community include regular visiting of the house-bound by the clergy and Pastoral visiting team, home communion offered by the Eucharistic ministry team, and monthly services in three care homes. At Christmas, carol services were held in several other care homes and sheltered accommodation – all across the benefice.

Some of our members belong to the street pastors who patrol the streets of Caerphilly on Saturday nights, and we have forged links with several local care homes and independent living communities with carols and hospitality. In particular this year, St Andrew's has extended its links to include hospitality at times like Hallowe'en, when older folk welcome the opportunity to gather safely. We also held a "bag-pack" on Holy Saturday, spreading the good news ("Easter tomorrow") to Asda customers with stickers etc.

A key focus area for the Benefice is the opening up of our churches and halls for community activity:-

- St Catherine's Hall has always been busy, and continues to be so including Keep fit, cup'n'chat, slimming world and film club. They also host the "Food Co-op", providing good value fruit and vegetables, as well as a soup lunch to the local community.
- St Andrew's was opened in the first 3 months of the year to "Night Shelter" a Caerphilly council based initiative, which worked well with help from the council of churches. The church has always been used as a community centre (which was its purpose when built) and is now extending its activities activities include slimming world, toddlers, a Rainbow unit, craft and hobbies, and open doors days, and of course the garden is available to all at any time.
- St Martin's has Rainbows, Brownies, Guides, and Aikido meeting regularly in the evenings at the back of the church, and St Teilo Café Church on Tuesdays offers an opportunity, not only for teas and t cakes, but also for anyone to come in and consult the clergy, or locate graves in the churchyard. The charity "Contact the Elderly" has continued to meet with us twice a year, providing tea parties for those living in isolation a great success. Despite its size as the largest of our churches, expansion of community activities in St Martin's is presently

inhibited by the fact that there is only one large space available – and this has to be shared with the frequent requirement for funerals and weddings.

- St Ilan is open all day every day for passing visitors very popular with walkers now provided with toilet facilities (a "port-a-loo")
- St Martin's and St Catherine's hosted once again a Caerphilly Town flower festival entry.
- All off our churches offered open days with refreshments and other activities several times during the year

### **Buildings - conservation and care**

Major matters undertaken at the recommendation of the Church Action Teams (CAT's), all of which were paid for from grants, donations, and fundraising were:-

- St Martin's placement of the "St Teilo Cross" over the community area and a further initiative to sell nearly all the pews, which has created greater flexibility for services "in the round". Work completed included urgent repairs to the organ and the clock, sanding/sealing the floor in the lady chapel, installing WiFi, and an additional radio microphone
- St Catherine's nothing major in 2017, but planning to address the quinquennial requirements in 2018
- St Andrew's nothing major in 2017, but planning to address quinquennial matters in 2018
- Ss Peter and Cenydd preparations for closure of the church including check of inventory, and draining down the heating system
- St Ilan major work completed to mend the hole in the roof and preparations started for remedial work on the tower in 2018
- And of course, regular maintenance in all buildings gas and electricity inspections, PAT testing, fire
  extinguishers, lights, organ and sound system servicing.....and so on. In ST Martin's there was a new initiative
  on "maintenance" with the establishment of a new team of volunteers to address regular monitoring as well as
  reported problems.
- A major exercise was undertaken to implement the new Health and Safety procedures developed by the Church in Wales in liaison with Ecclesiastical Insurance. Remedial action is being progressed through the CATs

### Social and fundraising Events.

Fundraising and social events included open days (including the national Open Doors Day), "Bags 2 the Future" and other recycling collections, the summer fete, the Spring Fayre with Easter Egg hunt, the Fun Days, the Mistletoe market – all good fun. Christmas preparations included the now regular "Christmas Tree festival", "Here comes Christmas" and this year the Eglwysilan carol event was held in St Martin's because the Rose and Crown was closing. Then there were Carols in the Bandstand and in several care homes.

We had various meals around the churches – breakfast clubs, Italian dining, Harvest supper, Christmas lunch, Curry evening, Cheese and Wine evening, BBQ, and wine tasting evening. Also, quiz nights, skittles evening, Pamper days, and Coffee evenings.

We also had the charity events - Soup Sundays and charity breakfasts, Macmillan Cancer Care coffee mornings and afternoon teas. We had ongoing collections of goods for "Mary's Meals" (139 bags sent off), "Bridging the gap" food bank; Harvest gifts for local care homes, and Christian Aid Lent lunches and bucket collection. Then there were the knitted Christmas tree leaves which ended up in blankets for the homeless. The food co-op is sponsoring two children – one through World Vision and one through Compassion, St Andrew's is sponsoring one child through World Vision, and Fair trade goods are on sale in all churches. WE supported Pancreatic cancer by "going purple" and having a charity breakfast

And then there were the trips – the Bellringers did their usual trip round churches to ring bells. The Benefice did three trips - to the Panto in Cardiff, a trip to a wine making centre and Stratford in the summer, and the Bath Christmas Market - all were very successful and enjoyable.

The churches are a popular venue for concerts – some for our own fundraising, and some for other organizations. This year, we have hosted Plas-y-felin school, the Community chorus, an Easter concert with COR, Caerphilly Miners fundraising concert, St Martin's school carol concert, Aber Valley Male Voice Choir, two "home-grown" concerts, an evening with soloists from the Welsh National Opera, and of course the monthly recitals arranged by Dan and Laura Curtis, and

#### 1. Accounting policies

The Financial Statements have been prepared in accordance with applicable United Kingdom accounting standards, the "Statement of Recommended Practice" (SORP FRS102) issued by the Charity Commissioners and the Church in Wales Accounting Regulations. The historical cost convention is used except for the valuation of certain fixed assets, whose valuation basis is detailed in note 1a below. The accruals basis of accounting has been adopted. The principal accounting policies are applied consistently.

#### a. Fixed assets

**Freehold property:** Churches, Churchyards and Vicarages are vested in the Representative Body of the Church in Wales; such property forms no part of the assets of the Parish. Moveable Church contents require a faculty for disposal so are considered to be inalienable property and are not valued, nor recognised on the Balance Sheet. Expenditure incurred on Churches (including contents), Churchyards and Vicarages is written off when incurred.

Other freehold land and buildings are held in trust for the Parish by either the Representative Body, or the Llandaff Diocesan Board of Finance

No provision for depreciation of land and buildings is made. Routine additions and replacements to Church Hall contents are charged to current expenditure.

**Equipment**; stated at **note 7** , is written off by depreciation over Five

years.

# **Investment assets:** are stated at mid-market values on the balance sheet date. **b. Funds**

**Endowments funds:** are funds the capital of which must be maintained; only income arising from investment of the endowment may be used either as restricted or unrestricted funds depending upon the purpose for which the endowment was established.

**Restricted funds:** represent a) income from trusts or endowments which may be expended only on those restricted objects provided in the terms of the trust or bequest, and by donations or grants received for a specific object or invited by the PCC for a specific object. The funds may only be expended on the specific object for which they were given. Any balance remaining unspent at the end of each year must be carried forward as a balance on that fund.

Unrestricted funds: are general funds which can be used for PCC ordinary purposes.

**Designated Funds:** are sums set aside out of General Funds for specific designated purposes.

They can be transferred back to unrestricted funds at any time.

#### c. Incoming resources are all accounted for gross

Planned giving, collections and donations are recognised when received.

Indirect giving: Tax refunds are recognised as soon as the amounts are claimable.

Grants and Legacies are accounted for when the PCC is legally entitled to the amounts due.

Investment income: Dividends are accounted for when receivable; interest and tax recoverable are

accrued. Where the PCC has not invested separately for each fund interest is apportioned to individual funds on an average balance basis.

All other income is generally recognised when it is receivable.

#### d. Outgoing resources

4. Payments to PCC members

Quota is paid regularly and is included in expenditure for the year to which it relates.

Unrestricted fund grants (including donations to missions) are recognised when determined by the PCC.

Amounts received specifically for missions are dealt with as restricted funds and the liability for payment is recognised when the amounts are received.

All other expenditure is generally recognised when it is incurred.
