Report of the Deacons (the Managing Trustees)

Who we are and how we work

Highbury Congregational Church began in 1827 and is an independent Church that is part of the Congregational Federation. While we work closely with other churches all we do is decided and funded by our own Church Members. We do not have any outside source of funding and we do not have any outside body over us. All who belong are welcomed into church membership on confession of faith in God and Jesus Christ as Lord and Saviour. Those Church Members meet together in the quarterly Church Meeting to seek the mind of Christ in shaping the life of the Church and setting the future direction of Church life. There is a team of Ministry Leaders serving the Church: Andrea Lacey in Children's work, Mary Buchanan in Youth work, Jean Gregory in Mission and Outreach, Lorraine Gasside, Louise Middleton and Rachel Jacques in Pastoral Care, Judi Marsh in Discipleship and Sharon Wallington (who has finished at the end of 2017) in Worship. The Deacons serve the church as Managing Trustees and ensure all the Church does is in keeping with its aims as a Congregational Church and its responsibilities as a Charity with reference to finances,

safeguarding, health and safety, disability, employment and other legislation. They are Iain MacLeod, Ted Horsfield, Darryl Mills, Janet Partington and Kate Blazey (Peter Harrison was Deacon until June 2017). Helen Roberts (who is finishing at the AGM in March) is on the Diaconate as Church Secretary and Roger Gregory as Treasurer. Richard Cleaves serves the whole Church as Minister. We are part of the Congregational Federation and are registered as a Charity 1159085. We have adopted the Congregational Federation's Declaration of Trust as our Governing Document together with our own Working Practices document.

Our Objects and Vision

The principal purpose of our church as summed up in our foundation documents is 'the advancement of the Christian faith according to the principles and usages for the time being of Congregationalism'. We 'may also advance education, relieve need and carry out other charitable purposes in the UK and other parts of the world.' Our vision is that Highbury be a place to share Christian friendship, explore Christian faith and enter into Christian mission with Christ at the centre and open to all.

Our Vision and Aims for 2017

Three years after we re-organised the life of our church, focusing on three main areas: Renewal and Gifts, Personal Faith and Prayer, Mission and Outreach we carried out a survey of those belonging to the church at the beginning of 2017 which formed the basis for discussion at our Annual Meeting in March and helped us shape our plans for the next three years. We set out our plans to focus on *Giving for Growth* to build up the way we all give our talents, time and money in the work of the kingdom. That very much tied in with the plans we have begun to make following the the announcement of our Minister's retirement in July 2018. In worship and in pastoral care our focus has been on involving people in the life of the church. We have continued to build up our Community café and monthly lunch. We have taken steps during the year to become a Dementia Friendly church, enlisting many of our church family as 'Dementia Friends' with the Alzheimer's Society.

Benefitting People Through Church

As a registered charity we are obliged to demonstrate in our Annual Report that all we do is 'of public benefit'. As a church we exist for the benefit of other people: the detailed reports in this issue of Highbury News demonstrate the difference we make in so many different areas! Pastoral Care is at the heart of all we do.

Pastoral Care is right at the heart of what we do as a church family. Rachel Jacques and Louise Middleton joined Lorrane Gasside as our Pastoral Care Ministry Leaders. They support a team of visitors who offer pastoral care in the church family and beyond. We have had two evenings to build up our pastoral care: the first focused on the support of people living with dementia and led to us enlisting people from church as 'Dementia Friends' and registering as a Dementia Friendly church. The second was a training session on the use of the church's defibrillator.

We firmly believe that pastoral care has to do not only with physical and emotional needs but also with spiritual needs as well. Our Pastoral Care links in closely to our **Worship.** It is in worship and prayer as we make connections between the Bible and the everyday world people are living in that we seek to offer a source of spiritual strength and renewal to help people in the living of their lives. Our Sunday morning service brings people of all ages together in a setting where young people and children can make a world of difference to older people and those older people can be a real support to families with young children. It has also been a setting where visiting speakers have challenged us to go beyond our comfort zone. Our evening service meets the needs of a smaller group of mainly older people who value the opportunity for quiet reflection. Worship also happens at our monthly Messy Church celebration when we have a fun way of doing church that's aimed at families with younger children.

Faith is not something that comes as a neat package with all the loose ends neatly tied up! It can be messy and there's always something more to explore. The focus of our **Discipleship** ministry has been on our Explore evenings. We linked those evenings with themes we have been exploring on Sundays. Tuesday evenings give an opportunity to explore our faith together. We completed the Congregational Federation's GIFT Course and have developed links with Open Doors and the persecuted church. Our explore evenings have also given people the opportunity to develop their creativity with some inspirational craft sessions and evenings when we have sung hymns together from our new hymn book.

As part of our **Mission and Outreach** locally we have developed the use of our café space and our community café and on a number of occasions been joined by friends from Charlton Lane at our monthly lunch. That has become one of those many initiatives we take for granted at church that seek to counter the reality of loneliness. We were again involved with the local Fairview Community Association, supporting their firework display. It was good to be part of the Christian Arts Festival once again, showing some stimulating and thought-provoking films. Our Family Film Club is well attended and gives families the opportunity to enjoy some recent releases in a community setting. Our digital Scalextric club, Hy-Speed, is in need of more helpers, but took the track to the Charlton Rovers fun day at the end of their season. We hosted a day conference to mark the centenary of the Balfour Declaration, bringing Jewish, Christian and Muslim speakers together, two of whom had come over from the West Bank specially. We have continued to give very practical support to Cheltenham Welcomes Refugees and also to FoodShare, CCP's Food bank.

Our work with **children** is another important part of our outreach into the community. Our Toddler Group has gone from strength to strength through the year and once again we have been able to make some very real connections with church through Messy Church and the Family Film Club. Our Open the Book team continues to take assemblies at Oakwood School and Richard, our Minister, assemblies at St John's and three special assemblies at Christmas Easter and Harvest at Belmont School. We once again welcomed Pittville Year 7's for their Christmas carol service. We have worked with St John's school children to do the Women's World Day of Prayer Service and enabled the school to use the church for music lessons. We participated in their 150th Anniversary Celebrations and in their Christmas Fair.

Our **young people** challenged us to undertake an Eco-Church survey and reflect on ways we can make the church more eco-friendly. Hy-Tec, our youth group continues to meet on Sunday nights and Hy-Tide during the service on Sunday mornings. One of our young people, Adam Schonbeck, has worked with Rob Lacey to live-stream our morning services for older people in care homes to share in our worship.

Benefitting People in our Community

For a town committed to the arts, with a large number of retired people there is a surprisingly small number of venues available for community use. In the last twenty-five years most of the venues in Cheltenham have been closed. We are among many churches to make our premises available extensively to the community. Re-furbishment projects over the years, most recently the creation of a foyer for the hall and of a café space and a servery in the church itself, have made our premises more attractive: they are fully accessible for people with disabilities throughout, with a loop system in the hall as well as the church itself. We are deeply indebted to Peter Harrison who has developed this part of our service of the community immensely. There are now something like 25 groups using our premises regularly.

A number of groups provide *care and support* to people with particular needs: the Highbury Club supports those with visual impairment and others, we host two Narcotics Anonymous groups and one Gamblers Anonymous group. There are two heart to heart exercise classes and one balance class. Our premises are used from time by the NHS 2Gether trust.

There are a number of *life-long learning* groups, including various U3A classes, teaching art, the history of art, bridge, and Shakespeare. This year has seen the start of some WEA groups and the regular use of the premises by various art classes. We also host a lacemakers class, the Carlton Lacemakers, and two upholstery classes. The Mid-life Choirsis choir continues to rehearse and we welcome Monkey Music for wonderful music sessions with toddlers and their parents.

Among the *interest groups* is the NHS Retirement fellowship and we also provide a venue for the committee of the Cheltenham Horticultural Society. The hall is frequently used for children's parties.

We are host to Brownies and Guides and also to Beavers, Cubs and Scouts. The church has been involved with Guiding and Scouting from the very beginnings of both movements.

Benefitting People in the Local Community

Each week we collect something like 25 kilos of food packages for CCPS's FoodShare Food Bank. Each month we have a special collection mainly for local charities. In 2017 we supported Oxford Vasculitis Association, Dream Days, Cheltenham Welcomes Refugees, Cheltenham Youth for Christ, St Vincent's and St George's Association, Heidi's Heroes, Listening Post Counselling service, MS Society, Langley House Trust and the Knole providing care for ex-

offenders, CCP's Hamper Scamper Christmas appeal for families. We supported Hamper Scamper instead of the Operation Christmas Child shoebox appeal this year. Our special Christmas collection was for the work locally of Winston's Wish, caring for children in bereavement.

Benefitting People in the Wider World

Our harvest special collection went to the Shepherds Society run by Bethlehem Bible College to bring much needed support to Palestinians and other son the West Bank and in Jordan. We are in a world mission partnership through the Council for World Mission and this year welcomed people from a number of different churches to a special celebration of their 40th anniversary. The preacher was a mission partner from Jamaica now working in South Africa who had been Moderator of CWM, the Rev Dr Roderick Hewitt. In 2017 Stefan and Birgit and family returned from 10 years working in theological education in Brazil: Stefan has taken a post teaching Biblical Studies in a theological seminary in Brazil. We continue our support of Children's Homes in Kerala State, of Cecilia, whose father is in prison in Zambia. We have built up our support for the work of Embrace the Middle East, Middle East Concern and Open Doors in their work around the Middle East, especially with the persecuted church. Our Minister, Richard Cleaves, has continued his work of teaching with the Congregational Institute for Practical Theology and with the support of the church has contributed to the 2nd Edition of Philip Esler's *Early Christian World* (Routledge, 2017)

Our Vision and Aims for 2018

At the beginning of January 2018 we welcomed a number of people who made a profession of faith and became members of our church and we also invited all church members to renew their commitment. We then launched Giving for Growth with special services encouraging people to reflect on the importance of Giving time, talents and money for the growth of the church. We have sought help and guidance from the Congregational Federation and Yvonne Campbell, the General Secretary, to set about making plans for a vacancy and for future ministry in the church. Prompted by those reflections our aim for 2018 is to build on Giving for Growth and seek to come together with a shared purpose in seeking a new way forward for the church and its ministry.
