The purpose of the Charity is to advance the Christian faith in the Area of Benefit in accordance with the principles and practices of the Participating Churches.

St Andrews Church, Devizes is set up to benefit the public in general. All meetings are free of charge and open to all. Services and facilities are provided to all in the local community who will benefit from them.

The Church's purpose is beneficial through the promotion of individual and family stability and wellbeing and increased ability to contribute positively to society. Pastoral work focuses on visiting the sick and the bereaved.

Groups benefiting from activities and facilities include, but are not restricted to, the elderly, the young and other groups with special needs. The Church seeks to meet the spiritual, mental and physical needs of people in the community. No detriment or harm is expected to result from the church's purpose. The Church seeks to develop and maintain positive relationships with other faith and non-faith groups. Families and individuals will benefit from meeting their spiritual, mental and physical needs. No financial benefits are paid by the Church.

Achievements and performance

Summary of the main achievements of the charity during the year

Church Secretary

Much has happened since our last annual report. We have celebrated the Church Festivals of Advent, Christmas, Lent and Easter, all with themes to help our thoughts through those times. We are grateful to those who, through the year, have arranged flowers, have kept the Church tidy, served coffees and teas, welcomed people at the door, and all the things that make us the people of St. Andrew's.

Our Church building continues to be used both for Church activities and also for community activities. It is regarded as a 'good' place to be, and people are pleased to have a warm place to meet in. That's the building, but I feel that we, as a Church community, have been challenged by the 'Walking the Way' Day that we shared in Swindon. We all acknowledge that, nationally, there are now fewer people attending regular worship, and our challenge is to share the love of God shown to us in Jesus, with those we meet day by day. This is not always an easy thing to do, but one that we are challenged to face.

We have had, and will continue to have, many shared meals, where we enjoy good food and also good conversation. St. Andrew's is good at providing meals - and cakes, and I would thank all those who help in this social activity. The Big Breakfast is also an opportunity to welcome people into our Church community and many people look forward to that.

Property Group

No major works have been carried out. The focus for the year was on general maintenance and upkeep. Main elements of maintenance have been: door handles; system battery replacement, estate tidy; damp control in the side vestibule; cleaning the bulk of the fabric and fittings, painting and facility updating.

Lettings of Church Premises

Our Church premises are used regularly by a range of 'outside groups' who pay for their use, as well as many groups with Church connections who do not pay but in some cases make donations.

Over the last year we have dropped from nine to eight regular outside groups paying to use our premises. This means the Hall is available on a weekly basis on Thursday afternoons and evenings and Friday afternoons. However, there are a reasonable number of repeat occasional users.

Letting income to the church has averaged around £13,200 over the last five years.

Pastoral Secretary

Currently 21 volunteers are involved with pastoral contact and visits. We aim to have a pastoral contact for all church members and friends. Some visitors have been very busy this year supporting people in their groups through difficult times. We are very grateful to them all.

The church membership lists have been kept up to date. We were pleased to welcome 12 new people into membership. Sadly, we have had to report the deaths of 5 members or friends since the last AGM.

Christmas gifts to the value of £162.50 were gratefully received by our older members and friends.

Section D

Achievements and performance

Safeguarding

The Safeguarding representative for St Andrew's Church makes sure that we have the procedures in place to keep both our children **and** our vulnerable adults safe. However, all members have a part to play in safeguarding and should become informed and undergo training if involved with these two groups.

Renewal of DBSs for those working with children at St Andrew's Church is in progress.

There have been no disclosures made concerning either children or vulnerable adults this year.

Monday UFO's (Under Fives' Organisation)

We have had an up and down year numberwise, but we have tried to make it fun for the children who have come. We have coloured, glued, snipped, read stories and put together jigsaws. The Mums and minders have chatted and enjoyed a cup of tea while the children have played.

Thursday UFO's

Thursday Mums and Toddlers continue to thrive. We have a good selection of run-around toys, a kitchen, a slide, a trampoline and several items suitable for tiny one as well as a good selection of books. All of thee we aim to keep in good condition and replace when necessary.

Messy Church

We are now coming to the end of our ninth year of Messy Church at St. Andrew's. During this time we have had over 80 families come along – some for a couple of times and others who have stayed with us for several years. Some of our older youngsters come along to help.

We have been operating once a month, on the second Sunday, for the past two and a half years. With the competition of so many activities on Sundays now, we have to continue to work hard with our planning and keeping Messy Church fresh and inspiring.

Tuesday Fellowship

The Tuesday Fellowship is flourishing. Our numbers attending every Tuesday afternoon remain constant averaging 24. We are all one, big, happy family, maintaining the tradition of opening and closing the meeting with devotions.

Our income is solely from a voluntary collection and there is usually around £400 to donate to charities at year end. Our speakers have included travellers' tales from Fiji, Cornwall, Kenya and Mexico. We have seen quilting, heard advice about relating to dementia sufferers, the story of Imber village and a history of musicals to name a few.

Choir and Music Group

The Choir helps lead our music on Sundays. It has dedicated members but always welcomes new ones. We have three organists who bring variety to the style of playing.

The music group continues to enjoy playing music together and using their talent to support worship both at St Andrew's, Trinity Church at Market Lavington and for Churches Together events such as Christmas Carols in Albion Place which was broadcast by Fantasy radio. The Wharf Service was a 'sing a long' rather than a service and it was well attended. This year we have had musicians from other churches join us at our Monday rehearsal and that has enriched our friendships and music.

Achievements and performance

Ladies Evening Group

Ladies Evening Group continues to flourish, with about 50 members, over half of whom have no connection with St Andrew's Church. We feel we are an excellent outreach into the community. We meet on the 1st and 3rd Tuesday evenings of every month from September to June and we are a good place to meet and make friends – especially over tea/coffee at the end of the meetings.

This year we have again enjoyed interesting and varied talks on a wide range of topics. Once again, the Autumn Fayre organised by our group did well, raising the sum of £586.00 for Church funds.

Social & Catering (SOCAT)

This is the group that involved with social and catering events within Church. This includes everything from Sunday lunches to fundraising activities. We meet every 2 months, usually on a Friday morning, to plan upcoming events and get others involved too.

We are always looking for ideas to put on different events to support and build up the social side of church membership. We also look outwards as we share our faith, welcoming and encouraging those who are yet to find faith. Sometimes we just do things to have a good laugh.

We owe a duty of care to anyone eating the food we produce, particularly where there is a payment. We have mostly all been on food hygiene courses and operate the kitchen following the standards you would expect in cafes or restaurants.

House Groups

Three House Groups meet twice a month and provide quality time in which all sorts of life and faith matters are talked about in a relaxed setting. Members support each other and pray for situations they are concerned about.

Poetry Group

The Poetry Group meets monthly to read poems on a chosen topic or theme. Recently you would have found us in a member's home as we 'wander'd lonely as a cloud', visited 'Adelstrop' and 'slipped the surly bonds of earth and touched the face of God'. We have even tried our hands at writing our own short 'haiku' poems. There is usually 7 or 8 of us from several churches reading aloud and enjoying a wide variety of poetry - a bit like 'Poetry Please' on Radio 4.

St Andrew's Traidcraft Store

Traidcraft was set up as a faith organisation in 1979. It aims to tackle poverty by creating a market for fair trade producers. The monthly Traidcraft stall at St Andrew's contributes in a small way to achieving this aim by providing an outlet for some Traidcraft items – mainly food, of which we stock 25 different items. These can be purchased knowing that the producers (who in other circumstances would only be paid a pittance) will get a fairer share of the purchase price. The current annual turnover of the stall is in the region of £2,000.

Art Group

The Art Group started in October 2015 and meets on a Wednesday afternoon twice a month in the Church Hall. The group is open to anyone who enjoys art – painting and drawing in a variety of mediums. We usually have at least six people joining us including friends from outside the church membership.

Section E

Financial review

Brief statement of the charity's policy on reserves

Unrestricted (ie General) Funds are used for the day to day running of the Church.

The main reasons for holding general reserves are:

- To ensure that the church always has funds available to pay its way (working capital).
- To protect against unforeseen circumstances ie loss of income and increased expenditure (eg urgent repairs or replacement of equipment).
- To enable the Church to respond to new opportunities for mission and service.

The target level of reserves is between £30,000 to £40,000: £15,000 to £20,000 for working capital and £15,000 to £20,000 for unforeseen circumstances and opportunities. Actual general reserves at 31 August 2017 were £32,797 (2016: £35,699).

Restricted Funds are utilised for the purposes for which the funds have been set aside. The funds are utilised in a time frame set by the Church Council. Actual restricted reserves at 31 August 2017 were £26,204 (2016: £26,987) to be used for repairs, maintenance and improvements to property.

Churches Together in Devizes

The Church plays an active role as a member of Churches Together in Devizes, being one of eight churches representing a broad range of worship across the town which together focus on four priorities:

- 1) Grow more confident in faith,
- 2) Champion social justice,
- 3) Nurture children and young people and
- 4) Be good stewards of the environment.

Wiltshire United Area Methodist/United Reformed

The Church is part of the Wiltshire United Area Methodist/United Reformed which covers a mixed urban/rural area of Wiltshire and includes the expanding towns of Trowbridge, Warminster, Westbury, Devizes, Calne, Corsham, Bradford-on-Avon and Melksham, together with the surrounding villages of Whitley, Winsley, Bromham, Semmington, Seend, Steeple Ashton, Market Lavington, Monks Chapel, Chittoe Heath, Holt and Hilperton. The Wiltshire United Area is committed to:-

- worshipping God in meaningful ways
- · drawing upon the power of prayer
- · recognising, receiving and sharing the love of God
- encouraging Church growth in town and village churches
- · developing ecumenical links
- · reaching out to the wider community
- seeking to meet the needs of all age groups

Charities

The Church supports many charities whose objectives and activities are in line with those of the Church. In addition to raising funds for specific charities (eg Christian Aid) the Church is committed to supporting from its own funds three charities for a period of three years — The Devizes foodbank (a local charity), The Samaritans (a national charity) and The Turning Point Trust (an international charity).
