The accounts record an amount of £3454 that was outstanding at the end of the year. This debt was the balance of a debt of £7470 that the Treasurer incurred in the course of arranging the funding for the 2015 ECS annual tour.

The full debt of £7470 was correctly shown in the accounts at 31 August 2015. The accounts for the year to 31 August 2016 showed partial repayment in the amount of £4026, but omitted to show the balance of £3454 due to oversight. The accounts for the year to 31 August 2017 correctly show the outstanding debt and include a note explaining the debt.

The debt was overlooked in the 2016 accounts because the Treasurer incorrectly believed that he had repaid the debt in full. The Treasurer repaid the full remaining balance of £3454 shortly before the AGM on 25 October 2017. The accounts examiner and the Committee are content that this repayment closes the matter. The Committee and the Treasurer agree that in future the Treasurer will not incur any debt to the ECS without clear Committee oversight.

The items relating to the 2016 tour in the 2017 accounts represent the partial refund to members of surplus arising on the 2016 tour.

Objectives and activities

The objects of the Society are to further and assist in the musical education of people of the Borough of Epsom and Ewell and neighbouring areas. To provide facilities for the study and rehearsal of choral and other music by promoting and participating in public performance and to support and participate in the Leith Hill Musical Festival and other festivals and activities related to its objects.

We have had a very busy year singing many different styles of music from a concert spanning a century of English music, through sacred music by Janáček and Rossini, to a dramatic finale of opera highlights.

We were able to put on the opera concert thanks to two generous bequests from long-serving members of the choir, Cecil Wiltshire and Mary Craddock-Jones. Their generosity also funded an entertaining choral workshop with Ghislaine Morgan last May.

Concerts

In November 2016 the choir gave a performance of Benjamin Britten's Cantata Saint Nicolas in St. Martin's Parish Church. In this performance we were joined by both the Nonsuch School Chamber Choir and trebles from Unicorn Singers Kew. The concert also included works by Parry, Tavener and Howells and we were accompanied by Marion Lea and Ben Lewis Smith on piano with Peter Jaekel on the organ.

Our annual Carol concert on 17th December 2016 was held in St. Martin's Parish Church with the help of a lively brass band. At the end there was a retiring collection for The Children's Trust.

Early in March 2017 many choir members participated in the Leith Hill Musical Festival performance of Bach St. Matthew Passion conducted by Jonathan Willcocks.

On Saturday 11th March 2017, accompanied by organist Ben Lewis Smith, pianist Marion Lea, harpist Fontane Liang and four young student soloists, the choir performed, in St. Martin's Church, a Spring Concert comprising Rossini Petite Messe Solennelle and Janacek Otcenas (The Lord's Prayer).

On Saturday 10th June 2017, in St. Andrew's United Reformed Church Cheam, accompanied by a large orchestra and three soloists the choir gave a concert featuring Famous Choruses from Opera.

Leith Hill Musical Festival

March saw us join members of all the Leith Hill choirs to sing a performance of Bach's St. Matthew Passion at the Dorking Halls. In April the choir participated in the Leith Hill Musical Festival in Dorking. The main works in the evening concert were Ralph Vaughan Williams Dona Nobis Pacem and Parry Blest Pair of Sirens.

Tour to Chantilly

Our Choir tour in July this year was a return visit to Chantilly in France where we gave a concert of music by Brahms, Stanford, Parry, Mendelssohn, Bach, Finzi, Fauré and Adrian Payne in the Eglise Notre-Dame de Chantilly. This was followed by singing in Mass in this church the following Sunday morning.

Fund Raising

In December choir members sang carols in Epsom's Ashley Centre which enabled Epsom Hospital Medical Fund to collect £398 and, later in the month, Parkinson's UK to collect £700. Thanks go to Martin Seath for conducting us on both occasions.

Our annual Carol concert on 17th December 2016 was held in St. Martin's Parish Church. At the end there was a retiring collection which enabled The Children's Trust to collect £470.62.

The Plant sale was once again held by Sue and John Taylor in their garden. They raised a magnificent total of £1310.25 for choir funds. Many thanks go to John and Sue and all their many helpers including Anne Richardson who made up many beautiful hanging baskets.

Social events

The beetle drive party held in February was tremendous fun with everyone concentrating on adding to their beetles and winners and losers moving round onto new tables. All was brilliantly organised by Helen Phillips and Roger Barnard and a whole host of helpers and £472 was raised for choir funds. Thank you to all.

Membership

At the end of April one of our Vice Presidents - Rosemary Gibbs sadly passed away.

We had 6 new members and 3 returning members join us over the course of the last season and ended with 50 Sopranos, 35 Contraltos, 12 Tenors and 21 Basses totalling 118 members.

Administrative Information

The Society is governed by its constitution which was adopted on 2nd March 1977 and amended on 23rd October 2013.

NOTES TO ACCOUNTS 2016-17

Note 1:

In the accounts of 2014-15, a debt of £7470 was incurred by the Treasurer as an element of the 2015 tour. In the accounts of 2015-16, a partial repayment of £4026 is recorded in respect of this debt. Although the Treasurer believed that the debt had been fully repaid, efforts to identify the repayment of the balance of £3454 have not been successful. Hence it appears that an outstanding debtor of £3454 ought to have been included in the 2015-16 accounts. The Treasurer continues to investigate this matter, but in the event that full repayment cannot be clearly demonstrated, he will pay the balance of £3454 to ECS before the end of 2017.

Note 2:

The Opera concert was agreed by the committee, with the intention of using some legacy funding to cover the exceptional losses which would be made by such a major concert. I have allocated £5000 to the legacy expenditure, as the committee agreed that the loss should be similar to a normal "large concert".

Note 3:

The LHMF shows a loss, although each attendee pays the full fee, but I allocate the Musical Directors festival costs to this line.

Note 4:

Music Hire shows a loss, due to the charges now levied by the Parish for storage of our Library in the hall balcony.

Note 5:

We took the decision to invest in lighting, rather than hiring for each concert, as a sale of equipment came up, which meant that for the equivalent of a year's hire, we could own our own.

Note 6:

The legacy situation in total is summarised on the attached report.
