Summary of the objects of the charity set out in its governing document	To advance education and relieve need in Africa in such a way as the Trustees may from time to time determine, in particular but not exclusively by the provision of educational programmes, learning resources and feeding programmes in schools and local communities.

We provide funding to our partner school to deliver the following projects:

• **Compassionate Programme** which enables local children to receive an education that they deserve. These children are from homes where parents struggle to feed and clothe their children. We are currently supporting 30 children at Ngong Hillside Academy but we need to expand the Programme to enable more children to attend school.

When they join the Programme each child receives a track suit and a school bag filled with learning and writing materials.

In addition to supporting the children during school terms we hold Compassionate Programme Weeks during the Easter, Summer and Christmas. This is a week long Programme involving craftwork, playing games and day trips. At the end of the week the Trust donate a food parcel containing flour, rice and cooking oil to their parents to sustain them through the holidays.

To celebrate Christmas, each child received a gift from The Bouncing Ball Trust of either a dress for girls and a shirt and trousers for boys.

- Feeding Programme providing children with a hot, nourishing meal at lunchtime. These lunches are often the only hot meal that the children receive during the week. Already the Feeding Programme is making a difference to the health of the children, leading to an improvement in their academic performance.
- **Reading Programme**: Working in partnership with the Teach A Friend To Read charity we oganised run a pilot one-to-one reading scheme in the Ngong Hills and are planning to roll this across Kenya. The Reading Programme will make a real difference to the lives of Kenyans and will empower them to better their own and their communities' lives.

In addition to above projects we have provided financial support to our partner school. To cope with the increasing school roll we have bought new desks and chairs, and blackboards for the school.

The Trustees take cognisance of the Charity Commission's guidance on public benefit when considering proposals for fujding from our partner school for the programmes.
