The major risks stem from the fluctuation of pupil numbers and the availability of teachers. The Charity manages the former by maintaining reserves that allow the Charity to operate, for a limited period of time, classes that are not viable due to a decrease in pupil numbers. This situation can also arise when classes have to be split due to an increase in pupil numbers. This could also result in individual classes temporarily being run below break-even point. We manage the potential shortage of teachers by maintaining a network of supply teachers and teaching assistants, and by ensuring a good working relationship with other Dutch language schools in the area (e.g. Fulham Dutch School, "De Regenboogschool", etc).

The charity in general aims to maintain links with other Dutch and Flemish charitable, governmental and educational organisations. The charity in particular aims to maintain friendly relationships with other non-profit organisations which aim to promote the Dutch language and Dutch-Flemish culture in the world, the UK and London in particular. There are no formal relation between the Richmond Dutch School and any of these organisations.

The trustees see major risk in UK leaving the EU and the impact this could have on the size of the Dutch-speaking community in the UK. Events will be followed closely, in particular the treatment of both EU residents currently residing in the UK as well as the restrictions that could be imposed on immigration from the EU, and the Netherlands and Belgium in particular.

Now the school is more established, the charity will need to further strengthen its governance structure and increase the involvement by parents, and attract new/additional trustees.

Summary of the objects of the charity set out in its governing document

The charity's objects ("the objects") are the advancement of education for the public benefit, in particular by providing Dutch language and Dutch/Flemish culture classes to primary school-aged children from homes with one or two Dutch-speaking parent(s), as a means to help these families maintain the Dutch language and retain links with their cultural heritage. The geographical limit of the charity is the Borough of Richmond and close surrounding areas.

The charity provided Dutch language and Dutch/Flemish culture classes to primary school-aged children from homes with one or two Dutchspeaking parent(s).

The Charity gave financial support to families with more than one child by offering a 10% discount to first siblings and a 50% discount to any siblings thereafter. The Charity also provided a 50% bursary to a family who was not able to meet the tuition fees.

The charity's constitution foresees discounted fees for parents in financial difficulties.

Achievements and performance

Summary of the main achievements of the charity during the year

During the period covered by this Annual report, the Charity's ability to promote the Dutch language among primary school-aged children from dual-language families grew from 30 pupils and 3 parallel classes representing different capability levels to 35 pupils and 4 parallel classes.

The Charity made significant progress in its day-to-day management and curriculum enhancement by appointing an Executive Director experienced in the organisation and curriculum of Dutch language classes to children. The Charity also decided to focus its efforts on school-aged children by ceasing to provide the monthly Dutch stay and play session for pre-school children. The sessions were increasingly becoming a drain on both financial and human resources without a noticeable impact on the advancement of either the Dutch language or Dutch/Flemish culture.

The charity was able to maintain its reserves over this period to ensure it retained a buffer for short term student number fluctuations.
