Report of the Trustees for the Year Ended 31 December 2016

The Trustees present their report with the financial statements of the company for the year ended 31 December 2016.

1. ORGANISATION

Geraldine Connor Foundation is a company limited by guarantee. The members of the company are also its Trustees. The Trustees hold quartely meetings, one of which is the AGM. Day-to-day management of the charity and its activities is delegated to Selina McGonagle, the charity's director.

2. GOVERNING DOCUMENT

The governing document is the articles of association of the company dated 18th December 2012.

3. OBJECTIVES

The objects of the company are the advancement of the arts and culture in particular by:

- continuing the work and vision of Geraldine Connor in advancing the development and education of
 individuals in the arts and culture, and thereby developing professional and life skills, encouraging and
 nurturing new work and talent, and encouraging and promoting equality, diversity, empowerment and
 inclusion in society through the Arts.
- providing opportunities in the Arts that might not otherwise be available for talented individuals.
- advancing the development of young people looking for guidance in the performing arts, in particular (but not exclusively) by giving them the opportunity to experience, participate and learn from projects with Caribbean culture through the performing arts.

In setting the objectives, the Trustees have given careful consideration to the Charity Commission guidance on public benefit.

4. ACTIVITIES AND ACHIEVEMENTS

The Geraldine Connor Foundation (GCF) appointed a new charity director, Selina McGonagle, in March 2016. To assist with the governance of GCF, two consultation groups have been formed; *Ambassadors* and *Creative Associates*. The *Ambassadors* are a group of 10 people (aged 14+) who have participated in GCF projects and wish to pursue a career in the arts and agree to advocate on our behalf. In 2016 the group met 3 times to discuss and evaluate the work of GCF. The *Creative Associates* are professional artists who either worked with Geraldine Connor or who have delivered work for GCF. They understand the ethos of the work we deliver and are willing to assist in the artistic programming of the Foundation. In 2016, the *Creative Artists* met twice and we have 10 associate artists.

The board of trustees met 3 times, including an AGM, and we have recruited 1 new board member, Pamela Johnson.

Sarah Sarhandi created *Both Universe*, a new production which explored her story as an artist with joint British and Pakistani heritage and her experiences in the two contrating worlds of Karachi and London. The multi-layered performance of music, dance and film was a collaboration between artists from Pakistan and the UK. The production was performed as part of the Alchemy festival in London at the Southbank Centre in May 2016 and in Bradford at Kala Sangam in June 2016.

Our consistent arts programme for young people, *Creative Café*, was delivered in partnership with Leeds City College. In June artists Lladel Bryant and Zodwa Nyoni delivered "Who am I?", a 6 week course of workshops in film and drama where the participants explored their own lives and heritage. The participants produced short films of dramatic monologue delivered to camera. In October, *Caution Collective* and artist Christella Litras worked with the young people on singing, song writing and performance. The participants created their own songs and performed to an audience.

Report of the Trustees for the Year Ended 31 December 2016

We continue to develop *Forest Dreaming*, a musical theatre version of Shakespeare's A Midsummer Night's Dream. Writer Pat Cumper and composer Domique Le Gendre have been commissioned to write the score. In August, to assist with the creation of the production, we brought together artists and participants to work together on the themes of the production. This Creative Lab was an intensive week of music, dance and theatre, working together to ensure that the final production is relevant and entertaining to new audiences.

We supported artist Sheila Howarth for creating costumes for the Leeds West Indian Carnival 2016.

In September, with financial assistance from the Creative Employment Programme, we employed a Communications Intern, Kathleen Helm. The focus of her work is to build our online audiences and profile on social media.

5. FINANCIAL REVIEW

Principal sources of funding in the year were the sale of Harewood rum, which was gifted to Lord Harewood's Charitable Settlement, which then donated the proceeds of £81,000 to the Geraldine Connor Foundation and £50,000 from the Emerald Foundation.

6. RESERVES POLICY

The net funds of the charity at 31 December 2016 were £157,995. These were held at the year end to finance the administration of the charity and its future plans as described below. The Trustees have a target to maintain free reserves at around £75,000 to enable the Foundation to deal with fluctuations in income levels.

The funds of the charity are unrestricted.

7. FUTURE PLANS

In 2017 we aim to:

- Continue to deliver consistent participatory arts activities for young people in Leeds. We are exploring further opportunities in Bradford.
- Work with our Ambassadors and Creative Artists to ensure GCF is appropriate for you people and of the highest artistic standard.
- Produce two new artistic projects/ productions.
- Celebrate 10 years since the last performance of Carnival Messiah through the presentation of the Carnival Messiah film.
- Continue to develop Forest Dreaming through further research, development and performance.
- Develop the Foundation's staff team
- Fundraise for the core costs of the organisation.

Our aims are to further explore creative work that celebrates work of cultural significance including that of the Caribbean and develop audiences for this work; to engage young people and young artists with participatory work that further develops their skills and aspirations in the performing arts and who can contribute to the future development of the organisation; to work with artists many of whom worked with Geraldine Connor to further shape the artistic direction of the organisation; to ensure longer term financial support for the charity and staff the company accordingly.

Report of the Independent Examiner to the Trustees and Directors of Geraldine Connor Foundation
