118th Annual Report of the Council of the London Topographical Society for 2017

Our 117th Annual General Meeting was held on Thursday, 6th July 2017 in the Octagon, Queen Mary University, Mile End Road. It was well attended and after the formalities of the meeting there were short talks by Alastair Owens, Professor of Historical Geography at the QM University, who spoke on the Octagon, the People's Palace, the College generally and the burial ground; and Bernard Nurse, author of the Society's 2017 publication, who spoke about his work.

Council meetings were held in January, April and September to discuss the Society's publications programme, membership, finances and general administration.

The Society's annual publication for 2017, a joint venture with the Bodleian Library, was *London: Prints & Drawings before 1800* (LTS No. 179) by Society member Bernard Nurse. It contains more than one hundred images of the Greater London area before 1800 from maps, drawings, manuscripts, printed books and engravings, all from the Gough Collection at the Bodleian Library, providing a fascinating insight into life in Georgian London.

During 2017 long-serving Council Member, Michael Port resigned, and Caroline Barron and Andrew Thorp were elected to the Council at the AGM. Sadly, David Webb, a long-time member of the Society and Council Member, died in 2017.

The Society's total income for 2017 was £50,986 while expenditure came to £33,851.

The Society made a single grant this year of £10,000 to the British Film Institute (BFI), the third of three annual grants, for digitisation and cataloguing a series of short historical films about London which the BFI may produce, in conjunction with the LTS, as a DVD in 2019.

During the year 49 new members joined the Society: at the end of 2016 there were 1240 paid-up members and four honorary members.

Our *Newsletter* was published in May (No. 84) and November (No. 85) with articles ranging widely over London both past and present. The two Newsletters' front cover pictures of old views of London provided attractive tasters for our major publications.

Purchasing Properties in East London in the Early Nineteenth Century: the London Dock Company in the 1800s, by Derek Morris, and *Copyhold Tenure in the Manor of Stepney*, by Mark Ballard, provided documentary evidence for the development of London's East End, while Dorian Gerhold's *Radical Politics in the 1640s, Locating the Whalebone*, threw light on a corner of the City of London. Jeremy Smith wrote about the significance of the famous Visscher Panorama and its conservation (to which the LTS contributed), by Caroline de Stefani. *Discovering the Lawrence Wright Panorama of London*, by Hubert Pragnell, prepared us for one of our 2018 publications.

David Crawford's *A Railway Through Eight Millennia of London* surveyed the contribution of archaeology, and his article on *A New Theatre in the Round, a Transformation at the Brunel Museum*, brought us up to date with a striking innovation in an example of Victorian engineering. Another transformation noted was the new Design Museum created within the twentieth-century shell of the Commonwealth Institute building in Kensington, while the regular feature *Changing London* focussed on Walbrook in the City and the Serpentine Pavilion in Kensington Gardens. Book reviews discussed a variety of subjects; burial grounds and London south of the river proving popular themes, while the 'Bookshop corner' featured bookshops in Chelsea and Bloomsbury.
