REVIEW FOR THE YEAR ENDED 30TH SEPTEMBER 2017

As Chief Executive Officer I am pleased to present the Trustees' Annual Report together with the financial statements of Freedom Charity.

FREEDOM'S SUCCESS

Welcome to Freedom's report and end of year review for 2017

This year we have focussed our efforts in forging stronger links with the University of Winchester and have delivered talks and Masterclasses to their students and have made regular visits to the university throughout the year..

We continue to get calls to the Freedom helpline from victims and those looking for help for victims of abuse.



We have got recognition of our Red Triangle badge and this has now become the national symbol for FGM. Freedom's posters on the Red Triangle campaign were sent to every police force in the UK.

We also have been invited to deliver training on FGM to staff in NHS hospitals and doctors surgeries around England.

We have continued to visit schools, colleges and universities and donate copies of the novels '*But It's Not Fair*'

and '*Cut Flowers*'.

COMMUNICATION: PRINTED AND E-MEDIA

We have continued to develop the website to make it easier to navigate and have sections for teachers, professionals and easier ways to donate online.

The Freedom app was updated to include more information about FGM and signpost where victims and professionals can go to for help.

The novel '*Cut Flowers*', which was printed in June 2016 has been a great success and we have donated thousands of copies to schools and colleges around the country.

'*Cut Flowers*' comes with PSHE Association lesson plans that have been promoted on the PSHE Association website, leading to hundreds of enquiries from schools across England for copies.

The feedback we have had from teaching staff is that these are some of the best resources they have to tackle the sensitive issue of FGM.



EDUCATION

We are still working with the PSHE Association who have linked Freedom Charity on their website as a resource for accredited lesson plans, and we get several enquiries a week from schools for copies of the lessons we have produced.



Aneeta Prem was invited to be a keynote speaker at the annual PSHE Association conference and there was a lot of interest in Freedom's work in delivering training in schools.

Again this year there were numerous visits to schools, colleges and universities nationally; some were schools we have visited in the past who have asked us back, but most have been schools and colleges new

to us.

TRAINING PROFESSIONALS

We were invited to offer safeguarding training to not only NHS staff but other front line staff including several police forces,

In October we were invited to the University of Suffolk Education Festival for Headteachers and there was positive feedback from Headteachers who wanted to invite Freedom to deliver talks in their schools.

In January we were invited again to the University of Birmingham to deliver training to over 200 of their final year PGCE trainee teachers.

In March on International Women's Day IWD. Aneeta was asked to deliver a keynote address at Norwich Cathedral to highlight the work of Freedom, describing how we help empower women and girls. Aneeta had an invitation to visit the Prime Minister at Number 10 to celebrate IWD with other leading women.



In July we were asked by a domestic abuse charity to deliver a training session and talk at their annual conference. This was attended by over 200 people and Freedom donated copies of the '*Cut Flowers*' novel to all the delegates.

Freedom was again involved with key conference organisers in the last year and we were invited to deliver talks in events run by the Capita Conference, Optima and the PSHE Association as Freedom is recognised as the leader in the field of Forced Marriage. Aneeta was again Chair of the Capita conference on Forced Marriage. Freedom was consulted on the choice of guest speakers and the topics and format of the conference.

INFLUENCING

Freedom's Red Triangle become the national symbol for FGM. We had enquiries from police forces around the country to supply them with the badges. This campaign has been going from strength to strength.

Freedom has been in the news commenting on human rights abuses, child sexual exploitation and FGM.

The major news channels that Freedom have been featured on include Sky, BBC, and Channel 4 News.

Our posters went to every police station in the UK and Freedom has had TV and media coverage on the National symbol.

LOOKING FORWARD

We are planning to change the structure of the charity to a CIO in the coming year and to work closely with the University of Winchester to develop our teaching program into their curriculum for their teacher training and their social worker courses

We are planning to continue with promotion of the Red Triangle campaign and hope to have the badge out to most of the police forces in England for FGM awareness day in February.
