Trustees' Report

The trustees present their report and the financial statements for the year ended 30 June 2016. The trustees who served during the year and up to the date of this report are set out on page 1.

Structure, Governance & Management

London Nightline is a registered charity, number 1015744. The Charity's governing document is its Trust Deed, dated 3 December 1992.

The Charity is administered by a management committee comprising the Chair, Trustees, Coordinator and the Executive Committee. It is vested in the Trustees to run the Charity in accordance with its governing documents in order to meet its charitable objectives.

The major risks, to which the charity is exposed, as identified by the Trustees, are reviewed regularly and procedures have been established to manage those risks.

Objectives & Activities

The charity's stated objective is to provide relief to persons suffering from despair and distress who are students at any legal institution of higher education in London and its neighbourhood by the provision of a telephone helpline and other on-line support.

The trustees have considered the Charity Commission's guidance of public benefit in planning the charity's activities for the year.

Achievements and Performance

During the year ending 30 June 2016, the charity has continued to provide a term-time telephone helpline which is available to students in further education in London. The helpline provides support for students in distress or trouble using Skype, texting, chat and email services.

The helpline is available to over 250,000 students in London, on web at Open University website and is staffed by trained student volunteers from 6pm to 8am.

Financial Review

The charity's primary source of income is derived from higher education institutions and individual donors and benefactors. During the year the charity's cash funds have increased through careful management of its resources.

The charity continues to ensure it has the financial resources to maintain its objectives at all times.

The charity is seeking to move to a larger premises in the year to 30 June 2017 to accommodate the increase in number of students. The premises will require refurbishments which will be funded by the retained earnings.

Trustees' Report Cont.

Statement of Trustees' Responsibilities

The trustees are responsible for preparing the Trustees' Annual Report and the financial statements in accordance with the applicable law and United Kingdom Standards (United Kingdom Generally Accepted Accounting Practice).

Law applicable to charities in England and Wales requires the trustees to prepare financial statements for each financial year which give a true and fair view of the charity and of the incoming resources and the application of resources of the charity for that year. In preparing these financial statements, the trustees are required to:

- 1. Select suitable accounting policies and then apply them consistently;
- 2. Observe the methods and principles in the Charities SORP;
- 3. Make judgements and estimates that are reasonable and prudent;
- 4. State whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- 5. Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act of 1993 and the Charity Accounts and Reports Regulations of 2008. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the reservation and detection of fraud and other irregularities.

1 Accounting Policies

a) Accounting Standards

The financial statements have been prepared under the historical cost convention and in accordance with the Statement of Recommended Practice, Accounting and Reporting by Charities (SORP 2011), and the charities (accounts and reports) regulations 2011 and applicable accounting standards. The principal accounting policies adopted in the preparation of the financial statements are as follows:
