Treasurer's Report for the year ended 31 December 2017

Following the retirement of David Barker as Treasurer, I was appointed as his successor at the AGM on 23 April 2017. I am sure the whole congregation will join me in expressing a sincere thank you to David who has done a splendid job of steering the finances of the church over the last 10 years. At the PCC meeting held on the 13 November, Brook Carbutt was appointed as Independent Examiner and I wish to express my thanks to him for diligently fulfilling this time consuming role.

A set of Accounts examined by Brook and approved by the PCC follows, together with a copy of the Independent Examiner's Report. A full set has also been exhibited on the notice board [by the main door].

The Total receipts on unrestricted funds were $\pounds 87,046$, which included a grant of $\pounds 5,984$ towards the costs of tree felling and rebuilding part of the retaining wall to the graveyard. Gift Aid for 2017 was much lower when compared with 2016, as the 2016 figure also included a backlog from 2015. Gift Aid is now up to date and being claimed quarterly.

The actual total for 'giving/collections/donations' during 2017 was down by 8.97% on 2016, or £4,520. This is a cause for concern going forward as unfortunately the costs of running your church continue to increase. Whilst fund raising efforts were excellent, overall these produced less income in comparison with the previous year.

The PCC are most grateful that our Church was remembered in the Will of the late Fred Spurr who kindly left us a very generous pecuniary legacy of £1,000.

Since November, the Fellowship Area is now hired out Monday to Wednesdays between 3.30 p.m. and 7.15 p.m. during term times to enable children to be given extra tuition in the core subjects. The letting to the Oakwell Art Group, terminated in May, when they moved to the Birstall Community Centre.

We have managed once again to pay our parish share in full, however, looking forward to 2018 the share request has increased by almost 5%. We need to find £45,281 before we can even think about maintaining the building, paying the gas and electricity, insurance etc. etc..

Total outgoings on unrestricted funds during the year was $\pounds 93,974$. This means our expenses have exceeded our income by $\pounds 6,928$, not a sustainable position going forward.

Expenses, over and above the general running expenses of the church have included new Audio Visual equipment, additional costs for the graveyard wall not covered by the grant, tree pollarding in Church Wood, temporary repairs to the roof over the north porch, architect fees and a new kitchen boiler (half of which was paid for by the Bridge project).

VICAR'S REPORT

Paul began his report by saying that the past year had been a difficult one for him personally. He had a fall in July and had been stressed by the situation regarding his daughter's pregnancy and the birth of her twins, one of which has Spina Bifida. He said that, as he approached his 65th birthday he is more and more aware that he can't run around as much as he used to when he arrived in Birstall twenty years ago.

Nevertheless, the cycle of events and seasonal services have kept going. He reminded the meeting that the week after last's year's AGM we had been involved in the celebrations as the *Tour de Yorkshire* passed through Birstall. In June we hosted the *Great Get Together* for our community. In September the Archdeacon had come to help celebrate his 20th anniversary in Birstall, and in early October we had joined in with the dementia charity concert at the Princess Ballroom.

He was delighted to report that an excellent new thing begun this year: Deeper - the bimonthly informal evening Praise and Worship Service led by Chris Taylor.

Sadly, our congregation lost Marjorie Langley and Allan Gill who died.

He expressed his gratitude for those who support his, particularly his wife, Annette; the churchwardens, Miles and Denise; the readers, Leif and Wendy; and all the Pastoral Ministers; and also to all the church members who fulfil a wide variety of ministry roles. It was, he said, their love, encouragement and support that keep him going.

In looking forward to another year, Paul said it would be one which would be challenging in many ways, not least of all financially, as the leadership and congregation sought to push forward with ministry, mission and maintenance which, without God's presence would be impossible and pointless.

Finally he asked for God's blessing on the people of the church, and through them, on the Birstall community.

CHURCHWARDENS' REPORT 2017/18

FABRIC

1 Fire Extinguishers have been serviced. The compressor unit in the main boiler has been replaced.

2 Dead leaves removed for paths and drains. Also the Upper gutters were cleared and some small saplings removed.

3 Heaters in the Fellowship Area have been cleaned and repaired by Fred Lister.

4 Weeds poisoned on paths around church and manually cleared by the steps on Kirkgate.

5 A PAT test meter has been purchased and all electrical items have been PAT tested by Fred Lister.

6 Faculty received: - for Window in Vestry for conservation repairs. Funding offer received for £5000 balance has been applied for via the Hon Glaziers Trust and in case of that not happening a further application to the All Churches Trust is being made.

7 Temporary repairs have been made to the roof where lead had previously been removed. This was because damage to the parapet walls and replacement flashing materials had failed. Water had seeped behind and was causing the underlying boards to deteriorate.

On going works

a The reordering of the West End to include- new kitchen, new entrance and two new toilets .One being easy access for disabled. Now looking into funding opportunities.

- b Plans have been drawn for Access for All into church.
- c The rebuilding of the boundary wall with Longbottom wall is on hold.
- d New carpet has been laid down in the ringing chamber.

DEANERY SYNOD

There have been three Deanery Synod meetings during the last twelve months. All of them where held jointly with the Dewsbury Deanery. The June meeting was held at St Saviour's Brownhill. Liz Morton, a member of the Diocesan Children, Young People and Families Team, spoke about the need for inclusion and that all churches should aim to build a culture of intergenerational relationships.

The October meeting was held at Thornhill Parish Church. The speaker was Richard Noakes, the Director of the Diocesan Board of Education. He spoke about the wonderful work that is being done by the 242 church schools in the Diocese where some 65,000 children are taught to the best standard and engaged in acts of worship. 'The challenge,' he said, 'is for parishes and schools to work together to deliver life in all its fullness.'

The February meeting was held in our own church when we welcomed Bishop Nick Baines. He spoke passionately about the diocese and its challenges, after which he responded to questions concerning mission, ministry, money and minors with supplementary questions from the floor. He emphasized the importance of encouraging and empowering the laity. At the end of the meeting our vicar, Paul, announced that he would be resigning as Rural Dean as of June 1st.

SAFEGUARDING - CHILDREN AND VULENERABLE ADULTS
