The Trustees of Plymouth Vineyard ("PVC") who also act as Directors of PVC for the purposes of the Companies Act 2006, present their annual report together with the financial statements of the charitable company for the year ended 34 December 2017.

The Board of Trustees are satisfied with the performance of the charity during the year and consider that the charity is in a strong position to continue its activities during the coming year, and that the charity's assets are adequate to fulfillits obligations.

#### OBJECTIVES AND ACTIVITIES...

As stated in its statutes, (Memorandum and Articles of Association) Plymouth Vineyard is established for:

- I. the furtherance of religious or secular public education;
- II. the advancement of the Christian faith including missionary activities in the United Kingdom and overseas and also including but not limited to the planting of new churches and organisations of congregations;
- III. the relief of the poor and needy;
- IV: the relief offithe sick and elderly;
- Vi. such other charitable objects and for the benefit of such other charitable bodies and institutions as the Committee shall in their absolute discretion see fit...

As can be seen from the overview and developments of the church during the past year, Plymouth Vineyard continues to fulfil its objectives as outlined in its purpose and mission statements and its.

Anticles of Association.

The Trustees have reviewed the activities of the charity in the light of the guidance published by the Charity Commission on public benefit. The Trustees are satisfied that the charity's activities during the past year continue to be for the public benefit, relating as they do to benefit the community in the City of Plymouth and beyond.

#### ACHIEVEMENTS AND PERFORMANCE

## Growth and Leadership Development

The overall leadership and vision setting of the church is in the hands of the Lead Pastors. In 2017 the pattern of meetings which brought together key team members was established and developed. It gave greater pastoral oversight and accountability whilst maintaining the leadership input of these key people which is so vital.

A distinction is made between key ministry leaders, the operations team which works midweek (a largely, voluntary body) and Housegroup leaders. Once a term all these leaders were gathered together along with any others who led in a nonspecific capacity or were leaders in training. These times have been important for consolidating and communicating vision, encouraging the leaders and providing teaching input.

The gradual growth seem over the last few years continued and even accelerated im 2017, particularly with the move to a more central venue for Sunday mornings. A feeling of increased momentum and enthusiasm was noted.

Housegroups, pastoral structures and community

The housegroups are seen as the vital structure for pastoral care to the church community, and the vehicle by which it is delivered. Training was given on how to develop these groups and better care for the people in them, realizing that people's personal and emotional health was an important value for us as a church.

Childrem's Storehouse

Children's Storehouse has continued to be a successful ministry to young families and children, with a good reputation amongst the many local professional agencies that refer families in crisis need to this project. The charity was successful once again in obtaining a grant from BBC Children in Need and Devon Community Foundation, and over the year, we provided clothing, bedding, beds, equipment and other items to meet the basic living needs of just over 500 disadvantaged young children. An average of 15 families per week also came to the drop-in sessions just to chat and hang out over a cuppa and cake, with play and craft activities for the children. This is encouraging families to feel part of a community and helps to reduce the isolation that many of them experience, as well as strengthening relationships and improving children's development. The Christmas party was held at a new venue and it made a big difference—our thanks go to Plymouth Argyle Football Club for the use of their venue.

Children's and Youth Ministry

Children and youth remain a vital priority in the church—not only are they the emerging generation and important to our future, they also face significant challenges in the present, and the church wants to help them face these challenges—of culture, mental and emotional well-being and their development into stable, secure adults.

We took groups to a number of events beyond the city, including Spree (a weekend camp for 7-12s), Soull Survivor (a youth camping conference) and Go Wild' (an outdoor activities weekend). The numbers of children on a Sunday morning has necessitated reorganising the way that groups are split, and lunder a new children's church leader this is a work in process.

We lost our paid youth leader in 2017 which has provided both a challenge and an opportunity. The youth Housegroup has been led by the young people themselves which has been a great learning experience for them. The youth section of the church as a whole has been under an interim leadership whilst we give time for long term youth leaders to emerge.

A presence in the City and beyond

The Lead Pastor is the Chaptain for Plymouth Argyle FC and both Lead Pastors are active in city-wide events and training opportunities. They are also leaders of the South West Area for Vineyard Churches, and oversee the Vineyard churches for that area.

It is an aim for the church that all members sees themselves as instrumental in bringing blessing and life to the City and the communities in which they live and work, whether it be through practical help, prayer or just their active presence.

#### FINANCIAL REVIEW

During the year ended 31 December 2017, the charity received total income of £89,636 and incurred total expenditure of £93,906, so there was a deficit of income over expenditure for the year of £4,270.

Most of the charity's income is obtained from church members donations, and is used for the general running costs of the church.

The charity is extremely grateful to have been awarded grants during the year as restricted income towards the running costs of Children's Storehouse - £10,000 from BBC Children's Need and £2,000 from the Devon Community Foundation Plymouth Drake Fund. From these grants, a total of £1,833 is defierred income, as it relates to expenditure to be incurred in 2018. An additional grant of £3,300 was received from Vineyard Churches UK, to cover both the expenses for the Lead Pastors as Area Leaders and for events and training to benefit Vineyard Churches in the South West and Walles, of which £204 was carried forward to 2017.

The charity supported local missions through regular giving to Pregnancy Crisis Care and Fusion, and made one-off gifts to two other Plymouth charities - Shekinali Mission which provides services from homeless people and The Zone which provides services for young people. The charity also supported severallmissionaries working abroad, including Love the One, and continued to make a regular donation of 5% of its unrestricted income to Vineyard Churches UK.

#### Reserves Policy

At the end of 2017, the chamity had total reserves of £11,009 with restricted reserves of £4,824. The Trustees consider that the ideal level of unrestricted reserves would be equivalent to 3 months expenditure. With unrestricted reserves totalling £6,185 this is therefore lower than needed, so the Trustees will continue working towards building up the level of reserves with on-going careful management of expenditure.

#### Going Concern

The Trustees have reviewed the circumstances of the charity and consider that adequate resources continue to be available to fund the activities of the charity for the foreseeable future. The Trustees are of the view that the charity is a going concern.

#### Investment Policy and Performance

The charity operates a low-risk and ethical approach to the investment of reserves, which are held in an interest-bearing cash deposit account with the Co-operative Bank.

#### STRUCTURE, GOVERNANCE AND MANAGEMENT

#### Governing Document

Phymouth Vineyand is a charitable company limited by guarantee, governed by its Memorandum and Articles of Association dated 23 October 2003, and is affiliated to the Association of Vineyard Churches UK and Ireland (VCUKI). It has been registered as a charity with the Charity Commission since 29 March 2004:

#### Method of Recruitment and Appointment of Trustees

The Chair of the Board of Trustees, who is also the Lead Pastor of Plymouth Vineyard, initiates the recruitment of new Trustees from members of the church who are then approved by the Board. A minimum of 3 Trustees is required by the Memorandum and Articles. Trustees normally serve for an initial period of 3 years, and may serve for a further period if they are agreeable and are invited to do so. As the church has grown, the charity has recognised the need both to hold on to experienced Trustees and to appoint new Trustees who are able to offer relevant skills and experience, to ensure that the Board can contribute fully to the charity's development. When new Trustees are appointed, they are required to study the Trustees Manual published by VCUKI and are given ongoing training by the Lead Pastor, as well as accessing training offered

When new Trustees are appointed; they are required to study the Trustees Manual published by VCUKI and are given ongoing training by the Lead Pastor, as well as accessing training offered nationally by Vineyard Churches at their annual National Leadership Conference. The Trustees can also attend training events run by the Area as well as other organisations.

#### Organisational Structure and Decision Making

- 11. The Board of Trustees normally meets 5 times a year and monitors the overall governance of the charity. The Trustees are responsible for setting and reviewing policies, approving the statutory accounts and budgets, monitoring charity performance by the use of financial data, and making decisions about expenditure and staff appointments and salaries. The Trustees also give advice and counsel to the Lead Pastors in relation to the financial, legal and administrative life of the church.
- 2. The two Lead#Pastors are responsible for the oversight, direction and vision of the church. Decisions are made in consultation with the different staff and leaders operating in their various functions, and with the support of all the church's leaders. They receive oversight in their role externally through the oversight system arranged by VCUKI.
- 3. Ministry, Leaders and Coordinators head up specific areas of the church and lead the teams who report to thermas volunteers for that ministry.
- 4. Housegroup lieaders oversee small groups, set up by the church to encourage people to look after each other. Housegroups are organised into clusters and the housegroup leaders from each cluster meet regularly together to support each other, with their development and coaching being the responsibility of the Lead Pastors.

#### Risk Management

Plymouth Vineyard has undertaken a full risk analysis for all its activities. This policy is under constant review and updated as necessary. The church is fully insured against public liability. Staff contracts are reviewed annually along with the job descriptions and appraisals. All staff, trustees and volunteers involved with children and young people are DBS checked and receive safeguarding training, which is updated every three years. Our latest training was completed in April. Our Safeguarding Policy is reviewed annually and one of the Trustees is responsible for safeguarding. There also is a Health and Safety Policy in place for public meetings and activities.

#### Related Parties

Plymouth Vineyard is a Christian Church. It is affiliated to the Association of Vineyard Churches, UK & Ireland (VCUKI) from whom it receives pastoral oversight and training. More locally it is part of the South West Area of VCUKI. It is also a member of 'Churches Together in Plymouth' - an ecumenical group...

#### PLANS FOR FUTTURE PERIODS

**Leadership Development and Pastoral Structures** 

Our focus last year was the emotional and spiritual health of the body, and discipleship. This will continue because it is so important, and we see that with the recent growth and congregation turmover there is a need to develop community through the opportunities provided for relationship found in social events and activities. We very much want to pursue these opportunities to the small group communities previously called Housegroups, but now to be called Life Groups. Life Groups are our pastorall units in the church, and the development of these groups and the

people that lead them are a priority.

Continued investment in our young people is essential - we have appointed new youth leaders for the year and we hope that they will work with the children's pastor to both disciple our young people and provide excellent children's church for everybody on a Sunday morning...

Local mission

The church will continue to engage all the members in providing food and services to those in poverty, and will encourage people to engage in serving the City's needs wherever they feel led! We will work alongside existing charities and organisations wherever appropriate to maximise

This year we will seek to devise a plan for the future development of our compassion ministry, which will include increasing our storetiox ministry and looking for other opportunities to bring a blessing to the City of Plymouth.

Children's Storehouse

The chapity has applied to BBC Children in Need for another three years funding, as well as to several other Trusts and Foundations, which if successful, will enable existing provision to continue and develop the project even further. The planned review of local mission will include the Children's Storehouse provision, and how best to develop its future.

Floreign: Mission

Our support of foreign missions has been consistently maintained over the years, but 2018 is the year to decide which project to invest in further, strengthening relationships, sending teams out and giving an increased prayer focus. Our choice will be from within the Vineyard church family because we see most chance of an effective and long-term commitment here...

Premises:

Our city, centre. Sunday, premises has been a great success and we are already, beginning to fill the venue. We will continue to look for a venue that will help us expand our midweek provision as well as host Sunday services.

They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

#### NOTES TO THE ACCOUNTS

#### 1 Basis of Accounting

These accounts have been prepared under the historical cost convention, with inters recognised at cost on transaction value unless otherwise stated in the relevant notes to these accounts. The accounts have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and with the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and Charities Act 2011.

Plymouth Vineyard constitutes a public benefit entity, as defined by FRS 102.

#### 2 Accounting Policies

#### Fund Accounting:

Unrestricted funds are donations and other incoming resources which are available to be used in accordance with the charitable objectives at the discretion of the Trustees.

Restricted funds are funds which are to be used within the objects of the charity, in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular restricted purposes.

#### Income.

All income is included in the Statement of Financial Activities when the charity becomes entitled to the resources, it is probable that the income will be received and the amount of income can be measured reliably.

Gift Aid receivable is includedlimincome when there is a valid declaration from the donor. Any Gift Aid amount recovered on a donation is considered to be part of that gift and is treated as an addition to the same fund as the initial donation. The tax reclaimable on Gift Aided donations is accrued for if not received by the end of the financial year.

Interest on funds, held on deposit is included in the accounts when receipt is probable and the amount receivable can be measured reliably.

#### Expendituse and Liabilities

Expenditure is recognised once there is a legal or constructive obligation committing the charity to pay out resources and the amount of the obligation can be measured reliably. Expenditure is classified under the headings that aggregate all costs related to that activity. Expenditure includes attributable VAT which cannot be recovered, since the charity is not registered for VAT.

Liabilities are measured on recognition at their historical cost and themsubsequently measured at the best estimate of the amounts required to settle the obligation at the reporting date:

#### Assets

Debtors are measured on initial recognition at settlement amount.

Tangible fixed assets are capitalised if they can be used for more than one year and cost at least £500. They are valued at cost. Depreciation is calculated on the straight-line basis, incorder to write off the cost of each asset over its estimated useful life, as follows:

Equipment - over 3 years: Fixtures and Fittings - over 5 years

#### Gifts

Decisions concerning which individuals and institutions receive gifts out of the assets of the charity are made by the Leadership Team in consultation with the Board of Directors, in accordance with the Memorandum and Articles of Association.
