Background

The PCC of the Parish of S. Augustine w S. John, Kilburn, co-operating with the Incumbent, has the responsibility of promoting the Gospel of Jesus Christ and the mission of the Church within the parish and more widely. The Church of England has been described as the one institution that exists for the benefit of those outside.

Due to the established nature of the Church, everyone within the geographical boundaries of the parish can look to S. Augustine's as 'their' parish church.

Practically, the Incumbent and the PCC have responsibility for maintaining the Church plant and the Assistant Curate's flat.

The Parish Church

Since it was opened in 1875 and consecrated in 1880 the Parish of S. Augustine, Kilburn has held full catholic privileges. The Church was built during the resurgence of the Anglo-Catholic movement. Having passed Resolutions A, B & C under the Priests (Ordination of Women) measure 1993 and passed the new Resolution in September 2015 under the House of Bishops' Declaration; in accordance with 'The London Plan' the parish is under the care of the Bishop of Fulham.

The Life of the Parish 2017

The parish continued in 2017 to offer a daily mass with additional devotional services of Stations of the Cross and Holy Rosary offered throughout Lent.

The Sacraments of Holy Baptism, Confirmation and Holy Matrimony and Confession were all celebrated.

The main focus remains worship on Sunday and provision of a Sunday School.

In February we celebrated the 104th birthday of Miss Peggie Faulkner.

A Parish Pilgrimage to the Shrine of Our Lady of Walsingham was conducted.

The Bishop of Fulham celebrated St. Augustine's Patronal Festival on Saturday 27th May 2017. A Summer Fayre was held followed by a St. Nicholas Christmas Fayre in aid of the Organ Fund as were the Advent pop up stalls.

Every Saturday we continue to welcome (as we have since September 2012) the Community Payback workers without whose work the parish ground maintenance and most cleaning would be lacking in support.

In November we bade farewell to Mr. David Wyatt who resigned as Director of Music after 26 years. In November Fr. Amos appointed Mr. Tom Stockwell as Acting Organist to Trinity Sunday 2018. The group formerly calling itself 'the choir' was disbanded to provide fresh opportunities for the development of a music ministry in the parish.

Fr. Amos undertook a sabbatical January – March 2017 and as a consequence the Parish for the first time supported St. Nicholas' Childrens' Hospice, Bloemfontein, South Africa at Harvest.

Safeguarding

Mrs. Hazel Adams was elected our Safeguarding Officer and Mr. Jozef Orzech was elected the Parish Children's Champion. Both are Parochial Church Councillors and both lead/assist with the Sunday School providing high profile and communication.

In line with diocesan policy, all those working with children and young people are required to hold an enhanced CRB / DBS disclosure. The new PCC reviewed and re- affirmed its commitment to the Safeguarding of Children and Vulnerable Adults. The PCC approved other members of the congregation to be appointed to positions for which DBS checks were required, obtained and recorded by the PCC before the appointments were made.

On average 1 person attended Evensong per week in 2017 who did not attend a Sunday mass. From November 2017 Evensong became Evening Prayer.

Maintained communication with Brent Council regarding the Durham & Gloucester Houses redevelopment, assisted by Mr. Martin Sargeant, Diocesan Director of Operations.

Received cabinets in which to appropriately store the St. Augustine's archive.

Received reports from the Foundation Governors regarding St. Augustine's Primary School.

Received reports from the Foundation Governors regarding St. Augustine's High School.

Entered into a Faculty Licence Agreement with Perfect Mobile Creche.

Obtained a Faculty for the restoration and completion of the organ.

Agreed a Common Fund Contribution of £58,500.00 for 2018

Oversaw the continued treatment to remove Japanese Knot Weed from the site.

Entered into contracts with location managers for filming and recording opportunities.

Report from Bell Tower

Bell ringing in 2017 took place every Sunday before the High Mass and on St Augustine's Day and Christmas Day. We welcomed three groups of visitors, rang three quarter peals with the local band and rang out the old year on New Year's Eve.

The regular practice on Monday evening has continued, with more ringing on six bells than eight, following the loss last year of four of our most experienced ringers. We were sorry to lose our American visitor in April, but in May were pleased to welcome an Australian ringer, who has become a regular member of the band. We have trained another new ringer this year, but, sadly, following a broken hip, Christine Stratford, who has been ringing with us since 1999, has had to give up ringing. In July we all very much enjoyed a ringing outing in South London, arranged by the two of our former ringers who now live there.

All our ringers are members of the Middlesex County Association and London Diocesan Guild of Church Bell Ringers and support the activities of the Association.

Report from Sunday School

The Sunday School teachers are Hazel Adams, Tatika Wyre, Lyne Khabbaz and Laura Collignon. Other parents also assist e.g. with taking the register. There is a worksheet with pictures and puzzles based on the week's Bible readings which the children use when they arrive. Copies of the worksheet for the week are also available at the back of church for any children who are remaining in church throughout the Mass. We have craft and art activities based on the week's readings. We also sometimes have games and songs. We have a Bible reading from the week's readings and a discussion with the children about it. The reading, discussion and activities are usually based on the gospel for the week. When the weather is good enough Sunday School takes place in the garden.

Before we come back into church we have prayers where we encourage the children to say thank you for good things that have happened, to pray for the sick and those in difficulty, and to pray for the week ahead.

Ages range from 0 up to around 11 and we also sometimes have older children. Although there are toys for the babies and younger children they are encouraged to participate in the Sunday School activities as much as possible. All children and parents in Sunday School are encouraged to join in the prayers.

The children are sometimes asked to come up at the end of Mass to talk to the rest of the congregation about what they have been learning and to show them what they have made.

Sunday School ran for 52 weeks of the year in 2017. We had a total of 501 attendances of children and 256 attendances of adults, so on average ten children and five adults per week.

Financial Review for 2017

General Account

On the income side, direct giving via Stewardship, Collection Plate, and Other Office (OO) collections (weddings and funerals), together with Gift Aid (GA) and a small investment income showed an overall fall of 1.4% compared to 2016.

Stewardship increased by 10%, but loose cash collections were less than half the amount of 2016. As a consequence, the increase of GA is only due to the fact that the amount for 2016 had been reduced by an accounting regularisation. Both these income sources are within the Parish control and management and continue to benefit from close scrutiny by the Stewardship recorder and others involved in the financial oversight. OO collections for services such as weddings and funerals are by their nature outside the control of the parish and we depend on the generosity of those attending.

Direct giving represented a little more than 62% of the General Account Expenditure.

Although the church was more successful with lettings than expected, thanks to delays in the start of the South Kilburn demolition works, the income raised was only half of what it was in 2016.

Altogether, the church ended the year with a deficit of the general account amounting to more than £4000. While this amount should be mitigated by the prospect of income to reach us early in 2018, this situation is a cause for concern. To put it bluntly, the parish is not covering its running costs.

Now that South Kilburn development as reached its active stage, our potential income stream is soon to dry up and we need to plan other ways to make up for the shortfall this will cause.

Fabric Account

2017 was the year when no money was spent from the Fabric Account, as all payment towards the Heating Project had been completed in December 2016.

Donations have kept coming, and the two Fairs and other events have produced some income towards the Banners Fund and the Organ Fund. It should be noted that the restoration of the Organ is expected to cost the best part of £450,000, which means that we will have to find ways of raising substantial amounts of money before any work can begin.

The bigger picture

The very nature of the Fabric Account means that all money within it is 'restricted'. Church accounting principles do not allow for such funds to be taken to cover any deficit in the General Account. Therefore, our present deficit makes our need for careful stewardship more pressing than ever.

I would like to invite all parishioners to take this concern to heart in a prayerful way. In this as in so many other matters, I pray that we will all gather around our Parish Priest as our focus for unity in mission, and support and supplement his sustained efforts in ensuring that our Parish has a sustainable future.
