## Ealing Soup Kitchen Trustees Review Year ended 31st December 2017

Ealing Soup Kitchen has had another successful year providing nourishing food and a helping hand to those who need it, around Ealing and beyond.





Our main services are the weekend soup kitchens held at St John's Church, Mattock Lane, Ealing, and the drop-in hubs on Friday afternoon (also at St John's) and Monday evening at the Salvation Army centre in West Ealing. This year we have also been increasing the number of outreach evenings we've undertaken, distributing sleeping bags and other essential items to individuals sleeping rough

With all the changes going on in the world this year, it's been somewhat surprising that ESK has seen little fluctuation in demand for our services, which remains very high. Arguably, that's a bad thing, we would like to see the number of people in need decreasing. On the other hand, it gives us confidence in the range and type of services we provide. We constantly look for ways to add services that are not being offered by other groups in the area, such as haircuts, showers, and specific clothing items.





Our Worker with Homeless People, Andrew Macleay, continues to build his profile, including some excellent media presence, as a key go-to person for anyone needing help. The volunteer team he has built for the Monday Hub are highly reliable, coming back each week without fail. The six weekend volunteer teams also remain solid, and efforts continue to grow this to seven or eight teams, in order to decrease rotation frequency and alleviate team attrition.

Our fundraising efforts remain in place, and donations are always welcome. We thank the many local churches who support us, along with generous individuals and local companies, in particular British Land and Ealing Broadway Centre, who have made ESK one of their four named charities, and the Sandhu Foundation. Local politicians also pitch in and their continued support is appreciated.

Donations have made it possible this year for us to fund construction of showers at St John's, which are primarily used by our customers. This allows us to be one of few places in the Borough where homeless people are welcome to come and wash themselves.

We look forward to continuing to help as best we can in 2018.

## Ealing Soup Kitchen Independent Examiners Report Year ended 31st December 2017

### Independent examiner's report to the trustees of Ealing Soup Kitchen

I report on the accounts of the Trust for the year ended 31st December 2017, which are set out on pages 1 to 6.

## Ealing Soup Kitchen Notes to the Financial Statements Year ended 31st December 2017

### **1 Accounting Policies**

The principal accounting policies adopted, judgements and key sources of estimation uncertainty in the preparation of the financial statements are as follows:

### **Basis of preparation**

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)) as amended by Update Bulletin 1, the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Charities Act 2011 and UK Generally Accepted Practice as it applies from 1 January 2015. The accounts (financial statements) have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair view'. This departure has involved following Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn. Ealing Soup Kitchen meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note(s).

Reconciliation with previous Generally Accepted Accounting Practice and date of transition In preparing the accounts, the trustees have considered whether in applying the accounting policies required by FRS 102 and the Charities SORP FRS 102 the restatement of comparative items was required. There has been no necessity to restate the comparitives. The transition date to FRS 102 was 1 January 2014.

### **Incoming Resources**

Incoming resources are included in the Statement of Financial Activities (SOFA) when:

1. the ESK receives the resources;

#### **Expenditure and Liabilities**

Liabilities are recognised as they are paid.

### 1b Funds accounting

Funds held by the ESK are:

Unrestricted funds - general funds which can be used for ESK ordinary purposes
Restricted funds - a) donations or grants received for a specific object. The funds may only
be expended on the specific object for which they were given. Any balance remaining
unspent at the end of the year is carried forward as a balance on that fund.

### Restricted funds

Included in the reserves is an amount of £7,979.00 (£10,996.76 2016) specifically raised for the "Worker with Homeless People" only.
