Trustees report for the year ended 31st March 2018

The trustees presents its annual report and the unaudited financial statements for the year.

Review of the current year

The trustees are pleased to report that the church continues to be successful spiritually by ministering to many people in the different location. The church has improved in membership strength and is increasingly reaching out to the community. The church would like to expand further and grow the church beyond its current membership to be able to reach out to more members of the Community and among others, thus fulfilling its mandate of "Taking the Healing Power to the Nations of the World".

The overall financial position reflects the fact that the Charity maintains its standing as we move to the new location in Kingswood Community. The trustee strives to maintain financial stability by reaching out to more people and training future leaders. In addition to our regular weekly activities such as Sunday Worship Services, mid-week teaching services, choir practice, women/men and youth meetings, Sunday school for the children; the charity carried out different departmental training/ teaching seminars/workshop, naming and dedication of newborn to members, conferences and family meetings.

As part of our desire to fulfil our Vision of "Taking the Healing Power to the Nations of the World". The church has been able to involve in charitable community support in Bristol, where we made provisions for the homeless and the poor during our Christmas operation feed the poor programme. We were able to provide food, blankets, clothes and groceries for the homeless. We were glad to make them happy and put a smile on their faces during the Christmas season. We want to use his opportunity to thank the entire members of the church for their contributions towards the success of this project.

St. Paul New Covenant Church strongly relies on volunteers for its work in meeting the needs of its members and the public. The trustees would like to take this opportunity to thank our staffs, core leadership team members, heads of departments, our 14 Volunteers and members of the various divisions in the church for their valuable contribution in keeping the church operational in this financial year.

In this financial year, the mission arm of the church went to Malawi for charity work. We have two Volunteers who went to Malawi. The mission was from 24-30 October 2017. We visited three orphanages in Blantyre, and we organise operation feed the poor in Palombe village in Malawi. The church was able to provide school uniforms, Jumpers, shoes and feeding program for 150 orphans. The trustee was delighted for this great success and achievement in fulfilling the mission statement of the church.

Moreover, the church was able to establish music School (Praise 360 Music School) where children in the community who are interested in singing and instruments were trained how to play various musical instruments such as drum sets, keyboard, trumpets, bass guitar. The music School also do voice and vocal training for children who are interested in singing. We are glad to see the school helping the children in our community to develop their talents. This is our little way of giving back to the community.

Future Plans

In the coming year, there will be more training programme for the youths, the pastors, and various departments of the church. This development will enhance the fulfilment of the vision of the church. We are also working hard to purchase a 14-seater bus for the church to help individuals that have transport challenges to come to our worship services. The trustees are also working to see that two more branches of the church are open within the city of Bristol, to move the worship centre closer to those who come from far places. Also, we are planning to do charity work in Uganda which is one of the less privileged countries in East Africa from the 24th October to 30th October 2018. The church will support two Orphanages with clothes, shoes, school materials and feeding programme.

We also trusting God that the charity will continue to grow numerically and spiritually, and we will be able to do more charitable work in our local community and the rest of the world as we fulfil the mandate and the vision of God for our church (Take the healing power of God to the nations of the world.) Finally, the church intends to continue to work with other organisation within and outside Bristol to improve the lives of people across age, gender, nationalities and social, economic group. In the coming year, we hope to continue to provide sound Ministerial Training for both members and the public.

We also believe that this report provides evidence of the public benefit of the charity's work in the year ended 31st March 2018.
