Dear Members

A very warm welcome to our 2017 AGM. I am delighted to be addressing you as Chair of the Coventry Irish Society. This is especially so as I am also the Chair of the Cork Association in the 60th anniversary of the twinning between Coventry and Cork. As part of that celebration I am delighted to hear that our history exhibition 'Irish Heart, Coventry Home' will be showcased in Cork City in September 2018.

The past 15 months since our 2016 AGM have been very eventful. The Society has achieved a lot and also coped well with a variety of challenges including having to move premises at short notice.

We are proud as a Society to have helped many vulnerable Irish receive some necessary entitlements. As always this is the main emphasis of our work. More than 100 people have received in-depth support to access welfare, pensions, housing or disability benefits since our last AGM. Further welfare related projects included a mental health support group and individual counselling.

Our 'Shamrock Group' for those living with memory loss has also been very successful with a total of 16 people including Carers that have received support.

Also our network of social and befriending support continues to combat social isolation and also celebrates our culture that we are all proud of.

We are also proud to have provided support to Irish Survivors in the midlands on a voluntary basis. Recently we were delighted to receive news of a small grant to support the Survivors Lunch Clubs from the Ireland Fund of Great Britain. The Society fights to ensure that Irish Survivors get the proper support and receive their entitlement of £12,000 from 'Caranua' the Statutory Fund.

A huge highlight for the Society this year was our oral history project 'Irish Heart, Coventry Home' where we documented the contribution of the Irish community to Coventry. The exhibition at the Herbert Art Gallery and Museum averaged an attendance of 220 visitors per-day.

We are as ever extremely grateful to the Emigrant Support Programme for supporting the work of the Society. We were delighted to have visits from Rosie Keane, Alannah Maxwell and Ruaihi Dowling from the Irish Embassy this year. I would like to thank all our members and volunteers for their great contribution to the Society. Also to thank my fellow Trustees and the CIS staff team for their hard work and support.

We hope the next 12 months will be a prosperous one for everyone and that the Society will receive new revenue. I urge the Irish community in Coventry to support the work of the Coventry Irish Society.

Managers Report 2017



It has been a very busy year with our usual high input into providing health and welfare services to the Irish community. The Society maintains a high level of services to the vulnerable Irish and as always this is our main priority.

However we also provide a wide range of general advice and befriending support as well as cultural events such as the Saint Patrick's Festival.

Our Shamrock Club providing support to those living with memory loss goes from strength to strength.

The increase in Irish Passport applications since Brexit has remained steady and a high number of Second and Third Generation Irish are applying for Citizenship. We would like the Second and Third Generation Irish to join and support the Society.

Our befriending and social support groups and networks continue to be popular and we receive regular attendances of anywhere between 70 –120 to our lunch clubs, 50 people attend the Claddagh Group that meets at Flannellys every Tuesday as well as a variety of members and friends that drop in for a one to one chat and a cup of tea.

Our Heritage Project 'Irish Heart, Coventry Home' was a huge success with 700 people attending the launch event. The exhibition was on from March 9th to April 10th 2018 where an average of 220 visitors per-day visited the exhibition. This project has put the Irish in Coventry "On the map" and it is both a celebration and a lasting legacy for future generations.

The Society still supports Irish Survivors and holds up to 6 lunch clubs per-year in Birmingham and monthly outreach sessions that are conducted on a voluntary basis. This project has recently received a grant from the 'Ireland Fund of Great Britain' which is wonderful news for the Survivors.

We continue to receive excellent and much needed support from Coventry University. Special thanks to Dexter du Boulay, Simon Horsman and Mark Holmes for their fantastic contributions to the Society. Also thanks to Geraldine Hammersley and Cathy Hunt for their excellent work on our Heritage project.

We are as always extremely grateful to our main funders the 'Emigrant Support Programme' for enabling us to continue our important work.

We also need to thank the Heritage Lottery Fund, Cork City Council, Coventry City Council, The Deeley Group and the City of Culture team. I would like to thank all our friends, members and volunteers for their support. Also the Trustee group and staff team for their hard work and commitment to the project.

A special mention to our Honorary President David Cairns who continues to help the Society.

Win McGlynn Welfare Project



The Welfare project covers an large amount of ground with regard to helping Irish people. We provide advice, support and guidance with the whole range of welfare benefits, pensions, housing applications and related issues, debt, utilities bills, U.K. and Irish state pensions. In addition people request help with returning to Ireland and applications for birth certificates.

Irish Passports have continued to remain high on the agenda since 'Brexit'. Many Second and Third Generation are applying for their passports.

The Society continues to enable many Irish people and importantly many vulnerable Irish to access entitlements and services that they may not otherwise avail of. By providing a culturally sensitive and aware service our clients are comfortable enough to approach us for help and support. The Society often liaises with other services such as health, housing and social services to ensure the needs of our people are being met. I also help out with our 'Shamrock Club' which is a lovely group for people living with memory loss. We do activities and have a good chat the people really enjoy it.

Health Workers Report

The CIS Health worker role is shared by Dawn and Ann. We continue to offer support and advice on a wide variety of Health and Welfare issues. These include various benefit claims e.g. Housing council tax, (We have had more clients coming in for support mainly due to the changes and how they need to apply for these on line, this being very difficult for clients with literacy and technology fears) Disability Living Allowance(DLA) Attendance Allowance, Carers Allowance, Community Support grants. Due to recent changes in the benefit system we have had a large number of claims/enquiries/appeals to deal with mainly Personal Independence Payment (PIP) and Employment Support Allowance (ESA) as the boundaries have changed considerably and clients with literacy and technology problems finding it very difficult to access forms to apply for the benefit they are entitled to.

Then came “BREXIT” and this was like a tornado hitting with at least 8-10 people queuing outside every day to collect application forms for Irish passports. In the first 3 months we must have given out approximately 500 passport applications along with information about Foreign Birth Registration for other members of their extended families. This has continued up to the present, and we are still experiencing a high number of people applying for passports.

2016 saw the start of our Dementia Care Group and this has been a real success. We have had 5/6 regular attenders each week who always enjoy their time with us. Unfortunately we had the upset of finding new offices earlier this year, and this meant losing the room used for our dementia group, however Father Tom at Christ The King Church offered us a room, and we have been able to carry on offering this service. Our group is growing but we still have spaces for more referrals please contact Ann or Dawn if you know anyone who will benefit from this group.

Our Carers group used to meet on the first Thursday of each month in our previous offices but unfortunately we haven't been able to restart this group due to lack of suitable space.

The Claddagh Group continues to provide social interaction for between 40-50 people each week. We have had a very busy year with several meals and entertainment days, visits to the seaside and other groups in Leicester and Corby. We also organise a holiday to Ireland each year, and this continues to be very popular.

Although we are still working with a reduced budget, we are still able to offer services as stated to an increasing number of clients both face to face and via the telephone.

Report of the Trustees

The Trustees who are also Directors of the Charity for the purposes of the Companies Act submit their Report together with the reviewed Financial Statements of the Charity for the year ended 31st December 2017. The Trustees have adopted the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" issued in March 2005 in preparing the Annual Report and Financial Statements.

The Charity is a Charitable Company Limited by Guarantee and was set up on 1st October 2012 and commenced to trade on 1st January 2013. It is governed by a Memorandum and Articles of Association.

Objectives

The Charity's objectives are:

- to promote the benefit of the inhabitants of Coventry and surrounding areas with particular reference to those who are Irish or of Irish descent;
- to relieve sickness and old age, preserve and protect good health and advance education and training;
- to address issues of deprivation, social exclusion and isolation related to poor health and old age, preserve and protect good mental and physical health and spiritual well-being;

- to promote culturally appropriate housing, health and social welfare services and recreational and other leisure time occupations with the object of improving the quality for the said inhabitants.

Risks management

The Trustees conduct their own review of major risks to which the Charity is exposed, these procedures are periodically reviewed to ensure that they still meet the needs of the Charity and are as follows:

- an annual review of the risks which the Charity may face;
- the establishment of systems and procedures to mitigate those risks identified;
- the implementation of procedures designed to minimise any potential impact on the Charity should any of the risks materialise.

Financial Review and Reserves Policy

The company's "results" and position at 31st December 2017 are set out in the accounts on pages 7 to 12. There were negative Unrestricted reserves at 31st December 2017, and the trustees are seeking to address this and establish an appropriate reserves policy.

Trustees' Responsibilities Statement

The Trustees (who are also Directors of Coventry Irish Society for the purposes of company law) are responsible for preparing the Trustees' Annual Report and the Financial Statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the Charitable Company and of the incoming resources and application of resources, including the income and expenditure, of the Charitable Company for that period. In preparing these financial statements, the Trustees are required to:

- select suitable accounting policies and apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Charity will continue in operation.

The Trustees are responsible for keeping adequate accounting records that disclose with reasonable accuracy at any time the financial position of the Charitable Company and enable them to ensure that the financial statements comply with the Companies Act 2006. The Trustees are also responsible for safeguarding the assets of the Charitable Company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

In so far as the Trustees are aware:

- there is no relevant Audit information of which the Charitable Company's Auditor is unaware; and
- the Trustees have taken all the steps that they ought to have taken to make themselves aware of any relevant Audit information and to establish that the Auditor is aware of that information.

Independent Accountant's Report to the Members of Coventry Irish Society

We have both prepared and, there being two accountants involved, reviewed the financial statements of the Coventry Irish Society (CIS). The circumstances whereby this has come about are discussed in Section 4 of this report. The financial reporting framework that has been applied in their preparation is applicable law and Financial Reporting Standard for Smaller Entities (effective April 2008) (United Kingdom Generally Accepted Accounting Practice applicable to Smaller Entities).

This report is made wholly to the CIS members, as a body, in accordance with Chapter 3 of Part 16 of the Companies Act 2006. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the charitable company and its members as a body for this report or the opinions we have formed.

Respective responsibilities of trustees and reporting accountants.

As explained more fully in the Trustees' Responsibility Statement, the trustees (who, for the purposes of company law, are also the directors of the charitable company) are responsible for the records from which these accounts have been prepared. Normally, they would also be responsible for preparing the accounts, leaving the independent accountants merely the task of reviewing the accounts, but this year that was not possible and the independent accountants have prepared the accounts and take responsibility for them showing a true and fair view, subject to the note below.

Scope of the accounts

The accounts concerned are in accordance with the underlying books and records of the organisation and have been verified with reference to external documents (e.g. bank statements) where this is feasible. Being acceptable to us, we have not changed any accounting policies from past years. We have not received a trustees report for the year and so have no comment to make.

Reservations regarding "a true and fair view" and "Going Concern".

The figures we inherited from the years to December 2013 and 2014 were both subject to audit qualifications. In these circumstances we are unable to satisfy ourselves as to the appropriateness of the comparative figures and in particular the analysis of restricted and unrestricted funds. This impacts on later figures, especially the analysis of the capital funds on 31st December 2015 (The first period for which we were acting as independent accountants) as at the earlier year ends. On the other hand readers may wish to note and take some comfort from the fact that funders have not responded to these qualified figures in such a way as to indicate that they were unhappy with the position revealed.


It is also necessary to state that in determining whether Coventry Irish Society ("CIS") is a going concern the accountants must be mindful that, like many charitable bodies, CIS's activities in both scale and direction are driven by the grants it is awarded. Changes in grants will impact CIS's future activities. This is not to say that CIS would not be able to continue but that its scope will always have to be adjusted to its resources.

Qualified Opinion on the financial statements.

In our opinion, except for the possible effects of the matters described in the Reservations regarding "a true and fair view" and "Going Concern" paragraphs, the financial statements:

- give a true and fair view of the charitable company's affairs at 31st December 2017

- have been properly prepared in accordance with UK generally accepted accounting Practice (applicable to smaller entities), and
- have been prepared in accordance with the requirements of the Companies Act 2006.

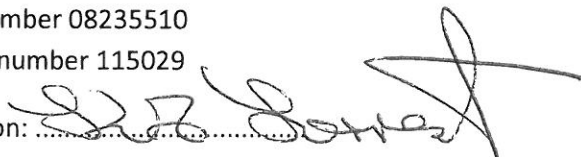

NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31ST DECEMBER 2017

1. Accounting policies

- (a) The financial statements have been prepared under the historical cost convention, in accordance with the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" published in the Charities Act in March 2005 and in accordance with the Financial Reporting Standards for Smaller Entities (effective April 2008).
- (b) The financial statements have been prepared on a going concern basis notwithstanding an overdrawn Unrestricted funds position at 31st December 2017. A reduction in funding from the principal funder reduced the Society's income significantly from mid-2014. The trustees have taken widespread and substantial remedial to rectify the situation, and are confident that a positive position has been restored. The 2017-18 grant awards from the principal funder, albeit at a lower level than pre-2014, have been confirmed at the date of approval of the financial statements. The trustees, being mindful of all relevant factors, consider the Going Concern basis to be appropriate.
- (c) Voluntary income is received by way of donations and gifts and is included in the full in the Statement of Financial Activities when receivable. The value of the services provided by volunteers has been included.
- (d) Grants, including grants for the purchase of fixed assets, are recognised in full in the Statement of Financial Activities for the year in which they are receivable.
- (e) Incoming resources from investments is included when receivable.
- (f) Resources expended are recognised in the period in which they are incurred. Resources expended include attributable VAT which cannot be recovered.
- (g) Resources expended are allocated to the particular activity where the cost relates directly to the activity.
- (h) Depreciation is provided at rates calculated to write off the cost of each asset over its expected useful life, which is estimated at five years for furniture, four years for office equipment and three years for computers.
- (i) Unrestricted funds are donations and other incoming resources receivable or generated for the objects of the charity without further specified purpose and are available as general funds.
- (j) Designated funds are unrestricted funds earmarked by the management committee for particular purposes.
- (k) Restricted funds are to be used for specific purposes as laid down by the donor. Expenditure which meets these criteria is charged to the fund, together with a fair allocation of management and support costs.
- (l) Rentals paid under operating leases are charged to the income and expenditure account on a straight line basis over the period of the lease.

2. Taxation

No liability to UK corporation tax arises for the year ended 31st December 2017 nor for the year to the 31st December 2016.
