REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 DECEMBER 2017

The trustees present their report and the financial statements of the charity for the year ended 31 December 2017.

OBJECTS OF THE CHARITY

The objects of the charity are to advance the Christian faith globally, encourage Christian mission activities through evangelism and humanitarian outreach, relieve the poor and needy, provide help and comfort to the sick, and to raise awareness of the needs of people worldwide.

The charity particularly seeks to provide assistance to people and places where it is difficult for western organisations to give such aid.

In pursuit of these objectives the trustees expend the charity's resources on:

- (a) grants given directly to projects that are being run overseas (grants to projects overseas).
- (b) touring the UK making people aware of needs overseas and distributing literature to regularly update people on needs and how these are being met (public education and issue awareness).
- (d) necessary administration incurred in the running of the charity. (Management and administration).

The charity operates a single unrestricted general fund which can be used for any purpose that meets the charity's objectives.

CONSTITUTION

The charity is a registered charity constituted by a trust deed dated 17th July 1975.

The charity is run by trustees who make additional or replacement appointments as they deem necessary.

The trustees meet regularly but have appointed a secretary to help them run the charity on a day to day basis utilizing volunteers and paid staff where necessary.

RELATED PARTIES

The charity is actively involved in joint projects overseas with the USA organisation and jointly produces the various mission outreaches globally.

Mr T Law and Mr J Law are members of the board of the US organisation as well as being trustees of this charity.

REVIEW OF THE YEAR AND FUTURE DEVELOPMENTS

The Trust's activities during the year have been in the countries of Myanmar, China, Iraq and Iran. We believe that our consistent work in these countries will help us to continue to build and develop successful outreach including training, discipleship, humanitarian efforts, church planting and distribution of Christian literature as well as humanitarian efforts.

Myanmar

During 2017 World Compassion continued to successfully operate the Children's Home with 23 children (capacity 48). The church and pastor in Twante oversee the operation of the facility and care of the children. We continued to train and disciple students and leaders using the ABC curriculum through local churches and pastors. This outreach will continue to expand in 2018 as funding permits. The Ministry Training Centre for mission students served 40 students for a nine month training session (August through April). The Charity continues to support church planting efforts in the country, we helped build a new Church building in Khamti, Myanmar for a thriving Church. As part of the Charity's training and discipleship programs, additional Leadership Conferences were held in 2017 with around 250 pastors and leaders in attendance. Additional Leadership Conferences are planned for 2018 as well.

China

The Charity continued its training and discipleship programmes in China throughout 2017. This was accomplished through growing the ABC Bible Training Programme to more than 2,500 students and expanding the CMS Mission School Programme with more than 500 students. It is the Charity's goal to grow these programmes for training and discipleship in China as funds permit. The ABC and CMS programmes continue to be a major outreach of World Compassion in spreading the Gospel in China along with significant training of believers throughout the nation. To further support the pastors and leaders of China, we held a couple Leadership Conferences with around 250 in attendance. Additional Leadership Conferences are planned for 2018 as well.

Iran

With the continued presence and in many cases the escalation of terrorist activities in the Middle East the Charity's work of placing Bibles in to Iran has been more challenging. Nevertheless, World Compassion continues to seek means to distribute Bibles in the nation of Iran. To date over 65,000 Bibles have been moved into the country through various means. We will work diligently to reach our goal of 100,000 Bibles as channels of distribution are opened and funds are available to move the Bibles.

Northern Iraq, Kurdistan

In 2017 the Charity continued to provide humanitarian relief to portions of Northern Iraq for the first half of the year. This included providing humanitarian relief items to refugees travelling across Europe. This work has been facilitated by working with local churches throughout the region. World Compassion partnered with an NGO that was already established in a village near Erbil, Iraq to help build a safe house for women who were slaves to ISIS soldiers. In this home that will be able to facilitate up to 28 women, we will help bring restoration through counseling and train them in practical skills to help empower the women to integrate back into society. The Charity will work diligently in 2018 to help open and operate the safe house, as well as sponsor women to live there for up to 6 months at a time.

Donor Education and Issue Awareness

The Charity held several donor dinners in the United Kingdom as a means to further communicate the mission of the organisation. Terry Law visited a number of churches in the region while Jason Law met with pastors and other leaders to present updates on the accomplishments and goals for the continued work of the Charity. These donor meetings and various church/pastor meetings were instrumental in communicating the financial needs of the Charity in order to fund the various mission works going forward.

Additional donor events along with church meetings and leadership meetings will be planned during 2018.

FINANCIAL REVIEW

The Trustees are pleased to report that over £67,000 in support of projects overseas was distributed in 2017. The Trustees are confident in the management of resources and work towards the continued growth in number of donors, legacy gifts, church and business relationships, as well as new ministry opportunities.

The Charity maintains a cash reserve as a means to address possible fluctuatuins in the monthly revenues and to insure the ongoing operations of the Charity in the UK. The financial stability and integrity of the organisation is very important to the trustees in order to continue to fulfil the mission of the Charity globally.

RISK REVIEW

The trustees have examined the major strategic, business and operational risks which the charity faces and confirm that systems have been established to enable regular reports to be produced so that the necessary steps can be taken to lessen those risks.

RESERVES POLICY

It is the policy of the Charity to maintain unrestricted funds at a level that will enable the charity to continue its day to day activities and to plan ahead.

RESPONSIBILITIES OF THE TRUSTEES

1 ACCOUNTING POLICIES

The accounts have been prepared on a receipts and payments basis.

Incoming resources

All income is included in the accounts when actually received by the Charity.

In order to perform it's charitable activities the charity is dependant upon voluntary help provided by friends of the charity. The value of such help is impossible to quantify and is not included in the accounts.

Resources expended

Resources expended are recognised when paid by the Charity.

Fund accounting

The charity holds funds in a single general unrestricted fund.

These are funds can be used in accordance with the objects of the charity at the discretion of the trustees.
