OBJECTIVES AND ACTIVITIES

Objectives and aims

Its main objectives and aims can be summarised as to:

- foster an interest in the birds of the Neotropics amongst birdwatchers throughout the world;
- increase awareness of the importance of support for conservation in the region;
- mobilise the enthusiasm of birdwatchers active in the region to contribute to the conservation of Neotropical birds;
- provide a forum for articles and notes about Neotropical birds, their identification and conservation through the
- publication of the Club's journals; and

- provide small grants to fund ornithological and conservation projects within the Neotropics.

Grant-making policy

Grants are made to fund ornithological and conservation projects in the Neotropics and are made both to locally based institutions (typically non-governmental organisations) and to individuals undertaking relevant research on threatened species or habitats. Preference is given to projects undertaken by Neotropical nationals and where NBC's contribution pays for a significant percentage of the work.

In return for providing funding, the Club requests recipients to provide a paper for possible publication in Cotinga or Neotropical Birding detailing the results of the project.

Significant activities

During the year, NBC continued with the publications strategy introduced in 2009 and produced one large issue of Cotinga and two issues of Neotropical Birding.

Neotropical Birding 20 and 21

Issues 20 and 21 of Neotropical Birding continued the trend set by previous issues and included many colour images of rarely seen or photographed species. The articles in Neotropical Birding 20 included:

- Birding's World Cup: Global Big Day;

- First photographs of the White-fronted Swift, a poorly known Mexican endemic; and
- a Photospot on the Fuegian Snipe at Cape Horn.
- Articles in Neotropical Birding 21 included:
- an account of the NBC fundraising tour to Chile;
- xeno-canto.org: a decade on; and
- wader quest in the Neotropics.

Cotinga 39

A wide variety of articles were also published in Cotinga 39 with these including:

- A new locality for White-masked Antbird in Peru;

- A list of the birds of Parque Nacional Saslaya in Nicaragua; and

- Birds of a habitat mosaic in the threatened Cerrado of central Sao Paulo, Brazil.

The short communications were equally varied and included details of the first record of Ruff for Cuba, notes on the nest and breeding of Chestnut-vented Conebill in southern Ecuador, the rediscovery of the Black-fronted Pipin-guan in Itajaí Valley, Santa Catarina, southern Brazil and the first documented record of White-collared Kite in Bahia, Brazil.

Other activities

In August 2017, the Club had a stand at the Rutland Bird Fair, with the Club's main prizes in its annual raffle being a pair of Swarovski EL binoculars and a stay at El Septimo Lodge in Ecuador. The Club would especially like to thank Swarovski Optik for their ongoing support in providing prizes for this annual fundraising event.

In collaboration with the other regional bird clubs, NBC has been involved in developing a code of practice to encourage "best practice" whilst in the field. It is intended for individual birders, field workers, tour companies and photographers and was developed in response to concerns of less than ideal behaviours. This has been published on the NBC website.

In December 2016, the bird tour company Birding Ecotours organised a highly successful tour to Costa Rica on behalf of the club with those who participated seeing a great selection of the country's specialities and also raising over US\$3,000 for the club.

During the year, the Club continued to operate a Facebook site and Twitter account.

Membership

Membership of the Club decreased very slightly during the year to 781 (2016:786).

OBJECTIVES AND ACTIVITIES

Grantmaking

The other major Club activity is funding conservation projects and 2017 was the most successful year to date of this programme with a total fourteen awards being made (2016: 7). The grants totalled £27,569 during the year (2016: \pounds 18,989), which means that over the last 18 years £116,573 has been provided to support Neotropical bird conservation projects.

Projects funded in 2017 were as follows:

- US\$5,000 for a study of Poylepis communities in Peru;
- US\$3,920 towards work on the effect of microclimate on terrestrial insectivores in Brazil;
- US\$1,500 for a project on some of the rarer species on Grenada;
- US\$2,600 towards a study of the endangered Peruvian Plantcutter;
- US\$2,920 for a study of parrots in Venezuela;
- US\$3,000 for work on nest predation avoidance for the critically endangered Masafuera Rayadito;
- US\$1,500 towards a project on restoring the population of Yellow Cardinals in Argentina;
- US\$2,448 on the conservation of the endangered Recurve-billed Bushbird in Venezuela;
- US\$3,000 for a study of the critically endangered Sapphire-bellied Hummingbird in Colombia;
- US\$3,000 towards a project to reintroduce Great Green Macaws in Ecuador;

- US\$2,780 on a nest box scheme for Grey-cheeked Parakeets in Ecuador;

- US\$2,989 for a study on the foraging habits of the Black-capped Petrel in the Dominican Republic;
- US\$4,830 for a project to reintroduce endangered Black-fronted Piping-guans into areas where they had become

extinct in Brazil;

- US\$1,500 on monitoring Crown Solitary Eagles in Argentina;

ACHIEVEMENT AND PERFORMANCE

Fundraising activities

From a financial perspective, 2017 was a highly satisfactory year for the Club with total income of £56,034 (2016: £59,952). Whilst membership subscriptions are the main source of unrestricted income, Council would like to thank the organisations and individuals who made donations during the year, especially the March Conservation Fund of Tides Foundation, whose ongoing support makes a huge difference to the number and size of conservation awards which could be funded.

The £19,226 spent on producing and distributing journals was the most significant expenditure which the Club incurred (2016: £20,458).

FINANCIAL REVIEW

Reserves policy

The Council have adopted a policy of maintaining the Club's unrestricted funds at a level equivalent to at least one year's normal unrestricted expenditure. They believe this provides appropriate and sufficient funds to ensure the continuation of the Club if, for example, there was a short-term decline in the number of members.

Investment policy and objectives

The majority of the Club's funds are held in Natwest Bank. In the judgement of the Club's Council, this is currently the most appropriate form of investment for these monies although with interest rates remaining at record lows, the amount earned is currently very low.

FUTURE DEVELOPMENTS

NBC Council regularly considers its strategy for the future and during 2017, the decision was taken to introduce a new membership category from the beginning of 2018, allowing members to receive electronic copies of the club's publications instead of, or in addition to, the printed versions.

Due to a combination of the unreliable postal services in a number of countries (hence members do not receive the journals they have paid for) and increased postage costs, it is hoped that this change will not only ensure more reliable delivery of the club's publications but will also boost membership in the Neotropics.

Independent Examiner's Report to the Trustees of Neotropical Bird Club

I report on the accounts for the year ended 31 December 2017 set out on pages five to nine.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year (under Section 144(2) of the Charities Act 2011 (the 2011 Act)) and that an independent examination is required.

Notes to the Financial Statements

for the Year Ended 31 December 2017

1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008), the Charities Act 2011 and the requirements of the Statement of Recommended Practice, Accounting and Reporting by Charities.

Incoming resources

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Resources expended

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Website

- 33% on cost

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
