### STRUCTURE, GOVERNANCE AND MANAGEMENT

### **Governing document**

The charity is controlled by its governing document, a deed of trust, and constitutes an unincorporated charity.

The day to day management of the charity is carried out by the members of the PCC, all of whom are also trustees.

### Recruitment and appointment of new trustees

Each DCC votes on its members annually at local level when they hold their individual Parish annual general meeting. New trustees are appointed by a majority vote and are given appropriate training to inform them of their duties and liabilities under Company and Charity Law.

### **Parochial Church Council**

The Parish of St Peters Ipsley is made up of the churches of St Peters Ipsley, St Johns Greenlands and Christ Church Matchborough. In addition a congregation meets at Ipsley C of E Middle School. The parish covers approximately one third of Redditch and includes the areas of Greenlands, Ipsley, Matchborough, Winyates and Winyates Green.

### Risk management

The trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

#### **OBJECTIVES AND ACTIVITIES**

### Objectives and aims

The primary objective of the charity is the promotion in the ecclesiastical parish of the whole mission of the church.

#### **Public benefit**

The trustees have complied with their duty to have due regard to the public benefit guidance published by the Charities Commission; the trustees consider that the charity meets the public benefit requirements of the Charities Act 2011 by carrying out its normal activities

### **FINANCIAL REVIEW**

#### Reserves policy

It is the policy of this Parish to hold in reserves the equivalent of two months' general running costs and three months' salary costs. It is also our policy to hold an amount for essential building works as required, to comply with forthcoming Quinquennial inspections.

In applying these parameters, the individual situations of the three churches within the Parish have been taken into account and agreed at DCC level.

The policy will be reviewed annually as part of the Church year end accounts procedure, agreed by each DCC and consolidated into one Parish policy.

The overall Parish Accounting picture at end of 2017 shows an increase in funds from £171K at end 2016 to £227K.

This favourable result arises due to the following main items:

- Specific Donations for Christ Church Community Missioner £12.5K
- Diocesan Funding for this same Project £8.6K
- Increased Lettings total £5K
- Fairer Parish Share across the Parish £35K

### Offset by:

- Operating Cost Increases £3.5K
- Community Missioner commencing in last Quarter £6.6K

These main improvements are shown in Total Cash within Current Assets, which increased from £54.3K to £96.6K

St Peters also cleared £20K loan commitments - the end of the Car Park funding project.

Thanks go to the DCC Treasurers for their hard work in the year, keeping a tight rein on costs and maximising efforts on income streams.

Looking ahead, we will need to maintain efforts to encourage regular giving and giving towards specific initiatives, and of course keep tight control of expenditure. Parish Share continues at a more achievable level, and the Fairer Share scheme will be re-run in 2018, to come into effect the following year.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2017

#### 1. ACCOUNTING POLICIES

### **Accounting convention**

These financial statements have been prepared in compliance with FRS 102 Section 1A, the Financial Reporting Standard applicable to the UK and Republic of Ireland, the Charities Act 2011 and the requirements of the Statement of Recommended Practice, Accounting and Reporting by Charities.

### **Incoming resources**

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

### Resources expended

The diocesan parish share is accounted for when paid. Any parish share unpaid at the year end is provided for in these accounts as an operational liability.

Other expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

### **Tangible fixed assets**

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Freehold property not provided Plant and machinery 10 -20% on cost

Consecrated and beneficed property of any kind is excluded from the accounts by section 10 of the Charities Act 2011.

Moveable church furnishings held by the Vicar and Churchwardens on special trust for the PCC, and which require a faculty for disposal, are accounted as inalienable property unless consecrated. For inalienable property acquired prior to 2001 there is insufficient cost information available and therefore such assets are not valued in the accounts.

#### **Taxation**

The charity is exempt from tax on its charitable activities.

#### **Fund accounting**

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

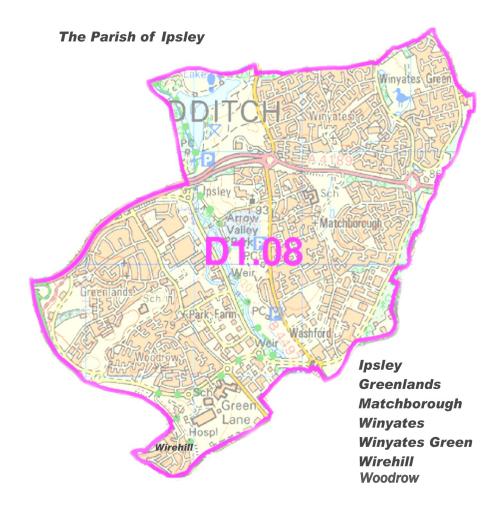

Harnhill Centre of Christian Healing in the Diocese of Gloucester and a replacement will be sought in the new year.

There was a lengthy debate on the Church of England's links with the Methodist Church. There is a new appetite for being in communion with each other. One of the main differences is the historical background as to how the church is led.

The Church of England is Episcopal lead from the top down with Bishops who ordain clergy – apostolic succession which the Methodist Church does not accept. More work is required on how the Church of England and the Methodist Church can come together, more clarification is required and there will be an update in July, but there seems to be a genuine willingness on both sides. Bishop John's view is that he would like to see us re-joining and one particular point of interest was that he himself had a Methodist education.

A motion was carried calling on the Government to bring forward legislation to minimise food waste. An average household throws away over 50% of the food it buys

Archbishop Justin called for a re-imagining of ministry with everyone being open to doing things differently.

Going forward a training session has been provided for clergy with input from national stewardship people alongside Alison Maddocks our Diocesan Stewardship Officer.

And I have seen His provision every step of the way. Jenny and I are so blessed to have such caring congregations in the three churches, who have faithfully prayed, encouraged and supported us through this time. There were cards, and offers of help, many offers of lifts to the hospital and back, the numerous phone calls and messages. So thank you for showing to us what it means to be part of the family of God.

I also want to express my thanks to the Rev. Richard Harding who has been there to shoulder a massive amount of responsibility of the three churches. In no way did the Parish feel the negative effects of my absence. When I went on sick leave, I left the leading and handling of the parish to Revd Richard, who very ably managed the affairs of the parish.

He supported Judy Evans and Linda Nicholas the churchwardens at St Peter's and Barry Humphrey and Sharon Forrest, the churchwardens at St John's in their role and ministry.

Revd Richard has amply proved throughout his year, that he is not just Vicar for Christ Church, but is truly a Vicar in the Team for the whole of the parish. So "Thank you" Richard for doing a sterling job and holding the parish in good heart. As we continue to work together, our motivational gifts complement each other so that we minister effectively together as a team.

Both Revd Richard and Revd Ian, maintained the priestly, pastoral and sacramental ministry across the whole parish. Though the churches were closed on an occasion or two because of the snow, they were never closed and no service was ever cancelled because ministry could not be provided.

I want to say thank you to highlight the role of the vast team of volunteers that have assisted in the workings of the parish and the three churches. The team of Readers, (Licenced Lay Ministers) has willingly worked hard to support the ministry of the church.

Some of our readers have faced health issues which have limited their input into ministry, but their love and zeal for the Lord's work has not diminished. Chris Tilley has not been able to return to work following complication after much awaited surgery on her foot. She continues to be off, and we covet your prayers for her recovery. Maureen Hughes has suffered major health challenges over the course of the year, and she too is currently taking it slow.

### **Deanery Synod Report**

The main feature of Deanery Synod in October was Stewardship and Alison Maddocks, the new diocesan stewardship officer gave a presentation. She took up her post as Stewardship Officer in January 2017.

Alison's role is to promote our 'Kingdom People' commitment to ensuring that we are 'Devoted to growing deeply as disciples, offering our time, talents and money to God', Alison's role is to work along-side churches to:

- Promote greater understanding of the principles of Christian Giving
- Inspire, equip and resource people in financial stewardship,
- Help with stewardship programmes, 'Fairer Shares' and the creation of Mission focussed budgets

The Rural Dean introduced the Buildings for Mission survey which he had trialled with his parish, and which our DCC have since engaged.

Reverend Christine Holzapfel the Rector of the Bromsgrove Team is to be appointed as a residential Ministry Team Member at the How can we introduce issues such as love and sin back into the world of political discourse?

After coffee, the Synod was joined by young people from CandY (the Children's and Youth Councils) for discussion on tables.

- Your neighbour isn't just the person next door, it's everybody
- What stops us reaching out to people? Often it is fear and churches can create a space through coffee mornings etc where people can come and talk to others
- Keeping church doors open makes a real difference in being available to the community

At the November meeting, Mission Development Officer, Doug Chaplin referred to the church's involvement with Worcestershire Welcomes and the Halesowen Welcome Group. He introduced the Revd Mike Todd who spoke about the Children's Society's work with refugees. See Mike's presentation.

Mike started by offering a big thank you for all that churches in Worcestershire and Dudley do to support the Children's Society. Each year, Children's Society collection boxes raise £1.7m and Christingle services raise £1.3m.

Mike explained that work with refugees and child migrants can be quite controversial and challenging. People don't always want to support refugees. However, the Children's Society has been working with refugees since WW2 when they were involved in the Kinder-transport scheme. The organisation now supports refugees through front line campaigning, advocating and project work. The Children's Society has a vision of churches as places of safety for everyone where a welcome is offered without compromise or judgement. There are six things that people can do; pray, listen to the voices of refugee children, change the narrative by talking to friends and neighbours, give, volunteer and provide foster care.

Chris McLaren, finally had her second hip replacement operation and spent the latter part of the year recovering from the surgery. And here I want to pay tribute to Andrea Mortimer who was the lone Parish Warden when Chris was off sick. I was ably supported by the churchwardens at St Peter's and St John's in the work of these churches. I could not do it without them. So thank you, Judy and Linda, Sharon and Barry for all your support.

Both Chris McLaren and Andrea Mortimer were very supportive in their roles as parish wardens. They have prayed faithfully for the clergy the readers and the parish, constantly carrying them in their thoughts and prayers before the throne of grace.

In 2018, we are looking at the future of current projects and asking where God is leading us with them, and also what God is requiring of us to see them grow and be fruitful. We are also looking at starting some innovative new outreach ministries, such as "Come and See" services at Christ Church, an evangelistic service for those who are unchurched. At St Peter's we are looking to start a Monthly Healing Service, where we can invite people to come and receive prayer for healing with the laying on of hand. In order to start this we need to prepare a prayer ministry team able to minister alongside the clergy in this key ministry. That is why we plan to run Prayer Ministry Training sessions later this year.

There has been increasing cooperation in ministry across the three churches. Maureen Hughes has joined us in baptism preparation sessions, and the Revd Ian has helped at both the Baptism preparation and the Wedding Preparation sessions held through the year.

As you will see from the finance report, God has blessed the three churches through this year. Partly because of a reassessment of our parish share, but largely because of God's faithfulness we had the resources to carry out the work and mission of the Church in Ipsley. Each of our churches goes into the New Year in the black.

As God has begun to do new things and strengthened the old through this year, so too we have experienced increasing opposition from both outside the church and in many instances from inside the church. This opposition has meant that we have had to spend a lot of our time and spiritual and emotional energy dealing with difficult circumstances rather than doing the work God has called us to do.

At the end of the year, as I was spending time in prayer and seeking God's face, I heard very clearly the words of Revelation 3:2 "Awake and strengthen what remains and is at the point of death." This to me is a sobering call. The church is always just one generation away from dying. While I believe we have a call to minister to young people and to prepare the younger leadership, I also believe we need to be doing work with parents and grand-parents, preparing them to teach their offspring the word of God, and bring them up in the faith of the church.

Therefore, in 2018, I have decided that I will call the churches to a bible based and sincere discipleship. We will preach the word of God and no other.

### Diocesan Synod

Synod is the method of governance in the Church of England. The Diocesan Synod is a body formed of the Bishops of the Diocese along with elected representatives of clergy and lay people from across the Diocese.

The functions of the Diocesan Synod are to:

- Consider matters concerning the Church of England and to make provision for such matters in relation to our Diocese.
- Express an opinion on matters of religious or public interest.
- To advise the Bishop and to consider and express an opinion on any matters referred to it by the Church of England's General Synod

In the Diocese there are 14,000church members, 280 church buildings and 100 church schools.

The Diocese has partnership links of Peru, Morogoro in Tanzania and the Protestant Church of Central Germany.

At the March meeting Dr Malcolm Brown, Director of Mission & Public Affairs at the Archbishops' Council, addressed the synod on the challenges and opportunities for the Church in the changing context of welfare provision in our country.

He went on to say that it is important that people are not penalised just for being unlucky. Not everyone who ends up in a mess is a fool or has made a string of bad choices. However, welfare shouldn't encourage people to be careless. In this way politicians are often faced with the impossible.

At the heart of welfare policy, churches are uniquely placed to change the way we talk about things, to help balance personal responsibilities with the responsibilities of the State. There is always the desire to seek out new possibilities and step beyond the familiar in following Jesus and once licensed there is always further training available and LLMs are encouraged to attend training events and the Reader Weekend at Holland House.

Catherine McLaren is currently exploring ordained ministry and her time as a reader will hold her in good stead. Catherine has this year gone on placement to other churches to experience different styles of worship.

We congratulated Peter McLaren earlier in the year when he graduated with a theological masters degree from Durham University.

Sadly some of our LLMs have faced health issues this year. Chris Tilley has not been able to return to ministry following complications after much awaited surgery on her foot. Chris McLaren also spent time recovering from surgery at the later part of last year. Maureen Hughes has been less active this year suffering major health challenges. Jesus went through all the towns and villages healing every sickness, today our Lord continues to pour out his healing balm when we pray for the sick so may we all pray for healing for our colleagues who are ill.

Looking forward, please continue to pray for the Licensed Lay Ministers in Ipsley parish as they face new and exciting challenges ahead.

We will nurture and encourage the churches to be filled with the Holy Spirit and bear witness to Christ in the power of the Spirit in the communities that surround our churches. I want our leaders to create a space in our services where the congregations can witness and exercise the gifts of the Holy Spirit at work in our teaching, worship and ministry.

As you will read the rest of the report may you see and hear what God is doing in our midst.

### **Finance Report 2017**

The overall Parish Accounting picture at end of 2017 shows an increase in funds from £171K at end 2016 to £227K.

This favourable result arises due to the following main items:

Specific Donations for Christ Church Community Missioner ££12.5K

Diocesan Funding for this same Project £8.6K

Increased Lettings total £5K

Fairer Parish Share across the Parish ££35K

### Offset by:

Operating Cost Increases £3.5K

Community Missioner commencing in last Quarter £6.6K

These main improvements are shown in Total Cash within Current Assets, which increased from £54.3K to £96.6K. St Peters also cleared £20K loan commitments - the end of the Car Park funding project.

Thanks go to the DCC Treasurers for their hard work in the year, keeping a tight rein on costs and maximising efforts on income streams.

### **Licensed Lay Ministry**

Licensed Lay Ministers (also known as Readers) are part of the nationally recognised and accredited public ministry of the Church of England. It is a voluntary, unpaid ministry with approximately 10,000 Licensed Lay Ministers nationally and around 160 in the Worcester diocese, 11 of whom are placed in Ipsley Parish.

You may wonder, what does a reader do? After speaking with the readers in our parish one can see that it is a varied and wide-reaching ministry.

At the heart of the role there is a ministry of the word, this is where the readers support the clergy in the ministry of teaching, preaching and leading worship which our Lay ministers contribute to on a regular basis but according to their gifts Licensed Lay Ministers are also engaged in a wide variety of other ministries. Ministries such as pastoral care work, chaplaincy work and we have here in Ipsley Parish ministers involved in both cathedral and hospital chaplaincy.

Community involvement is another important ministry in our parish. Rosie Humphrey has recently been elected as Chair of the Woodrow Community group, an umbrella organisation working with residents on Woodrow for the benefit of the local community. Marilyn Bishop is a trustee of the community project in Matchborough.

Beyond that, LLMs are involved in marriage preparation, baptism preparation, funeral ministry, healing ministry and still find the energy to do Open the Book, after school clubs, Messy Church, ladies prayer breakfast, lead House Groups and one even organises Sparklers, a group for under-fives and their parents or carers.

### Open the Book



Praise the Lord that cross parish teams of six or seven storytellers continue to be welcomed in four local first schools: Matchborough First School Academy, St Thomas More First School, Tenacres First School and Woodrow First School, to present Bible stories. We have all built up good relationships with staff and children, who love to be asked to participate in various ways.

Middle school staff have recognised an increase in Bible Literacy as children exposed to Open the Book move up through the system.

We held another successful Jamboree in the summer when we celebrated together over lunch and thanked those who regularly pray for the ministry or make props, as well as encouraging some who wanted to investigate what is entailed.

My thanks to all who give time, at least two hours a week, to pray, plan and prepare for each presentation, who stick to the scripts provided by Open the Book (very important as this gives confidence to Head teachers that we are not proselytising) and respect Safeguarding considerations. Training is often available; some workshops, and others to encourage and inspire. There was a memorable day which included storytelling input from Bob Hartman, and more recently another Care and Share event organised jointly by Open the Book and the Diocese of Worcester.

If you feel called to join a really enjoyable, exciting and rewarding activity then have a word with me.

- A member of St John's, Mike Palfreyman underwent ALM Worship Leader training and was authorised at Worcester Cathedral.
- The continuation of our midweek service of Holy Communion and Prayer was maintained, with an increase in the number of people attending.
- The number of Sunday's clergy take the morning service has increased; providing more opportunities for the congregation and clergy to connect.
- Long established provision of services to the community through parent and toddlers and community teas continues; also short mat bowls reaching new people with the love of God.
- A course to help the congregation identify our spiritual gifts was run twice a week. To help us learn and grow together, follow on Support Groups have also been set up.
- Volunteers continue to provide church children with Bible teaching, encouragement of fellowship and opportunities to pray together.

The annual Harvest Supper took place on Saturday 30th September, it was a time of fellowship and fun. Several people provided entertainment and Lynne Davis and her team organised the refreshments.

Rhoda Lingard organised Open Church events, which were well attended by both church members and visitors.

The social event team organised regular events which included a pudding evening, a visit to Clarke's farm, a treasure hunt, walks and teas.

Our Easter and Christmas services were well attended and it was good to see so many visitors, particularly so at Christmas.

Ignite, our children's group for the 7-13's meets every Friday during term time and numbers are steadfast, it is led by Judy Evans and Rachel Hathaway. Scramblers for pre-school children led by Felicity Melley meets every Monday morning during term time and Little Miracles, a playgroup for twins, triplets and more continues to meet weekly and is led by Sarah Barcham.

A Prayer Ministry team involving some of our church members meets regularly with pupils at Ipsley Middle CE RSA Academy, they have their own Prayer Room and many pupils visit them to talk and pray.

The Ipsley Parish bell ringing team is continuing to flourish. The team regularly ring at services and weddings. They meet most Fridays at St. Peter's for bell ringing practice.

We thank God for his blessings and encouragement over the past year we look forward to being part of God's vision for the future.

### Parish of Ipsley APCM Christ Church Report for 2017

In September last year God gave me a vision of a black dog with something in its mouth that it was shaking really hard — He also provided me with the interpretation that the black dog was the devil and the thing in his mouth was the Matchborough community and he was saying that the devil has got a hold on this estate so 'what are you as God's church going to do about it?' I shared this with this church and encouraged us to pray and seek God's face and also to make the church welcoming to everyone on this estate. This was discussed at DCC and it was agreed that we should remove some of the bars from in front of the church centre and also tidy up the frontage. Since we have been praying for God to move, we have come under a sustained spiritual attack and unfortunately we have had people undermining the ministry that we offer.

We continued to have problems with some youth from the community with anti-social behaviour and vandalism - the police were involved on many occasions, even to the point of using our downstairs meeting room at church for their base so that they could be on-hand. We have continued to work with the Council and the Police on ways to tackle this.

### **Community Missioner**

The exciting news for 2017 was the Diocese funding a Community Missioner for three years from the Lowest Income Communities Fund/Diocesan Social Responsibility Fund and subsequently Graeme Russell was appointed and commenced in post in October, moving from Wales with his wife Jackie. During the first three months Graeme spent time with groups meeting at Christ Church to build on current relationships and networked with other organisations and charities. His continued aim is to build up new and existing relationships and put into place projects/initiatives to help tackle some of the issues faced by the local community.

#### Youth

Cool Zone for 7-11's met on Friday evenings in term time, averaging 12-15 children per session. It is a joy to see them growing in confidence, emotionally, socially and spiritually - some are now speaking out in prayer.

- The Youth Ministry for 12-15's has grown and each Friday evening around 25 young people attend. Throughout the year we delivered a wide range of activities, events, trips and programmes to impact the lives of the young people of all ages.
- The Wave youth service occurs the last Friday of every month and is led by the young people. The purpose of the Wave is to create a safe space for the young people to experience God through authentic but relevant worship, talks and activities.
- Youth Alpha 15 young people we have built relationships with came to explore the Christian faith further. It was exciting to see the older youth again step out into helping run these sessions, including some preaching for the first time.
- A group of Young People went to Soul Survivor and they had an amazing time spending time as a Church family and experiencing the Holy Spirit in a transformational way.
- A second residential weekend Submerge was held at Peckwood over the Remembrance weekend and a special service of remembrance was shared together in the woods. As part of the vision for Submerge to help grow young leaders the older youth helped in many ways such as planning, cooking, worship and one of our young leaders even co-led the weekend. The weekend with 6 young people giving their lives to God, which is testimony not only to the youth ministry but also to the work the Church has done, as many of these young people had moved up from Cool Zone.

### **Prayer and Fellowship**

- Weekly prayer takes place from 7.30 8.30 p.m. on Tuesday evening when up to 5 members regularly prayed in the small prayer room in church but towards the end of the year numbers attending more than doubled and, as a result, prayer relocated to the larger downstairs room in the Church Centre.
- Support Groups, meeting in people's homes, continued on Wednesday evenings for prayer and Bible study.
- Some of the men from the church came together about every 6
  weeks at Studley Garden Centre cafe for breakfast and fellowship and the ladies met every 4-6 weeks in church to enjoy a
  continental breakfast, share around a Bible passage and pray.
- Regular fellowship lunches have been held after the Sunday morning services and these have proved to be very popular and a great way to have fellowship together.

### Community

- We continued with monthly litter picking on Saturday mornings around the Matchborough Water Gardens and the surrounding area.
- Our Fun Fest in July was very successful our yearly free fun day for the Matchborough community - talent contest, bouncy castle, face painting, craft activities and a free barbecue.
- The Remembrance Day parade started at Winyates centre with a short act of remembrance and a wreath laid on behalf of the residents. We then walked to Christ Church where a service of remembrance was held.
- A group of us sang carols before Christmas in some of the closes in Matchborough when quite a few residents joined us.

### **Christ Church Community Project**

The work through the Christ Church Community Project has mainly focused on the Lunch Club which has continued to grow to a point where we now have a waiting list. We also delivered Matchborough Voice to all the closes in Matchborough twice during the year.
