Structure, Governance and Management

The church is governed by the church constitution adopted on May 2002.

Membership

Members are admitted in accordance with the provisions of the Constitution by vote of the church meeting on the basis of their profession of Christian faith and recommendation by the Eldership.

Trustees

The trustees meet during the year to review operations, consider financial performance and discuss developments to ensure the church's objectives are being fulfilled.

Church Meeting

Regular meetings of church members are held bi-monthly. One of these meetings incorporates the annual church member's meeting to receive annual accounts, and to ask questions about them.

The church meeting has responsibility for the overall policy of the church, in accordance with the constitution. Relevant matters may be submitted to the church meeting or raised by members in church meeting for further consideration by the Elders.

Objectives and Activities

The principal purpose of the church is the advancement of the Christian faith, to include the advancement of education and such other charitable purposes within Suffolk, in the UK and other parts of the world.

When planning the activities for the year, we have considered the Commission's guidance on public benefit. In particular we try to enable people to find and live out their faith as part of our church community through:

Worship and prayer

Learning about the Gospel

Developing knowledge of and trust in Jesus

Provision of pastoral care

Missionary and outreach work.

Achievements and Performance

During the year Elders, Trustees and Members have sought to examine their lives and church activities to live in a way which enables others to encounter the love of Christ, grow in their faith and understanding of others.

On our website we described ourselves as:

"A welcoming church in Ipswich committed to loving God, each other and the community"

Services of Worship with age appropriate classes for children and young people have been held on Sunday mornings. During this period we studied a series entitled *Transformed Life* and used this in home groups and for daily readings. People are encouraged to speak of their spiritual experience and to pray for one another. This has included baptisms, commitments to Christianity and support for those on a journey in their discipleship. Weekly activities for children and young people involved learning about the Christian faith with craft, games, outings and the opportunity to make friends.

Church membership has remained at 72 members.

Easter celebrations were shared with Colchester Road Baptist Church and Rushmere Baptist Church.

A general invitation to attend a day at The Hut in Felixstowe was made to our contacts within the wider community.

Jonathan Conrathe led a weekend of mission in June.

Graham Jack was the speaker at our church weekend at Sizewell.

Weekly Toys and Noise for parents and toddlers continues to be popular with local parents on the Rushmere estate.

Family fun events were held at a local park in the summer, and a community carol singing event at Christmas.

The Shoe Box service resulted in around 100 boxes sent to Samaritan's purse for distribution overseas.

Christians Against Poverty (CAP)

We continued to work as a CAP centre, with Jayne Green as our church worker. At the end of March 2017 there were 30 active clients. 17 people have become debt free since CAP started at RCF.

This service continues to offer advice about debt relief, management of finances (via head office), practical help, food hampers, friendship and support to clients. Meetings for clients at local Costa cafes have also been running. An annual CAP service and lunch is offered to all related parties. Jayne's work with CAP has been featured in the local media and other secular support agencies have referred clients to CAP.

CAMEO continued to invite speakers to events, mainly attended by senior citizens from within and outside the church community.
