#### INDEPENDENT EXAMINER'S REPORT

Independent Examiner's Report to the trustees of Bramblebrook Community Association

I report on the accounts for the period ended 31 March 2018 which are set out on pages 2 to 4.

Respective responsibilities of the trustees and examiner

Basis of independent examiner's statement
