STRUCTURE, GOVERNANCE AND MANAGEMENT

The Trustees (who are also directors of the Charity for the purposes of the Companies Act 2006) present their fifth annual report, for the 12 months ended 31 March 2018.

History

Blue Apple Theatre was established as a Company limited by guarantee under a Memorandum of Association which established the objects and powers of the charitable Company and it is governed under its Articles of Association. The Company was incorporated on 25 October 2012, registered as a charity on 5 March 2013 and commenced fundraising shortly thereafter. The activities of Blue Apple Theatre (founded in 2005) were transferred to the Company under a Memorandum of Agreement dated 31 July 2013 from Winchester and District Mencap Society (now known as Winchester Go LD).

Trustees

The Articles stipulate a minimum of five Trustees, who are also Directors of the Company, with no maximum number. One third of Trustees retire by rotation annually, with a maximum duration of service being 9 years i.e. 3 rotations of 3 years. There were five trustees for the first quarter of the year and seven for most of the year.

Trustee recruitment is by open advertisement and seeks to maintain coverage of essential skills. We commenced further trustee recruitment once again at our Christmas production in December 2017 with positive results and anticipate new trustees will formally join the Board later in 2018.

Trustee induction is in place and further training on specific matters is provided. There are at least five Trustee meetings a year. Trustees also participate in small working groups on specific issues such as fundraising, staff recruitment and financial matters.

Staff

Personnel at Blue Apple, (four people,) have remained constant this year albeit job titles have changed.

We commenced in April 2017 with Simon Morris arriving to take up the 3- month interim post as Blue Apple's General Manager (0.8 fte), which he fulfilled so successfully that the appointment has been confirmed long term. Richard Conlon continues as Artistic Director (0.8fte) responsible for the Company's artistic direction, artistic coordination and oversight of our expanding Outreach work (see below) and the production team who provide the technical assistance and production values for each major show. Dance and Outreach work have been delivered by associate artists on behalf of Blue Apple.

The Artistic Director and General Manager report to trustee meetings and where possible attend. The Artistic Director and General Manager are assisted by a part-time (0.6 fte) Administrator and a part time (0.3 fte) Finance Manager who also undertakes the Company Secretary role. Both the Administrator and Finance Manager roles report to the General Manager.

The Founder continues to promote the Company and to assist on specific projects.

The charity is reliant on a number of volunteers who assist with rehearsals, performances and evaluation. They have yet again provided a wonderful resource to Blue Apple.

Since its inception Blue Apple has been based at the Tower, a performance space linked to Kings' School. This will be our last Annual Report to cite the Tower as our registered office address. Marking the performance development and organisational maturity of Blue Apple, most excitingly April 2018 will see the Blue Apple move its office headquarters and Core performance company into the University of Winchester. The new five-year residency is intended to support more partnership work between the two organisations.

Risk Management

The Trustees have a risk management strategy which comprises:

• an annual review of the principal risks and uncertainties relevant to the charity

- the establishment of policies, systems and procedures to mitigate the risks identified in the annual review
- the implementation of procedures designed to minimise or manage any potential impact on the charity should those risks materialise

Financial sustainability is the major financial risk for the charity. A key element of the management of financial risk is close attention to cash flows and projected outflows while seeking to secure grants and voluntary income including legacy pledges.

Financial Review

Total Income for the year to 31st March 2018 amounted to £151,504, which is £506 (0.3%) more than in 2016-17. Unrestricted income to the General Fund amounted to £58,560, while income from grants to Restricted Funds totalled £90,169. Compared to the previous year (2016/17):

- Donations, Gifts and Legacies at £15,818 were £ 5,483 (26%) down;
- Fundraising income at £ 1,021 was £ 1,705 (63%) down;
- Investment income at £ 201 was £ 305 (60%) down;
- Charitable activities (Drama & Dance fees & Production) revenue at £ 26,752 was £ 7,574 (39%) up;
- Grants income at £ 107,712 was £ 425 (0.4%) up.

Total Expenditure for the year to 31st March 2018 was £151,504, which is £24,449 more than in 2016/17, and is £650 below budget for the year. Unrestricted Expenditure from the General Fund amounted to £ 58,560, whilst expenditure from accumulated designated funds amounted to £ 5,275, expended from the funds set aside for Production Costs. Expenditure from Restricted (grants) Funds totalled £ 87,669. Compared to the previous year (2016/17):

- No Fundraising costs were incurred in either year;
- Charitable activities ((Drama & Dance group & Production costs) at £151,504 were £24,449 (19.2%) up.

At the year end, there was an overall in-year deficit of £2,775, comprising and excess of expenditure over income of £5,275 spend from previously accumulated designated funds.

The remaining value of tangible assets at £748 was written down during the year. The Charity's tangible assets consequently had no value at 31st March 2018.

The overall effect of the year's trading has been to reduce the Charity's overall Financial Assets from £131,881 to £ 129,106, a net reduction of £2,775. Unrestricted General Funds have remained constant at £106,881, while Unrestricted Designated Funds have reduced from £15,000 to £9,725. Restricted Funds have increased by £2,500.

Reserves Policy

The trustees review annually the need for reserves in line with the guidance issued by the Charity Commission and consider that, in the context in which the charity operates, with a substantial majority of the charity's income arising from discretionary Grants and donations, that unrestricted reserves need to be maintained at an amount at least equal to six months running costs, namely £95,000, so as to ensure Blue Apple can continue to run, during any period of unforeseen difficulty, all its planned core activities and meet its organisational commitments as well as those required by grant making bodies. The level of reserves currently exceeds the target of six months expenditure but is justified by the higher risk and uncertainty of adequate future grant income and the greater future investment required to be made of resources for staff and equipment. Restricted funds are necessarily disregarded in the assessment of required reserves levels as their use is dependent upon the requirements of the donor. Substantially all the reserves are held in readily realisable form.

Principal Funding Sources

Funding comes from a wide variety of sources (see list below) including Big Lottery, Arts Council, charitable trusts, local government grants, fundraising events, sponsorship by local businesses, ticket sales, members' subscriptions.

The Trustees are most grateful to all the organisations and individuals who have supported Blue Apple and to our growing band of Friends who have generously provided ongoing support. A list of major donors can be found on page 8 of this report.

PUBLIC BENEFIT, OBJECTIVES AND ACTIVITIES

The Trustees are mindful of their obligation to comply with Charity Commission guidance on public benefit and have taken this into account while exercising their duties and activities with regard to the charity.

Blue Apple Theatre is a highly ambitious theatre company which brings all the benefits of taking part in theatre to performers who have learning disabilities and enables them to present high quality productions to the widest possible audience in a variety of large and small-scale productions, touring theatre and film.

Blue Apple Theatre believes that direct involvement in the arts greatly helps in the building of a more inclusive and equal society.

Blue Apple Theatre's charitable objects are:

- (1) To promote social inclusion for the public benefit by preventing people with learning difficulties from becoming socially excluded, relieving their needs and assisting them to integrate into society by developing their skills, enhancing their capacity and improving their life opportunities through the use of a variety of performance media, and by building a more integrated society through greater understanding and valuing of people with learning difficulties.
- (2) To relieve the needs of people with learning disabilities in such ways as the trustees shall think fit.

The Blue Apple Theatre Community Project, which is funded in part by the Big Lottery Fund, aims specifically to enable people with learning disability to develop their social skills and confidence, to be physically and mentally active, to feel less isolated and have more friends, and to engage more actively in the wider community.

The following is a brief account of the main activities undertaken to carry out our charitable purposes for the public benefit.

Programme

During the year we had a total of 83 regular attenders in our Winchester groups whilst our outreach work (see below) reached another 69 people. Some members are very active, becoming increasingly experienced performers and attending several different sessions.

Weekly sessions include large-group sessions (referred to in this document as 'Main Company') for 32 adults (up 4 from last year) who have learning disabilities (LD), working alongside 15 volunteers including sixth formers and university students. To accommodate additional demand for places and permit greater depth and one-to-one support time within rehearsals, since January 2018 people now attend sessions either on a Monday or a Wednesday. These sessions are led by the Artistic Director and have worked towards two major public performances (see below). The main dance programme is integrated into the Main Company sessions.

The Special Assignments Company provided weekly sessions for 13 adults with learning disabilities (up 1 member from last year), led by a Drama Leader and assisted by 2 volunteers, under the oversight of the Artistic Director. The University of Winchester has provided a rehearsal venue free of charge. The Special Assignments Company gave two major public performances in the year at the summer Hat Fair and the winter Woolly Hat Fair in Winchester.

We provided intensive weekly drama and dance training, led by the Artistic Director, for a smaller group who have, or wish to have, experience of touring ('Apple Core' and 'Apple Core Dance') of performers with Learning Disability.

Additionally, we provided further weekly dance sessions for 11 people, including sessions for those with moderate LD and some for those with more severe LD who need one to one support. We also provided weekly street dance sessions for adults with LD (average class size 12). These classes are led by freelance Dance Leaders.

We aim to achieve a tour or similarly outstanding performance piece bi-annually. This year 2017/18 we have hosted visitors from Ireland who have come to sample our work and learn from our

practice, noting the skill of our performers to be able to produce a repertoire of 2 major shows annually.

Outreach in Hampshire

We have expanded our Outreach programme this year thanks to a 22-month duration funding award from People's Health which finishes in July 2018. Through our 5 additional projects, across Hampshire and mainly outside of Winchester, we reached 54 children and young adults with a learning disability, taking part in drama and dance activities. These sessions come under the guiding aegis of our Artistic Director but have been delivered on behalf of Blue Apple by freelance dance and drama leaders. To list them and the numbers attending each session:

Osborne School, Winchester: 10

The Point, Eastleigh: 7

• Shepherd's Down School, Winchester: 12

The Lights, Andover: 9Ickneild School, Andover: 10

We also delivered 2 weekly sessions commissioned by Hampshire Cultural Trust; Epic Drama at Forest Arts Centre, New Milton for children with a LD aged 11 years plus (11 participants) and Drama at Ashcroft Arts Centre, Fareham, for young adults with a LD (10 participants).

Performances

The following were performed during the period by Blue Apple Theatre:

- Changes (Main Company), tales based on Greek myths, performed at Theatre Royal Winchester for 3 nights, June 2017, to an audience of 414.
- Elements of the Changes show were also presented at the Winchester Rotary Gala
 Night by members of the Main Company (audience 250 approx.).
- A dance segment of the Changes show was presented at Salisbury Playhouse for Salisbury Learning Disability Day (audience 75 approx.).
- The Christmas show at the Tower presented A King's City Christmas (Main Company,) an evocation of our home city of Winchester at Christmas, over 3 nights, December 2017, to an audience of 320.
- The Special Assignments Company additionally performed a street theatre piece, Argus, The Watchman, again reflecting a Greek inspiration, at the Hat Fair, Winchester July 2017 (audience 325 approx.) and performed Homecoming at the Woolly Hat Fair December 2017 (audience 70 approx.).
- Noggin, a dance piece developed in collaboration between Blue Apple and the University of Winchester D@win dance company, was performed Jan March 2018 on 5 occasions in different venues to total audience figures of over 600 people.
- The Back of My Hand was a piece commissioned and performed in October 2017 by Blue Apple's Core company at a CARE Conference, London recognising 50 years since the Abortion Act (audience 250 approx.).
- Our Street Dance group performed at the Kings Fayre (audience 40 approx.) and at the Innov8 Dance Showcase (audience 100 approx.)
- Performers, Founder and Staff from Blue Apple spoke at the Applying Shakespeare
 Conference, March 2018, an international symposium to discuss and profile the applied use of
 Shakespeare, hosted by Royal Shakespeare Company in Stratford (audience 80).

Achievements and Performance

(1) Enhancing individual lives:

- Training and touring has enabled some actors with learning disabilities to pursue ambitions of professional performance e.g. in StopGap Dance Company.
- People with learning disabilities have been engaged as volunteers in preparing drinks and clearing away, distributing flyers and posters, front of house at productions.
- Some Blue Apple Theatre members work as volunteers at a local commercial theatre.
- Positive feedback is received from parents and carers.
- Individual profiling of members tracks progress and addresses concerns.

(2) Engagement with the wider community:

Through performing high quality theatre to the widest possible audiences (see performance details above):

- Audience feedback is sought at every performance and written feedback has been very positive.
- Audiences include many people who have learning disabilities.

Through media:

 The website continues to be constantly revised and updated and now includes a blog section in which members' views are recorded.

Through fund-raising activities:

- A choral concert in Winchester, October 2017 attended by around 60, with proceeds to Blue Apple Theatre.
- A Rock Choir performance in Petersfield, March 2018, attended by around 200 people, with proceeds to Blue Apple Theatre.

Through engagement with local schools and colleges, and with the wider community:

- Local university students work alongside members in the Main Company and SAC.
- Local sixth form students take part in volunteer programmes.
- Dancers have joined other local groups at showcase events in Hampshire.

Evaluation

- Regular evaluation, evidence of outcomes and measurement of individual progress are undertaken by staff.
- A researcher from the Tizard Centre (University of Kent) is studying the social impact of BAT and has developed formal evaluation mechanisms for Blue Apple.
- Audience feedback is sought via questionnaires after all performance.
- A regular forum, 'Speaking Up', chaired and minuted by members, enables LD members to voice their experience, aims and concerns relating to Blue Apple.

Future plans

In accordance with our Business Plan and the objectives set out in the Blue Apple Theatre Community Project, the Trustees plan to maintain and consolidate Blue Apple Theatre's core activities and, as funds allow, to continue to extend these to enable more people with learning disabilities to benefit from Blue Apple Theatre activities, and to engage with wider audiences.

Notes forming part of the financial statements for the year ended 31 March 2018

1. Accounting policies

(a) Basis of preparation

The financial statements have been prepared under the historical cost convention, and in accordance with the Statement of Recommended Practice (SORP), "Accounting and Reporting by Charities" published in 2015, the Financial Reporting Standard for Smaller Entities, and applicable accounting standards. The comparative amounts shown are for the year ended 31 March 2016.

(b) Company status

The charity is a company limited by guarantee. The members of the company are the trustees named on page 2. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £10 per member of the charity.

(c) Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the trustees in furtherance of the general objectives of the charity, and which have not been designated for other purposes.

Designated funds comprise unrestricted funds that have been set aside by the trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes. The cost of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

(d) Income

All income is included in the SOFA when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy. No amounts are included in the financial statements for services donated by volunteers.

(e) Expenditure

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category.

Management and administration costs are those incurred in connection with administration of the charity and compliance with constitutional and statutory requirements.

(f) Tangible fixed assets and depreciation

Tangible fixed assets costing more than £500 are capitalised and included at cost, including any incidental expenses of acquisition.

Depreciation is provided on all tangible fixed assets at rates calculated to write off the cost on a straight line basis over their expected useful economic lives as follows:

Theatre and office equipment over 4 years

Computer equipment over 4 years

(g) Operating leases

Rentals applicable to operating leases are charged to the SOFA over the period in which the cost is incurred.

Examination Statement
