Report of the Directors for the year ended 31st March, 2018

The Directors, who are also trustees, submit their report together with the financial Statements for the year ended 31st March 2018.

Results

The results for the year and the financial position of the company ("MDSUK") are shown in the annexed financial statements. The company is a non-profit distributing company limited by guarantee and is a registered charity (No, 1145214).

The financial statements have been prepared in accordance with the accounting policies and comply with the Charity's governing document, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard (FRS 102). The Charity has taken advantage of the exemption in Financial Reporting Standards from producing a cash flow statement on the grounds that it is entitled to the exemption for smaller companies available in Section 38 of the Companies Act 2006.

Chair's Report

The past year has been one of change, with the Charity seeking to extend its ability to help those suffering from MDS. Some of the existing members of the Management Board stepped down and the Charity are still in the process of seeking new members with the necessary skills to help in the development of the Charity. The way in which the Board is established, with the majority of members being those suffering from MDS, means that this process is not easy as many willing people are unable to contribute due to their illness. In time, it is hoped to fill all those specific roles within the Board that were previously identified.

The Head of Fundraising is currently researching a Fundraising Strategy which, when devised and adopted, will enable us to call on a wider variety of funding sources to support our aims and objectives. In a similar way, the Board have taken the decision to fund research for the first time, in addition to our on-going involvement in several areas of research. To enable this to be done in a structured and financially viable manner, a Research Strategy is in the process of being formulated with the assistance of haematology clinicians.

A legal Constitution has been written by the current Chair and approved by the Trustees and Management Board. Our aims and objectives have been amended and updated in the Constitution to reflect the decisions made by the Trustees and Management Board. In addition, the new Code of Conduct has been incorporated into the Constitution so that the document can be utilised as a standard reference document for the Charity. It is intended to take advantage of the opportunity to change the structure of the Charity to a Charitable Incorporated Organisation (CIO) in 2018. As soon as that takes place, the new Constitution will be formally adopted.

Caitlin Limmer has been appointed a new Patron for the Charity in recognition of her long-standing work in fundraising for MDS. She is a tireless worker and her help in spreading knowledge and understanding of MDS is greatly appreciated. MDS UK is continually grateful for

the support, enthusiasm and dedication it receives from all its donors, including the many private individuals, in addition to the pharmaceutical companies Celgene, Novartis Oncology and Janssen. Without the support of all those people and organisations, MDS UK would be unable to continue in its support of those suffering from MDS.

I would finally like to thank the Trustees and Members of the Management Board, who freely give their time and energy, and the Chief Executive Officer and her staff for their work and dedication

Our purposes and activities

The Charity's principal activities during the year under review relate to the support of individuals suffering Myelodysplastic Syndrome ("MDS"), which is a rare blood cancer. The activities were previously carried on by a trust with the same name and were taken over by the company with effect from 1st April 2012.

The objects of the Charity are:

- (i) To relieve the sickness and preserve, promote and protect the health of sufferers of MDS in the United Kingdom through the provision of support, education and practical advice.
- (ii) To advance the education of the general public in the United Kingdom in all areas in relation to MDS.
- (iii) To promote and support scientific research into MDS and its treatment together with the care of MDS sufferers and those disposed to the development of MDS.

Achievements and performance

The Charity's main activities are the operation and maintenance of a website, the telephone helpline and e-mail support, regional and national group meetings as well as the Facebook page. MDS (UK) has continued to increase its advocacy work at both UK and European levels where it affects UK issues. All of these activities provide support and information to MDS sufferers and their families.

Achievements this year included: -

The MDS UK Patient Survey has completed recruitment and achieved the largest

Scientifically representative sample of MDS patients in the UK and data is being analysed. Preliminary data has been published within MDS UK platforms – with outside publications being worked on.

- MDS UK promoted the fifth "MDS World Awareness Day' in conjunction with international colleagues and the MDS Alliance. This event will continue to be marked in the future.
- The charity conducted 3 national patient forum events this year, as opposed to a single national event in London.
- The charity revised their membership procedure in light of the GDPR changes.
- The Charity has promoted it's services and activities at multiple educational events throughout the UK, to groups of patients, nurses, physicians and pharma industry, through presentations and information stands.
- The MDS Patient Handbook (in collaboration with Leukaemia CARE and Bloodwise) has started the 2nd Revision process.
- MDS UK continued to be actively involved at European and international level through
 organisations such as EMA (European Medicines Agency) ESH (European School of
 Haematology), EHA (European Haematology Association) and ASH (American Society of
 Haematology), together with other MDS overseas groups. Alliance activities have again
 increased, with MDS UK being a founder member and one of the core members due to
 experience and success in the UK. The formal co-operation will be of particular
 importance with regard to EMA licensing of new drugs.
- MDS UK, via the MDS Alliance, has continued to work on the new European project on rare diseases called ERN's (European Reference Networks). The ERN dedicated to rare haematology conditions is called EuroBloodNet and the main purpose is to share best practice across Europe as well as facilitate cross-border healthcare and a wider access to clinical trials.

Also via MDS Alliance, MDS UK has become an active contributor to the scientific public-private partnership project, HARMONY, which represents a unique data-sharing collaboration across European research centres which aims to provide answers to specific unresolved research queries.

These european activities were presented by MDS UK at an oral session at the British Society of Haematology national congress, for the benefit of the UK based haematologist audience.

- The specific Clinical Trial information service continues to be popular and accessed by patients, but also haematologists, and the Principal Investigators who can struggle to recruit rare sub-types of patients.
- In terms of clinical trials, MDS UK has accepted to be co-applicants in two university hospital led trials, providing the patient perspective at all levels of the project. A third clinical trial project for Watch&Wait patients was started – and work is on going.
- MDS UK was involved in the development of an innovative Patient Reported Outcome tool to capture real-time data of patients. This tool has now been presented at major haematology congresses.
- MDS UK presented data at the national expert's UK MDS Forum in collaboration with expert MDS nurses.
- MD SUK started work on a further innovative digital project in cooperation with company developing a new tool capturing Quality of Life information.

Financial Review

Total income for the year of £204,145 was 83% higher than the previous year (2016/17 - £111,689) as a result of a generous legacy of £74,867 received in the year. Donations of £89,435 were 26% higher compared to last year whilst grants remained at the same level as last year. Grants were received from the pharmaceutical companies, Celgene and Janssen. The grants are unrestricted and comply with the Code of Practice for the UK Pharmaceutical Industry.

Total expenditure for the year of £143,997 was £70,078 more than last year. This was largely due to appointment of a full time project worker seconded from Kings College London, development of our donor database, publication of the newsletter and issue of Patient Handbooks

The surplus for the year of £60,148 has been added to unrestricted reserves that now amount to £375,891. The receipt of the legacy and their confidence in the level of reserves has enabled the Directors to pursue the third objective of the Charity, 'to promote and support scientific research into MDS and its treatment'. The Board has designated £100,000 of the reserves to support this objective in 2018/19.

Reserves Policy and going concern

Reserves are needed to bridge the gap between the spending and receiving of income and to support the activities of the Charity in the event of a significant reduction in income. From time to time the directors review the required level of reserves. As referred to above, £100,000 of the reserves has been designated to support scientific research into MDS and its treatment. The remaining reserves are considered adequate to maintain the activities of the Charity.

The directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt about the ability of the Charity to continue as a going concern and have a reasonable expectation that the Charity has adequate resources to continue in operational existence for the foreseeable future.

Structure, Governance and Management

Governing document

The entity is governed by its Memorandum and Articles of Association dated 21st October 2011. The charity is a company limited by guarantee. The members of the company who are directors are listed above. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £10 per member of the charity

Appointment of Directors

Existing directors propose new directors. The number of directors shall not be less than three and is not subject to any maximum.

Organisation

The board of directors administers the charity and normally meets quarterly. There is also a management committee which meets quarterly. A Chief Executive is appointed by the directors to manage the operations of the charity. To facilitate effective operations, the Chief Executive has delegated authority, within terms of delegation approved by the directors, for operational matters including finance and employment.

Risk Management

The directors have assessed the risks to which the charity is exposed and are satisfied that systems and procedures are in place to mitigate, where possible, those risks identified.

The principal risk is that the level of activities undertaken by the charity is dependent on the level of funding received.

Directors' responsibilities in relation to the financial statements

The directors (who are also trustees for the purposes of charity law) are responsible for preparing the Directors' Report and the financial statements in accordance with applicable law and regulations.

Company law requires the directors to prepare the financial statements for each financial year. The financial statements have been prepared in accordance with the accounting policies set out in notes to the accounts and comply with the charity's governing document, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard (FRS 102) for Smaller Entities.

Under company law the directors must not approve the financial statements unless they give a true and fair view of the state of affairs of the company and of the incoming resources and outgoing resources of the company for that period

1) Accounting policies

Basis of preparation

The Charity is a company limited by guarantee and has no share capital.

The financial statements were prepared in accordance with the accounting policies set out in the notes to the accounts and comply with with the charity's governing document, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published on 16 July 2014.

Adoption of FRS 102 has not required any changes to the accounting policies and has not affected the reported financial position or financial performance.

Fund accounting

All funds are unrestricted and are available for use at the discretion of the directors in furtherance of the general objectives of the Charity. The Board has designated a proportion of the fund to support research related to MDS.

Incoming resources

Income represents income attributable to the activities of the Charity when the Charity becomes entitled to the donation or similar income and any conditions for receipt are met, and the directors are reasonably certain that they will receive it and the value can be reliably measured.

Resources expended

Liabilities are recognised as soon as there is a legal or constructive obligation committing the Charity to the expenditure. All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Irrecoverable VAT is reported as part of the expenditure to which it relates.

Charitable activities

Costs of charitable activities includes expenditure incurred in the delivery of activities and services for beneficiaries and all the support costs as shown in note 9.

Governance costs

Governance costs comprise all costs involving public accountability of the Charity and its compliance with regulation and good practice. These costs include legal and professional fees and the costs of the AGM and governance meetings

Corporation Tax

The Charity is considered to meet the definition of a charitable company for UK Corporation Tax purposes. Accordingly, the Charity is exempt from tax on income and gains falling within section 505 of the Taxes Act 1988 or section 252 of the Taxation of Chargeable Gains Act 1992 as any surplus or gains are applied for charitable purposes.

Cash flow Statement

Due to its size, the charity is not required to present a Cash flow Statement under the Financial Reporting standards.
