Administrative details.

- 1. The name of the charity and its charity number is shown above. The registered address is shown as Boughcliff House, Tidenham Chase, Gloucestershire NP16 7JN.
- The Trustees for the financial year ending 31 March 2018 were Anne Deidre Martin, Brian Ion Duerden, Peter Gilchrist, Sarah-Jane Gilchrist, Stephen John Hall, Roger Martin, David Owen Treharne and Iain Anderson Gardiner.

Structure, governance and management.

- 1. The charity is governed by a written unincorporated constitution adopted on 20 May 2014, approved by the Charity Commission, and managed by the Trustees who are appointed at the AGM and subject to re-election at the end of every three years on a rotating basis. The Trustees all undertake appropriate training in their duties and self awareness of the requirements to comply with all relevant charity law and good practice. The Trustees meet about nine times in each year when they discuss and decide matters of business to further the objects of the charity.
- 2. The objects of the charity are to help conserve, restore, maintain and upkeep the buildings, grounds, fabric, furnishings and fittings of the Church of St Mary and St Peter, Tidenham for the benefit of the community by the provision of funding and other activities and fostering public interest in the building of the church, its fabric and its grounds.

Financial review.

1. There is no general reserve policy decided by the Trustees. The balance sheet for the year ending 31 March 2018 shows net current assets of £86,380 with the capital account showing the same amount, including the value of the developed car park of £70,349. The land was purchased by the charity during July 2015 for £9000 and £61,349 has been spent by the Association during 2016-2018 in developing the land

into a functioning car park for the use of the church and associated activities. There is a deficit of £-4,477 shown in the income and expenditure accounts for the year to 31 March 2018. No asset is held by the Trustees for the benefit of any other charitable fund.

Public benefit statement.

 Throughout the period of the financial year the Trustees have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission when exercising their powers or duties.

Activities of the charity during the financial year.

1. The Trustees have continued to arrange fund raising events, such as a Burns night dinner, a quiz night, open gardens and Christmas tree and Flower Festivals and other fundraising activities and successfully raised funds by these means and by receipt of generous donations. Grant aid, gift aid and subscriptions resulted in a total income for the year of £41,755. As a result, following the investigations and planning approval, the Trustees were able to progress significantly the development of the car park which became useable for the benefit of church activities during the year. The car park project is ongoing, with completion expected in 2018-2019. In due course, ownership of the car park will be transferred to the PCC.
