Treasurer Report 2018

This report is for the year ending 31st March 2018

Our total income for the year is £ 30,044.24 which is made up of Filey and Bridlington Units combined.

- Filey income £ 26138.41 and Bridlington income £ 3905.83
- Filey income is down this year by £ 19797.65 due to receiving less donations.
- Bridlington income is also down by £ 250.68.
- Our total expenditure for the year Filey and Bridlington combined is £ 39732.67.
- Filey expenditure is £ 32799.61 which is down from last year by £ 2820.91.
- Bridlington expenditure is £ 6933.06 which is up by £ 3608.78.
- Cadet contributions for Filey totalled £ 6560.00 which is up by £ 263.00
- Cadet contributions for Bridlington totalled £ 939.00 which is up by £ 105.00 on the previous year
- Donations for Filey and bridlington are £ 4414.63 which is £ 19774.32 down on the previous year
- Fundraising for Filey is £ 6323.03 which is up by £ 96.05 and bridlington for the year is £ 79.00 which is down by £ 314.38.

The basic running cost for the Filey unit which is made up of Heat, light and water @ £ 3451.22 and Insurance costs @ £ 2853.75 is £ 525.41 a month which is up on the previous year by £ 95.51 a month.

* This years closing balances on the unit accounts are £ 6152.63 and £ 6691.36 giving a total of £ 12843.99.
