The Trustees present their report and financial statements for the year ended 30 April 2018. The Trustees have adopted the provisions of the Statement of Practice (SORP) "Accounting and Reporting by Charities" issued in March 2005 in preparing the annual report and financial statements of the charity.

Governing Document

The Charity is operated under the rules of its Articles of Memorandum (AOM) dated 12 August 2013. Overall Management of the charity is the responsibility of the Trustees who are elected and co-opted under the terms of the (AOM). Day to day Project activity is managed and carried out by volunteers.

Aims and Objectives

Its objectives are; "The promotion of community participation in healthy recreation for the benefit of the inhabitants of Sefton and the surrounding area, by the provision of facilities for playing basketball and to provide facilities in the interests of social welfare for recreation and leisure time occupation, with the objective of improving the condition of life for the residents of Sefton and the surrounding area."

Activities

The principal activities of the charity include;

to play basketball and develop a healthy and ethical lifestyle and help people achieve their full potential, raise standards of health and well being, develop self confidence, team working, communication skills and performance.

Summary of the main achievements during the year.

On the basketball playing side we had 2 National League Teams namely a Men,s team and a u16 boys team. We had 20 young women take part in a taster session and that led to commitment to train and participate in a team. We placed them in the Manchester Amatuer Basketball League so they could compete enabling them to develop their skills. This group were supported with travel costs by the Eleanor Rathbone Foundation. The social Inclusion side of this group grew and grew. We are so proud that these women found a pastime that enabled them to develop new skills, make friends and increase their self esteem. We also ran community sessions throughout the year giving access to facilities and coaching for boys and girls aged 8yrs and upwards.

Walking Basketball sessions has helped again with the physical/mental health and giving again social inclusion to very vulnerable people in society.

Off the court has been recognition of the work we do in the community.

The club has been working hard to fundraise with various events and activities, and providing support in terms of "manpower" for many junior basketball sessions.

We have had opportunities for people to take NGB qualifications in Coaching, and Officiating. This has enabled them to earn income and provide valuable resources to the sport.

Sefton Stars has many volunteers that continue to invest their time in a variety of roles within the club.

The committee meets on a quarterly basis to co-ordinate and steer the club and allocate tasks for events and fundraising comprising of parents and players, they continue to work hard to help sustain the club.

This year we have based most activities out of Litherland High School however spiralling costs have led us to look at sharing facilities and supporting a local basketball group in Liverpool for next year.

Structure, Governance and Management

Governing Document

Sefton Stars Basketball Club is a company limited by guarantee governed by its Memorandum and Articles of Association dated 26th November 2012. It is registered with the Charity Commission. Anyone over the age of 18 can become a member of the Company and there are currently - members (- in 2017), each of whom agrees to contribute £10 in the event of the charity winding up.

Appointment of trustees

As set out in the Articles of Association the trustees are elected by members of the charitable company attending the Annual General Meeting. The longest service one third of trustees retires each year and is able to offer themselves for re-election.

Organisation

The board of trustees administers the charity.

Related parties and co-operation with other organisations

None of our trustees receive remuneration or other benefit from their work with the charity. Any connection between a trustee of the charity and any client or supplier is disclosed to the full board of trustees in the same way as any other contractural relationship with a related party. In the current year no such related party transactions were reported.

Risk Management

The trustees have a risk management strategy which comprises:

- * an annual review of the principal risks and uncertainties that the charity faces;
- * the establishment of policies, systems and procedures to mitigate those risks identified in the annual review; and
- * the implementation of procedures designed to minimise or manage any potential impact on the charity should those risks materialise.

This work has identified that financial sustainability is the major financial risk for the charity. A key element in the management of financial risk is a regular review of available liquid funds to settle debts as they fall due to ensure sufficient working capital by the charity.

Trustees' Responsibilities

The trustees, who are also the directors of Sefton Stars Basketball Club for the purpose of company law, are responsible for preparing the trustees' report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the charity trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application or resources, including the income and expenditure, of the charitable company for that year. in preparing the financial statements, the trustees are required to:

- 1) select suitable accounting policies and then apply them consistently;
- 2) observe the methods and principles on the Charities SORP;
- 3) make judgements and estimates that are reasonable and prudent;
- 4) state whether applicable UK accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- 5) prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will contionue in business.

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Comapnies Act 2006. They are also responsible for the safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud or other irregularities.

The trustees are responsible for the maintenance and integrity of the corporate and financial information included on the charitable company's website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

1 Accounting Policies

1a Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), and the Companies Act 2006 and the UK Generally Accepted Accounting Practice as it applies from 1 January 2015.

Sefton Stars Basketball Club meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

The accounts have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a true and fair view. This departure has involved following the Statement of Recommended Practice for Charities applying FRS102 rather than the version of the Statement of Recommended Practice which is referred to in the Regulations but which has since been withdrawn.

The functional currency used by Sefton Stars Basketball Club is the £ Sterling.

1b. Preparation of the accounts on a going concern basis

The charity has unrestricted reserves equivalent to approximately two months' expenditure. Free reserves, after deducting the net book value of fund assets of £6,750 were £978. The directors consider the charity to be a going concern and have prepared the accounts on the going concern basis.

1c. Income

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Income from government and other grants, whether 'capital' grants or 'revenue' grants, is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the bank.

1 Accounting Policies (cont.)

1d. Expenditure

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably. Expenditure is classified under the following activity headings:

Provision of basketball facilities

Irrecoverable VAT is charged as a cost against the activity for which the expenditure was incurred.

1e. Funds Accounting

All income and expenditure together with gains and losses are allocated to a specific charitable fund.

Unrestricted funds are available to spend on activities that further any of the purposes of the charity.

1 Accounting Policies (cont.)

1f. Tangible fixed assets and depreciation

Tangible assets are stated at cost (or deemed cost) less accumulated depreciation and accumulated impairment losses. cost includes the original purchase price, costs directly attributable to bringing the asset into its working condition for its intended use, dismantling and restoration costs and borrowing costs capitalised.

Plant and machinery and fixtures, fitting, tools, and equipment are stated at cost less accumulated depreciation and accumulated impairment losses.

Depreciation is provided at the following annual rates in order to write each asset off over its anticipated useful economic life. A full year's depreciation charge is charged in the year of acquisition and no depreciation is charged in the year of disposal.

Motor vehicles

25% pa on a reducing balance basis

Equipment

25% pa on a reducing balance basis

Subsequent costs are included in the assets carrying amount or recognised as a separate asset, as appropriate, only when it is probable that economic benefits associated with the item will flow to the charitable company and the cost can be measured reliably.

Repairs, maintenance and minor inspection costs are expensed as incurred.

Tangible assets are dereognised on disposal or when no future economic benefits are expected. On disposal, the difference betwee the net disposal proceeds and the carrying amount is recognised in the Statement of Financial Activities.

1g. Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

1h. Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.
