Annual Return to the Charity Commission 2018 Bishop's Waltham Society 1170683

REPORT

Membership

At the beginning of 2017 the Trustees set a target to rebuild membership of the Society to 300 members and by January 2018 we had 307 members. We then chose to take the more difficult approach to the General Data Protection Regulation by asking all members to positively sign up for membership. We were aware that this would lose us some members. However, we are pleased to say that at the beginning of 2019 our membership numbers are now more than 340. As always we would ask all existing members to continue to promote membership of the Society to friends and acquaintances.

Members' Meetings

We've had another successful programme of monthly meetings this year with an average attendance of around 60-70 people. Some of the best attended were "Pew Rage", "Buster Crabb - the real story" and "Harlots, Dung and Glory - the history of Portsmouth". We were delighted that more than 60 attended our midsummer evening at the Museum in the Palace grounds, and that 70 members and guests joined the Christmas Party! A similarly full programme is planned for 2019 - details are provided in the current newsletter and are also printed on a small card for wider circulation.

Newsletters

The Society published three newsletters during the year: Winter (with an insert about our views on plans to demolish Abbey Mill), Spring and Autumn. The Summer issue was delayed until the autumn because attention was devoted to the Society's new book *We Will Remember Them* which had to be published before 11th November - the 100th anniversary of the Armistice (see more below).

Planning

During 2018 the Society's Planning Committee has again been very active. Letters with comments and/or objections have been submitted on proposals for: Abbey Mill, Albany Farm, Coppice Hill Phase 2, Locks Farm Standby Generator, Malt Lane and Postmead (both proposals). They are all detailed responses that seek to be constructive wherever possible. The committee continues to argue that developers should abide by the Bishop's Waltham Local Plan and Design Statement, as well as wider planning rules and guidance. We would again like to thank Pauline Mousley who, whilst not a trustee, makes a continuing contribution to the work of the Planning committee.

Finances and Grants

These are covered in the Treasurer's report, but we are pleased that we were able to increase the amount of grant aid this year.

Publishing

A great deal of effort went into the publication of our new book *We Will Remember Them*. The book tells the stories of the 61 servicemen from Bishop's Waltham who died in the Great War. It is based on very detailed research by Peter Ridley and we are grateful to him for allowing us to publish it in book form. We would also like to thank Alan Inder, whose idea started the whole project. The initial print run of 300 copies sold out within a month. With Christmas demand high, we printed a further 150 copies and a good number of these have already been sold too. We have covered all our costs and will be sending all surplus revenues to the Royal British Legion in due course.

It is planned to continue to publish new informative books, relevant to Bishop's Waltham and its residents, in the coming year(s). The next project is likely to be a book on the history of Bishop's

Waltham High Street. A number of other, shorter books/booklets are under consideration. Revenues from our publications is a significant factor in our ability to fund our wider activities. **Website**

A lot of work has been going on to overhaul our website and it should be launched by the time of the AGM. It is designed to continue attracting new members and to be an easy place for current members to keep in touch with what we are doing. It can be found at www.bishopswalthamsociety.org.uk.

Trustees
