Other areas of governance are regulated by the Constitution and we are working towards new set of policies to help the charity grow sustainably. These other policies include finance and reimbursement policies, fundraising policy and a recruitment policy.

Mosaic LGBT Youth Centre is a member of the LGBT Consortium (the national membership organisation supporting LGBT groups), UK Youth (a national organisation supporting the delivery of high quality youth work), London Youth (a London membership organisation supporting delivery of quality youth work in the region), ILGA-Europe (a charity advocating for human rights of LGBTI people) and IGLYO (a youth development and leadership network for European LGBTQI youth activists). Being members of these organisations allows us to work in partnership with other complementary organisations and be reactive to new ways of supporting LGBT young people, address emerging issues, as well as being alert to legal requirements.

Mosaic LGBT Youth Centre worked closely with a number of partners including West Euston Partnership, Old Diorama Arts Centre, Pride in London, School for Social Entrepreneurs, Wellcome Collection, Camden Collective, Mind in Harrow, Young Harrow Foundation, Jack Petchey's Foundation all of whom allowed us to deliver value and high quality services to our young persons.

Over the last twelve months a significant growth of the Board of Trustees has occurred. Recruitment of trustees has focused on building a breadth a strong team of individuals who bring a wealth of, practical knowledge and experience onto the Board in order to strengthen the charity.

Mosaic LGBT Youth Centre's structure is very flat and focuses on service delivery and sustainability. Lukasz Konieczka is our Director of Services who was appointed to this position in September 2017 while we welcomed Jonathan Buckerfield, Andrew Fordham, Glory Tan and Nick Tucker onto the Board, bringing specialisms of fundraising, communications, risk, data and risk management, and finance.

As a Board of Trustees, we recognise that we are still a young charity, and as such we need to focus on establishing a solid foundation on which to grow. Risk is managed across the board, but also addressed specifically at the Finance and Risk Subcommittee. The nature of the charity's work is that we are supporting often vulnerable LGBT+ young persons and there is an inherent risk in this. We manage safeguarding through set processes and procedures, including appropriate training, having dedicated safeguarding leads and discussing concerns at Frontline Subcommittee meetings.

## Objectives and activities

To relieve the mental and emotional distress suffered by young persons within Greater London and the surrounding area, who are lesbian, gay, bisexual, and transgender (LGBT) by the provision of advice, education and support with the objectives of increasing self-esteem and positive identity amongst said persons.

To promote equality, diversity and community cohesion as well as to eliminate discrimination to lesbian, gay, bisexual, and transgender (LGBT) persons by advancing education and raising awareness of issues affecting said persons.

Mosaic LGBT Youth Centre aim is to support, educate and inspire LGBT+ young persons of London.

In planning our activities for the year, we kept in mind the Charity Commission's guidance on public benefit at our Board Meetings as well as the best interest of our members and their needs.

The Youth Club provided a safe, inclusive space for over 160 LGBT+ young persons to develop a sense of belonging, community and self while developing crucial skills, knowledge and awareness that will help them to be a proud, more cohesive, kind LGBT community of the future.

We delivered a mentoring programme where our trained volunteers provided practical and emotional support and guidance to over 40 young persons in need offering a kind, affirming and attentive ear so they can talk about their difficulties in an open fashion.

Our inclusion and outreach programme engaged with educational establishments to raise awareness of sexuality and gender diversity amongst 375 staff and nearly 1,000 students aiming to reduce homophobic, biphobic and transphobic attitudes in schools and colleges.

Mosaic LGBT Youth Centre also delivered a residential programme Summer Camp in August where LGBT+ young persons spent time in wonderful surroundings of rural Wales in an LGBT+ affirming environment where they explored their identity, built their selfesteem and learned how to work together as a community. This year we also provided additional holiday activities in October with three cultural outings and in February half-term we organised a Winter Retreat in Brighton that offered young persons opportunity to learn more about wellbeing and managing stress as well as took part in great outdoor leisure activities and learned to cook. Feedback from the residential was overwhelmingly positive.

We also organised three major events Pride Prom; Homoween; and our Annual Winter Showcase. These events provided our young persons the chance to celebrate themselves and have fun without the fear of being judged or ridiculed for who they are. Pride Prom attracted 79 young persons and Homoween attracted 92 young persons. The Annual Showcase was attended by 26 young persons and over 38 members of their family and friends as well as partner organisations and funders.

The Culture Club grew from strength to strength this year, with trips to "Everybody's Talking about Jamie", "Kinky Boots", a private screening of "A Fantastic Woman", and Tate Britain's "Queer and Now" festival marking the anniversary of the partial legalisation of homosexuality in 1967 amongst many others.

Importantly, Culture Club allowed our young persons to see positive role models on stage and screen that they can relate to, including meeting artist Skin, lead singer of Skunk Anansie, which was a truly inspiring event. This year we offered our members free or heavily subsidised trips to 16 cultural events intensifying over half-terms and slowing down in run up to exams.

A great contribution was made by our volunteers. We are grateful for the many hours volunteers have spent supporting, educating and inspiring our young persons. Without this valuable contribution of time, energy, expertise and commitment, we would not have been able to achieve so much.

We managed to build our unrestricted income and we are reporting a surplus, meaning this will improve our sustainability whilst making us a more attractive partner for future funders and clients.

We are pleased to report that as an organisation that started with almost no funding, over the year we managed to secure contract to deliver our services some of which extend into the following financial year.

Being members of LGBT Consortium allowed us to be part of an alliance with fellow youth organisations in order to secure a Government Equalities Office contract to deliver work with schools combating homophobic, biphobic and transphobic bullying.

'An evening with ... Skin' took place on the 21st Feb 2018 and it allowed our young persons to be closer to a great role model, activist, singer and song writer. It was hugely positive experience as our members found it inspirational and insightful.

We were in strong enough position to enter into a contract agreement with Young Lambeth Coop as well as Lambeth CCG to sliver the work in that region to young LGBT+ young persons.

We have implemented a Reserves Policy that outlines our position on reserves. We review reserves levels on a quarterly basis at the Risk, Strategy and Finance Subcommittee. If reserve levels fall below an average of three months operating costs, a recovery plan will be prepared by the Risk, Strategy and Finance Subcommittee to presented to the Board. If the reserves exceeds an average of 11 months operating costs, the Board, in coordination with the subcommittees will plan how the surplus can be used to in line with our charitable objects.

Our main source of funding this year has been grants and trade funding. Grants offered us opportunity to grow as an organisation and trade allowed us to be more sustainable.

Majority of the trade income came from delivery of the programmes and professionals training to schools. In particular, we would like to thank:

- LGBT Consortium who facilitated the alliance that secured Government Equalities Office Contract.
- Young Lambeth Coop who contracted us to extend our services to LGBT young persons of Lambeth.

#### And our funders:

- Global Fund for Children who paid the rent of the space in which we deliver services.
- John Lyon's Charity which funded our Summer Camp and Winter Retreat.
- London Catalyst which offered us funding towards core costs
- Deutsche Bank grant managed by London Community Foundation which contributed towards our core costs.

The income is applied to the costs above, with the main costs incurred being staff salaries, rental costs on the spaces we deliver services from. Mosaic LGBT Youth Centre's efficient use of resources alongside financial control means that we end the year with a Reserves figure aligned with expectation to manage the charity's risks as set out in the Reserves policy.
