- Many new members joined the volunteer groups which are generically referred to as "Church Workers" in our midst.

- More welfare package given to members in acute need in form of litter monthly allowance.

- More volunteers underwent trainings which included membership and workers training.
- Successful women breakfast meeting was held with tens of women on attendance for teachings, fellowship and interactive sessions.

- Special giving towards our Building Fund continued with the aim of us getting our own Church building.
- It was a great improvement on the previous year in running with the vision and accompanying the mission realisation for the church.
- Diadem Church London had a colourful tenth year anniversary from the 30th of November to the 2nd of December with many guests including guest ministers in attendance with our regular members.
- Annual Feast of Ingathering (FOI) was inaugurated to be held over the last weekend of November yearly in furtherance to the pursuit of the ministry.
- Diadem Church Nigeria got registered with the Nigerian government and bank account opened in the name of the Church there for operations.

DONATIONS

All donations are the voluntary regular giving of the Church member through tithes, offerings and special giving.

VOLOUNTEERS:

The church has more people volunteering to help out in administrative work.

ADMINISTRATION:

The administrative and spiritual oversight of the Church is handled by Dr Akinyemi Olayinka Akintunde who remains the founder and chairman of the Board.
