Introduction

The Charity's objects ("the objects") are to promote the welfare of persons suffering from senile dementia and other forms of confusional states by the provision of advice in the care of such persons and by the provision of respite care in the borough of Spelthorne.

Chairman's Statement

While the number of places we fill each week each week has probably reached its upper limit of around 240. You will see from the accounts we ended the year with a deficit of £10,790. This was caused by a downward trend in revenue from Surrey County Council, which we believe is a result of more stringent means testing. We started to notice this effect in the first quarter of the financial year and undertook a number of actions to redress the balance.

A number of promotional activities were initiated to achieve an improved balance of private versus public funded guests in our Day Centres. We have always taken a cautious approach with our cost model and monitoring the check and balances to keep financial stability within the charity. As a result we are not dissatisfied with the balance sheet at the end of the year and look forward to a more stabilised financial outlook in the coming year.

An ongoing exercise over the past year has been to review and update all our policies and procedures to ensure they are current and effective. This has also given us the opportunity to consolidate and publish them for all to reinforce our working culture and ethics.

One of the main focusses of the new year will be to find new trustees and introduce new ideas and thinking to take the charity forward into the future.
