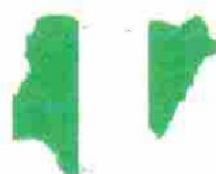

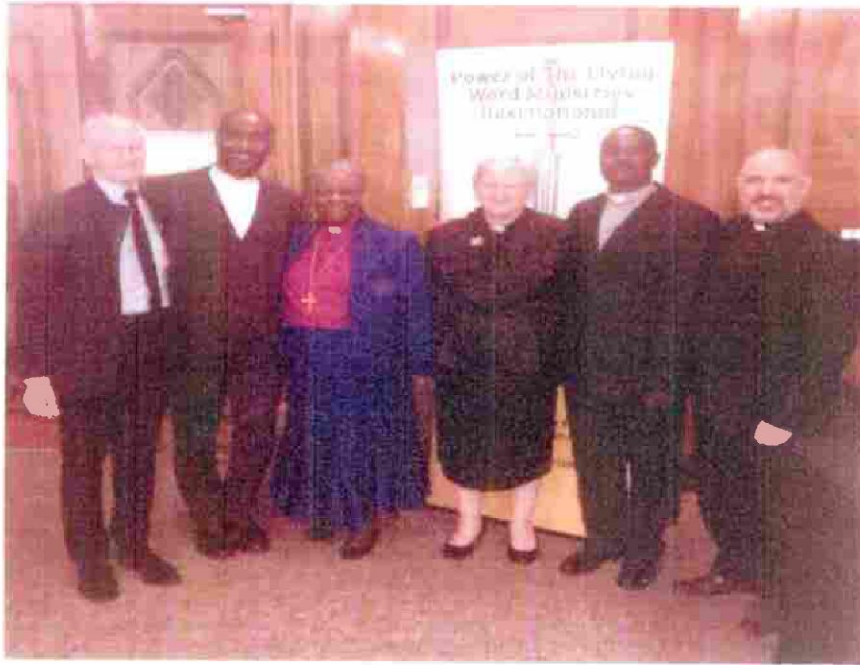
This annual report outlines and celebrates some of our mission work in 2017/18 here in the UK and with our partner churches overseas.

We heard that the definition of true redemption is the ability to accomplish what God has planned for you to do! Are you truly redeemed? Draw on God's anointing in order to save lives and mature the Church with other 5 fold ministers. Our Apostle focused on the purpose of TRAN to equip potential 5 fold ministers from our covering Churches and send them out as teams of 5 fold to go accomplish God's vision of ensuring true Redemption.

August 2017 – VBS in our Covering Churches in Kenya, run by a team trained by us over the years. We donated money for the children to have a hot lunch.

VBS is now well established in Porur Evangelical Church in India. The Vision has been caught by young leaders who are now enjoying leading the Children in activities.



Creative Arts

This year has been a year of growth and direction for the anointed arts. We have grown in choreography and creative direction as each member of the dance ministry has been ministered to by the chosen songs personally, which has brought power and impact to the ministry of dance. When we have danced for the congregation many were ministered to because of this power. We have danced to songs by William Murphy and shekinah glory. We have had group choreography and solos alike.

I have also had the opportunity to paint during church service illustrating the word of God, enabling the word to be presented visually as well as by preaching. This was received well and has ministered to individuals in a personal way.
