Name

The name of the Charitable Incorporated Organisation (“the CIO”) is Puntland Progress Coalition.

National location of principal office

The CIO must have a principal office in England or Wales. The principal office of the CIO is in England.

Objects

The objects of the CIO are:

To advance in life and help young people particularly in Leicester, England and Africa by providing support and activities which develop their skills, capacities and capabilities to enable them to participate in society as mature and responsible individuals. To advance such purposes that are charitable under the laws of England and Wales for the public benefit in the Puntland region of Somalia and the Haud region of Ethiopia by in particular but not exclusively;

(a) Providing or assisting in the provision of education, training, and necessary support to enable individuals to generate a sustainable income and become self-sufficient **(b)** The relief and assistance of people who are victims of war or natural disaster or catastrophe by the provision of emergency aid, food, clothing and shelter **(c)** The advancement of animal welfare for the public benefit by the provision of programmes to increase access to veterinary care and treatment **(d)** The advancement of environmental protection and improvement by the provision of access to sustainable waste management and the provision of programmes to increase awareness on environmental conservation and biodiversity

Status of CIO during given period.

The CIO was largely engaged in planning during the period of 27/06/2017 to 26/06/2018 and did not have any financial activities. Therefore we temporarily halted opening a bank account. We have engaged in long term planning for our charity and reshuffled our trustee board. A board member has resigned and a new member has been appointed as well as a new chair. We are now pursuing small sized grants and donations for our initial projects and how to facilitate the reception of income.
