Trustees' Annual Report

Activity during 2018

Trustees

There has been no change to the trustee status this year The total number of trustees remains at 24 with representation from 16 Wallsend schools.

Sub21 project

- * The sub21 programme now in its 10th year continues to be able to support young people in the Wallsend area.
- * Thanks to Big Lottery Fund we have been able to continue to provide a range of activities this year which have included a photography course, cooking, drama and dance. over 100 young people have taken part in these activities.
- * Figures for youth disorder from Wallsend police for the year to date show a continuing decrease in youth disorder.
- * Working with the Ocean Youth Trust we have been able to fund overnight sailing trips down the river Tyne as part of a transition activity between Wallsend primary and secondary schools.
- * We continue to link up with the 'Street Games Doorstep Initiative' to run a Friday night football session on the 'All Weather' pitch at Howdon. This runs successfully with around 30 participants each week

Young in Wallsend Programme

Funded by the Big Lottery Fund this programme has delivered a range of activities using 9 local partnerships. Partners include Barnados/ YMCA/ Prometheus/ Family Gateway (new partners this year)/ Local Churches Local Schools/ St Pauls Community Centre/ NE Youth. Over 400 young people have benefited from these activities NE Youth have run workshops and training events for the partnership.

5 Play days ran in Howdon Park during the summer holidays as part of an action for play programme.

Support for Wallsend primary schools

Wafy has been able to continue to support local primary schools by funding a number of after school sessions, including a Drama group, homework clubs and a range of sporting activities

Mental Health programme

With funding from Children in Need we have been able to develop after school support programmes for early intervention mental health needs. Following the 3 primary school pilots 2 further pilots ran at Burnside and Churchill secondary schools. Following the feedback we have set up a mental Health support group facilitated by Wallsend Children's Community.

Tennis

The thriving community tennis programme continues to run with Wafy support at Churchill Community College tennis centre.

Successful Grants / Funding

4 successful grant applications this year included:

- * From Big Lottery Fund reaching Communities for youth work. This is the third year of a 3 year grant worth a total of £386 K and will be shared with 9 partners from the Wallsend Youth provision group. We have been successful in getting a further 3 years of funding from Big Lottery under the new partnership funding programme. This will start in Oct 2019 to allow a seamless transition for the Young in Wallsend programme.
- * From Street Games Doorstep sport to run Friday evening open football
- * From the John Lewis Foundation to support play initiatives in Wallsend

Meetings

The management committee comprising the headteachers of all Wallsend schools met on 5 occasions throughout the year.

A well attended annual general meeting was held in September to feed back on the WAfY organisational review produced by Newcastle University as part of the Big Lottery Fund funding. schools met on 5 occasions throughout the year.
