I'm pleased to report on another exciting year amongst the family work at TMC. The project continues to change and evolve as we seek to meet the current needs of the families in our church and the wider community. There is a busy schedule of regular activities across the age groups as well as many one off events through the year. These are led by our family workers supported by a committed band of volunteers. Details of these are included in the separate reports from the family workers themselves.

There have been changes to the team this year. Our thanks go to Karen Davies for all her wonderful work with the 0-7's and we wish her well with her next ventures. Following interviews in November we were pleased to appoint Deborah Bevan as the new family worker for 0-7 year olds who took up her post in January. She has continued many of the regular activities as well as bringing her own new ideas to the children's work.

The Family Work Project is mainly funded by the generous giving from the congregation along with some grants. Grants are usually awarded to support the initial launch of a project assuming in time the project will be funded locally. While we continue to seek grant funding fewer sources are now available to us meaning it is important to build up local giving. There are full family work accounts presented alongside this report and further details can be found in the TMC "Money Matters" leaflet. We are grateful to Jackie Palmer for her efficient work on the finances over many years. However, her commitments in other areas have increased and she is looking to pass on the treasurer's role. If you are interested in serving in this way please speak to Jackie or myself.

We continue to have links with the Catalyst Team. While the majority of their work is in the local schools, three Catalyst workers, Laura, Jack and Matt, run the Youth Club Impact at TMC on a Friday afternoon. Although numbers are small this meets a real need amongst these youngsters. They are supported each week by a volunteer from TMC.

Included with this report is data for the last three years for the various family work activities. While the value of the work is not measured by the attendance figures it gives a picture of the wide variety of activities run by the project and the number of families involved at each one. We regularly reflect on the current needs and the resources available hence the activities we offer have changed over the years. Our family workers are always coming up with new ideas for reaching out to children and their families.

We thank the team for their endless energy and enthusiasm for this work, for all the willing volunteers who give so much time to the family work and the generous giving of members of TMC. All play a key part in bringing the good news of Jesus to the families in our community. Thank you!

### Family Work – 0-7s

It is a great privilege to be working as part of the family work team here at TMC and share the love of Jesus with the very youngest children of the church whilst supporting the many children and families that attend the weekly groups.

Regular Events Include;

### **TMC Toddler & Parent Groups**

The Easter Extravaganza event ended the toddler spring term with all the toddler groups joining together for a morning of Easter crafts, singing and egg hunting and was enjoyed by all! Along with the usual toddler volunteers, we were joined by others so a 'thank you' to the many volunteers who played a part in helping to make this event a success.

A new toddler group opened at the start of this term and this has meant that 20 new families have now started at toddlers on a Friday afternoon. There are mostly babies under a year in age at this new group and this has provided the parents with a venue where they can meet and talk about their babies together. Due to the large number of under 1s attending, the group has had to adapt the session; making the baby area larger and investing in equipment for this age group that includes sensory toys and treasure baskets.

We continue to have many families coming along weekly to the other four toddler groups to play, sing, enjoy craft and meet friends. Toddlers provides a fantastic opportunity to develop relationships with non-church families within the area, to show them God's love through our words and actions and to invite them along to other church events. We are blessed with an invaluable team of very dedicated volunteers who run these groups, for whom we are very grateful. After many years of faithful service, Julie Baylis and Elya Taylor have decided to step down from the Monday afternoon toddler group and I am sure everyone will join me in offering them our sincere thanks for all they have done in supporting the many families that have attended this session over the years. This does however mean that we will need two new volunteers to take on this group plus someone to organise the refreshments for the Friday afternoon group. If you or anyone you know would be interested in joining the toddler team, please let me know!

A weekly summer toddlers group will be happening for the first time this year. The summer holidays can be a long and expensive time for families as most groups closing during the school holidays. Every Wednesday in August, the upper hall will therefore be open to toddler families to 'drop in' and enjoy playing with toys and crafts from 10.30 to 2.30.

### Noah's Ark Tots

This weekly bible based toddler group welcomes preschool children with their parents and carers, who come to enjoy a time of learning about God through singing, stories, craft, games and refreshments. This session is attended by around 20+ children a week with a mix of church and non-church families. This term we have been thanking God for our senses and have just started learning about 'God's Big Book'.

### Sunday S:CAPE 0 - 7

Since Easter, the S:CAPE group has been re-organised to allow children to be in smaller teaching groups that provide more age appropriate activities. Pre-school children now meet in the upper hall with play based activities, a bible story and craft. This group has about 20 children registered with weekly attendance of 12 - 15. Those children in reception and year 1 meet in the downstairs hall, joining in with singing with the KS2 group and then using the lounge for their teaching space. Numbers in this group are around 6 a week. Y2 children have joined with the KS2 group.

### Other S:CAPE events;

**Easter S:CAPE** – The annual Easter S:CAPE for R – Y6 children was held in March. A morning of craft, games, dancing, challenges and activities all themed around the Easter Story took place with 60+ children attending.

**S:CAPE & RE:ACT presentation** – The annual S:CAPE presentation will take place on Sunday 8<sup>th</sup> July with the theme of 'Who is Jesus?' Followed by picnic and games on the moor.

**S:CAPE Holiday Club** – Due to the dates of the school holidays, the summer club will run for four days this year from Wednesday 25<sup>th</sup> – Saturday 28<sup>th</sup> July. The theme this year will be 'Seaside Rock' with the story of Peter running through the four days. We are hoping to have lots of children attend

from the local schools and publicise this with families that attend the church groups. If you would like to be involved with this, please speak to Chris or myself, your time and skills will be much appreciated!

### **Messy Church**

Messy church continues to draw many local families who come along for our celebration, craft and the fellowship meal. It is especially exciting to see so many families enjoying listening to the Word of God in such an informal and fun environment. Thank you so much to all who do help at Messy, with craft, preparing food, setting up and clearing up, leading the celebration and praying for us. It is a huge team effort and wouldn't happen without our amazing team of volunteers.

### Safeguarding

Safeguarding continues to be a priority for the family work team. Due to new safeguarding guidelines for TMC and the GDPR update, safeguarding has been a key part of the family work. Many new steps have been put into place to protect the youngest in the church with a new registration form and signing in sheet for the under 5s groups and forms that comply with the new GDPR regulations.

Finally, a big THANK YOU to all the wonderful volunteers who help the out with our children's ministry in so many ways and without whom, these activities would not occur. May the Lord bless you as you serve the children and families in our area.

We always need more support and help, so please do let us know if you'd like to get involved... we'd love to hear from you.

### Family Work (7-11yrs) June 2018

# <u>Each one is special, accepted and loved</u> - 'And now I give you a new commandment: love one another. As I have loved you, so you must love one another. If you have love for one another, then everyone will know that you are my disciples.' John 13: 34-35</u>

The family work with children aged 7-11yrs aims to provide activities and events for all children. It caters for those that have no knowledge of Jesus, provides a next step of activities for those already taking part in events or clubs provided by TMC in their younger years and always aims to be accessible to anyone who comes along for the first time. The work also builds on relationships with whole families and focuses on continuity and progression in provision while also aiming to be dynamic, responsive to needs and fresh. We continue to provide many events and activities for children while looking for new ways to take them forward in order to build further relationships with the families that we meet and in so doing to seek opportunities to share the Gospel. Alongside outreach activities, we continue to teach and encourage discipleship of the children within TMC as they grow in their faith and take their next steps.

<u>Sunday S:CAPE Children's Club</u> is a great time of fun, worship, prayer, teaching and discipleship that takes place during the 10:45 service. Between 20 and 40 under 11yr old children attend one of the Sunday S:CAPE sessions each week. A restructuring of our Sunday morning children's clubs took place at Easter which means that we now better cater for the various age groups.

**Trailblazers Youth Club** is a time when the children hear the word of God each week within a traditional youth club. We currently have 40 members with between 20 and 30 children attending each week. The summer term offers more opportunities to engage with families through events such as outdoor games nights and BBQs which continue to be really successful. Please pray for opportunities to share the love of Jesus with parents as well as children through youth club events. A new and exciting club has evolved from Trailblazers – see below.

### Xtra Youth Club

Xtra Youth Club is a brand-new club that we've started for children in year 6 (final year of primary school). The aim is to engage with them through giving them ownership of a club in a new setting/style before they start secondary school. The hope is that then attendance will continue in their teenage years. We currently have 26 members with over 20 attending each week children attending each week. Our lastest ventures have been an evening outing to 'Adrenaline' trampoline venue in Plymouth, a BBQ night on the moors and a games evening on the moors.

<u>School assemblies</u> continue to be both great fun and a blessing with 22 assemblies each term across 11 local schools. Each school assembly includes a song, challenges, story and prayer and each has the overarching aim of sharing the message of God's love for everyone. Assemblies continue to be an exciting opportunity to share the gospel with not only the children of Tavistock but also their teachers. School assemblies reach over 1400 children twice every school term and schools continue to be excited about inviting us to visit them.

**Easter S:CAPE Holiday Club** Easter S:CAPE was a fantastic God-centred day full of challenges, fun, games, team time and teaching based on the good news of Jesus. Nearly 70 children attended and more than 20 volunteers served.

**The 9:15 Service** remains a lively event that we regularly invite families to attend. Please do invite families that you think are in a position to receive through this outreach. God continues to bless the weekly 9:15 event and we continue to look at ways to take people forward not only through it and within it but also outside it. Thank you to all who do so much at the 9:15. If anyone feels called to serve at this outreach service please do contact me.

**Messy Church** continues to flourish with a very dedicated team of people facilitating it. It has been really encouraging to see many new families and people of all ages sharing in crafts, a celebration (story, songs, prayer, talk), a meal for everyone and of course lots of fun and fellowship. Messy Church is centred on sharing the message of Jesus and is a great opportunity for people of all ages to both serve and receive together. It runs on the second Thursday of each month from 4.30-6.30pm – whatever age you are you are welcome to come along. At present, 90 -100+ people attend each Messy Church.

### School visits

Due to various circumstances outside our control we have not provided sessions for local schools since Christmas. We are in contact with schools, we offer sessions each term and we look forward to welcoming children to TMC for events in the future. We enjoy sharing the love of Jesus with the children of local schools through facilitating the RE curriculum in activities at TMC.

### 10:45 Service

It's great to see an increasing number of children and families attending the 10:45 service. The all age nature of the first 15 minutes is really blessing the children, young people and families that attend. We continue to try our best to ensure that everyone in the church understands that everyone must be honoured during this time. Recent all age services and contributions to the 10:45 such as Mothering Sunday, Easter Sunday, Fathers' day and the S:CAPE presentation were widely enjoyed.

<u>Children and Youth Council</u> - This consists of members of our Sunday morning children's and youth groups meeting once a term to share their views, ideas and experiences of the working of their church. Their views are recorded and taken forward by the Family Work team to stewards, church council or other relevant bodies. Our next meeting is planned for July.

<u>Safeguarding</u> - This remains a priority in all areas of the church and an area that the family work team take very seriously. Role descriptions, taking up references and completing DBS checks for volunteers is now a common part of our role. We have recently revised and updated all role descriptions. Thank you to David Benzie for all his work in this area as TMC Safeguarder and thank you to all volunteers who complete this vital paperwork.

<u>Families</u> – as a team we aim to maintain good contact with families who attend TMC events or services and provide them with suitable and relevant activities, information and support. This is an important and complex task that is taking an increasing amount of our time. Please pray that our contact with families is well received and accepted.

<u>GDPR & Publicity</u> – Our use of text messaging and group emails is currently in the realms of the GDPR switchover. TMC has adopted the 'ChurchSuite Management System' which once fully up and running will make our publicity not only fully GDPR compliant but also more easily and appropriately targeted. Publicity through schools to regularly publicise events continues as before. God is really blessing the outreach being made by the family work project and opening doors for future contact. The children's page of the TMC website is also kept up to date by the team and serves as a useful noticeboard for events that we hold.

### **NEW ventures**

We're always looking for new ways to serve children and families and we have a few new ideas for the future. One event, in the planning stage for the Autumn, has the aim to celebrate the intergenerational nature of church and to make and rekindle links between ages and groups of the church. If God speaks to you about how we can serve people in new or different ways, please do share this with us.

### Coming up

In addition to our weekly events, coming up we have: school assemblies, S:CAPE Presentation, Family picnic, SUMMER S:CAPE Holiday club, family BBQs and family games night. As we advertise in schools and prepare to share the message of God's love through Jesus please pray for the children, families, volunteers, Family Work Team and the event itself.

<u>Thank you</u> – The Family Work Project is currently coordinated and led by three paid workers but it is run by the TMC congregation. Without you the project cannot spread the good news of Jesus. Thank you to the huge team of volunteers for your support, dedicated service, prayers and hard work towards this aim. We remain excited about what God is doing.

Ongoing contact with and support of the families that we meet and who attend events and services is also a key part of the project and an area that the whole team works hard on across the age bands. This is also an area that the whole church must be involved in as the number of children, families and young people the church is in contact with increases.

On a personal note, it has been a pleasure to have Dave Stranks as the line manager of my Family Worker post for many years. I would like to record my thanks to him for his honesty, support, ideas and encouragement. We will miss Dave and Pam when they leave and pray God's blessing and every happiness for them in their future ventures.
