1.0 Minutes of the AGM held on 25th April 2018

The minutes were agreed as a true record.

2.0 Presentation of Audited Accounts 2017/18

The Treasurer presented the audited accounts, circulated to the Trustees with the AGM papers, and provided an analysis of the deficit of £11,249 on the year's activities. The deficit had been expected as the level of fundraising, and subsequent Gift Aid had fallen during the year. Expenditure remained constant although aromatherapy charges had increased by £2,400 reflecting some increased hours agreed and the contribution toward training costs. Despite the deficit, the Charity's reserves remained strong.

The accounts had been independently examined by Mr Peris Edwards and a copy of the certificate was circulated.

The Trustees approved and signed the accounts as a true record.

3.0 Appointment of Auditors 2018/19

It was agreed to continue to use Peris Edwards again for 2018/19

4.0 HaTS membership

There were no changes to the membership and the Chair and Treasurer retained their positions. It was noted that several staff nurses had expressed an interest in joining the Trustees and this would be pursued.

5.0 Complementary therapist remuneration 2019/20

It was agreed that the level of pay would continue at £14.50 per hour in line with rates of pay at the Christie hospital.

Trustees were advised that the HaTS part-funded Christie appointed complementary therapist post for the Palatine Ward continued to work well.

6.0 HaTS Coordinator remuneration 2019/20

It was agreed that the position of HaTS Coordinator would continue to be remunerated at $\pounds 15$ per hour.


