ST KATHARINE'S CHURCH FINANCIAL REPORT FOR 2018 - CHARITY NO: 1144084

As we close the door on 2018 it is interesting to look back and remember the highs and lows of the previous 12 months and give thanks that, with the support we have had, we have been able to pay our way and ensure that we have all shared in the stewardship of St Katharine's Church.

The balance sheet shows us carrying forward total balances of £91,846.74 mainly due to legacies we have received previously to be used for specific projects, one of which manifested itself in the repair of the chancel floor in the summer. This has resulted in us reporting the excess of expenditure over income of £19,480.50, using £8,600 of the funds held in the Central Board of Finance No 2 account and £12,500 from the Restoration Fund held in the Central Board of Finance No 1 account.

The current account balance on 31^{st} December was £3,012 and the prepayment figure of £4,130 represents the annual insurance cover for church for 2019 which needs to be paid before our year end.

The CBF no 1 account holds the various funds we have totalling £12,742 and we use the money when the need arises.

The PCC are currently looking for an account into which we can transfer some of the funds in our CBF No 2 account to attract a better rate of interest whilst remaining secure.

BREAKDOWN OF OUR EXPENDITURE

Home Charities:

Diane Cashmore has organised the collecting boxes for the Children's Society again this year which brought in £539 and, along with the team, organised a successful Christingle service and the collection raised another £144.

Collecting boxes for the Church Urban Fund raised £106 and if you would like a box please contact Janet Hollick.

Bob Chapman continues to take our grub tub offerings down to Urban Outreach in Bolton and they have been very grateful for our food donations and for all the socks etc given this year.

The collection on Remembrance Sunday raised £332 which was passed over to the British Legion.

Overseas Charities

Lent boxes for USPG raised £220 last year and many thanks to Ruby Parr for organising the collection.

The Harvest collection raised £698 for Sightsavers following an excellent, moving presentation delivered by Janet Hollick and thanks to Peter Wynne for his help with the technical bits!

No collections from the confirmation service etc this year as they have been held elsewhere in the team.

Church

Extra <u>cleaning</u> was done following the chancel repairs and we are grateful to all who turn up on the dedicated quarterly sessions as well as remembering the regular volunteers who keep church spotless on a weekly basis. Sincere thanks to Sylvia Gregory and Sheila Kinrade for getting us organised!

The <u>electricity and gas</u> bills for the upper room are almost identical in comparison to last year so the new contracts negotiated for us by the Parish Buying Scheme are working well. The <u>church heating</u> shows the cost of heating the main body of church which was up by £400. The reason for the increase is that our direct debit had to be increased in the summer as it would not have covered our projected costs for the rest of the year. We are using more gas as church is open every Saturday morning and also due to the Beast from the East and a particularly long cold spring. We should bear in mind that for the church to be "warm" for 10am

the boiler has to start at 3am. Thanks to Janet Hollick and George Hibbert for setting the heat week by week and keeping us reasonably warm!

The <u>bellringers</u> opted not to take their gratuity last year; the <u>insurance</u> and <u>kitchen</u> are all around the same. The highest expenditure in the <u>maintenance</u> costs last year was £511 for flags; £250 for PAT testing; £398 to Guardian Technical for visits and maintenance for the fire alarm; £288 to Thermal Heating for boiler checks and maintenance; £140 for gutter clearance and £100 for the boards and roof slates to be checked – totalling £1687. The rest of the costs were general maintenance expenditure amounting to £545.

Office costs are up by £450 - £186 for the repair of our autobookie stapling machine and BT payments by £222. This seemed high so we have now renegotiated our contract with BT and this should reduce our expenditure in the current year.

The <u>water rates</u> have rocketed this year and it would appear that we are being charged for our surface water entering the main drains which it doesn't do - it is taken off through soakaways. United Utilities tested this some years ago, found this to be the case and capped our charges. We are in discussion with Waterplus who will have to do a retest and hopefully this will reduce the fees by the end of this year.

Churchyard

<u>Wages</u> were down due mainly to the very dry summer which meant only 10 cuts were necessary and our grasscutter, Jonathan Bowker, had a technical problem with his mower at the end of the cutting season which is why the back of church was never completed. It is hoped that mowing will recommence in March.

The <u>maintenance</u> covers the cost of hiring a skip and employing Westgate diggers to get the tree roots out at the bottom of the graveyard. Thank you to all who helped with the manual labour on that day! All our churchyard expenses were covered by an anonymous donation of £1,000 and other donations which all amounted to £1,105.

Diocese

Once again we were able to play our part in the Manchester Diocese by paying our parish share in full. This was helped by receiving £1,000 from the Diocese as we paid in full in 2017 and we should receive a similar amount in 2019 as we paid in full again last year. We have had a review by representatives from the Stewardship group in the Diocese and the figure for 2019 has only increased by £280.

Funds

Memorial Fund

We started 2018 with changing our hymn books at a cost of £2,106 and finished the year by replacing the chair lift which was £1,199. The old hymn books have started a new life at St Paul's Cathedral in Blantyre, Malawi, and all the dedications have been transferred to the new books. Other expenses paid from the Memorial Fund are:

Restoration Fund

The whole of the figure in the accounts was the cost of the repair of the chancel floor and consequent fees £25,027.48

As a charity it should be remembered that we received a £3,932 refund from HMRC after the work was completed and shows as part of the restoration income.

<u>Ministry</u>

Angela can claim for small $\underline{\text{maintenance}}$ jobs to be carried out at the vicarage and this year decided to spend it on much needed tree clearance costing £250.00.

The PCC had two training days costing £54 and seminar tickets for two amounted to £11.64.

Angela attended a bible study course in Cambridge and her travel was £152.

Council tax and water rates for the vicarage amounted to £2,770.80 so much the same.

Working expenses mainly travel costs and telephone bills amounted to £1,237.70 but since Chris Bracegirdle moved on, these expenses have been shared between the team as Angela has covered so many services. These expenses form part of the refund you will see in the income section of these accounts.

<u>Organ</u>

We continue to feel very blessed to have Garyth and the choir in our midst to celebrate week on week at St Katharine's and long may it continue. The organ has been tuned three times this year amounting to £690 the extra one followed the work done in the chancel - and Garyth and three visiting organists have received fees throughout the year.

Parish expenses

Coffee shop We are pleased we have been able to maintain our links with Fairtrade this year and the coffee shop was well supported once again. Funds received on Sunday mornings also pay for drinks provided at other occasions during the year. Sincere thanks to the coffee shop team who reliably turn up and do their bit. Expenses for 2018 amounted to £385.51 and donations amounted to £485.29 showing £100 profit.

Fundraising

We have had some memorable events throughout the year and it is wonderful to see the amount of support from the whole of the community as well as the loyal congregation at St Katharine's. Sincere thanks to all who have worked so hard to achieve this result.

Expenses amounted to £4,121 which included a £500 donation from the monthly coffee mornings to the cost of the chancel repairs. So with an actual spend of £3,621 and an income of £11,417.88 the events have raised £7,796. The breakdown is:

Floats used at the events amounted to £2,150 during the year and are shown in the income and expenditure columns.

Gratuities This year we celebrated four 80th birthdays with members of the congregation and a Golden Wedding. After another stint as Churchwarden we presented Rob Sharp with a gift and our sincere thanks.

Also Ruth Wills handed over the organisation of Sunday School and we are very grateful for all the encouragement and time she has given to our youth. A leaving token was given to David Cieszynski as he ended his Lay Leader training with us, and a welcome gift for baby Leah Screeton at Wingates. Our best wishes also went with Chris Bracegirdle as he left the team and moved to Bolton Parish Church.

<u>Machine rent</u> and consumables are as expected as are <u>stationery</u> costs and <u>stewardship</u> renewal.

<u>Magazine</u> covers the cost of Crux and the invoice was not received until mid January and amounted to £552 the same as last year.

Postages were up slightly as a top up was needed in December.

Sundries are odds and ends that don't fit anywhere else!

Fees paid away are fees paid to us for weddings and funerals throughout the year which are then paid to the verger, organist and bellringers where applicable.

<u>Fees</u> paid to us but due to the Diocese from the above services are sent on every month and fluctuate with the amount of services carried out.

<u>Prepayments</u> as explained is the insurance premium for 2019 and whilst it has to be paid before the year end it is not part of the 2018 figures.

<u>Upkeep of services</u> - <u>altar requisites</u> cover the wafers and wine used throughout the year. <u>Books</u> purchased this year were a communion register, lectionaries and diaries, Churchwarden year books and the Silence and Follow the Star booklets.

Sundries is the cost of oil and candles which has increased this year to £838. Also shown here are the costs of the Easter experience - £155; Mother's Day gifts from Sunday School - £61 and the Christingle expenses - £132. The candle money is offset from the candle tray donations which this year increased by £100 to £440.

Youth – the book presentation expenses and prizes amounted to £175 and, as less children went on the panto trip, our donation for half the cost only amounted to £78.

The total expenditure for 2018 was £117,997

BREAKDOWN OF OUR INCOME

Charities already discussed

Fees were lower this year as the numbers were less – 2 weddings: 1 banns read: 21 funerals: 2 burials of ashes.

<u>Interest</u> - with the chancel floor repair on the horizon the PCC made the decision to withdraw the J S Hodge bond on maturity and put the funds into the No 2 savings account in case of need. So the interest on the No.1 and No.2 savings account, with interest at 0.55%, is obviously lower and we need to find a safe place to invest the remainder of the funds we now hold.

The <u>fees</u> for the Diocese match those shown in the parish expenses.

<u>Magazine</u> - The magazine adverts and magazine sales were slightly down last year but it continues to be a great communication tool and thank you to Mary for putting together all the articles month by month.

Planned giving – gift aided donations have dipped again slightly but the non gift aid is slightly up. The one off gift aid donations are down by £900 and this has resulted in a lower amount that Chris has been able to claim back from HMRC. It is still a significant amount and sincere thanks to Chris for continuing to administer these claims so diligently. We may need to look at an alternative method of collecting these donations this year.

Regular realistic giving is vital for the future of our church and we all have a role to play in the stewardship. We give our time whenever we can which is also so important and saves employing people to carry out tasks that we can do between us. However, our bills need to be paid so if you can please try and review your giving on a regular basis. 100 people giving an extra £1 a week gives us £5,200pa plus gift aid – food for thought indeed. Sincere thanks to those who do review their giving it is deeply appreciated. If you have any questions about the stewardship scheme or gift aid please have a word with Jean Hibbert or Chris Skinner.

Restoration income has come this year from a regular donor and we are grateful to them for their regular support. The VAT refund for the floor was £3,932, Senior Moments and the Coffee Morning gang both gave donations towards the repairs – thank you to you all.

The organ fund donations trickle in throughout the year and we are grateful for your support.

Voluntary income:

Bellringers fund this themselves and helps with travel costs to other towers.

<u>Candle money</u> – donations always welcome – this year £440 came in against a total spend on oil and candles of £1,000.

Churchyard fund; coffee shop; floats and fundraising all previously mentioned.

<u>Donations</u> were boosted by a very kind donation of £1,000 and we thank everyone for their support once again. The demijohn collected £207 throughout the year and Blackrod Town Council have paid £150 towards the upkeep of our clock.

Other donations came in from Stitch and Knit, Blackrod Scarecrow Festival and Senior Moments.

<u>Heat donations</u> come from the weddings and funerals held in church during the year. During the summer we offset the grass cutting from these donations when heat isn't needed.

 $\underline{\text{Memorial fund}}$ received £4,030 – the increase due mainly to the extra dedications in the new hymn books and gifts in memory of loved ones.

<u>Plate collections</u> were down by £1,100 which is huge so this is an area we need to investigate and see how we can increase this figure – it is at its lowest level for 5 years.

<u>Refunds</u> totalling £1,648 came from the other churches to help with Angela's expenses and the rates on St Katharine's vicarage during the interregnum in the team.

The <u>room hire</u> of £900 was mainly paid by the Pilates class who meet upstairs every Monday. The figure is lower than last year as the brownies moved to the Methodist Church at the end of 2016 when they needed a larger room.

 $\underline{\text{Sundries}}$ – one wedding video fee of £35, and the duplicated wedding fees of £295 shown in the sundries expenditure column as a refund.

Other fees represent those paid for the verger, organist and bells.

The Youth section are fortunate to receive annual donations from Blackrod Educational Trust but in 2017 there was a delay in payments being made so two donations are showing in the 2018 accounts. We wish them well as they move forward with the new leadership team.

The total income for 2018 was £98,517

My personal thanks once again to the Churchwardens and Sidespeople for their weekly commitment in organising the banking which has been particularly difficult this year following two bank closures. To Chris Skinner for his supreme efforts during the last year, particularly in keeping abreast of the gift aid claims for us, and to Bob for ensuring our insurance cover is as it should be. Thanks as ever to Joan Trevena for giving her time to audit our books and keep me on the straight and narrow!

Behind every balance sheet there are many, many hours of voluntary help which keep our expenses as low as we possibly can and for that we are truly grateful.

On the income side we must remember all the people from this community and beyond who visit and support us on many different occasions and for lots of different reasons. Because of what is given to St Katharine's in time and financial support we are able to thrive and grow and ensure that this meeting place will be here for the people of Blackrod for many years to come.
