## Trustees Annual Report for the year ending 31March 2018 : Zawia Naqshbandia Mujaddadia Trust. Charity Reg. No. 1127520

As per the trust's stated constitutional objective 3.1 to acquire a building to enable us to deliver services necessary for the local Muslim community, e.g. to meet their religious / spiritual and social needs given that the community has significantly increased over the decades and their needs has become ever more demanding. In this regard the trustees have been actively looking for suitable premises to provide co-ordinated range of services for both young people and the elders. However, after a long search for a desired asset we finally succeeded in purchasing the church building known as the Eastwood Methodist Church in Central Rotherham in 2018.

The trustees had to face tough competition from rival groups but in the end were successful in acquisition of the asset. It has to be stated that our supporters and donors were very good in their generous support for the project. However, trustees used a variety of fund raising strategies, for example, collection from individuals, Mosques' congregations and live TV appeals etc. all this made it possible, and it's a great credit to our supporters for their relentless support for the project they thought was worthy of their support. The trustees are of course very grateful for their support and their confidence in our ability to make things happen. The trustees believe that the asset acquired will allow them to satisfactorily fulfil their stated objectives from 3.1 to 3.7 inclusively.

Also, currently we are working with the organisation in Sheffield known as Pay back, which is providing building renovation service free of charge on the basis that we are a charity and that we provide materials. They are currently carrying out the renovation work which could take good few months given that part of the building is fairly old. Once the work is done then of course real delivery work will start. Presently, the building is partially being used for over 50s healthy living keep fit exercises. Other local groups use it for their consultation meetings.

The trustees are mindful of their responsibilities and are therefore, taking at all times necessary precautions for health and safety of their users. Moreover, public liability insurance is already in place.

Currently there are no paid staff in the organisation, and we continue to both develop further policies and procedures with respect to health and safety and find new ways of generating income for the centre for long term sustainability.

The trustees are satisfied with their progress to date but continue to look for improvements where ever possible; and hope to carry out regular public / user consultation exercises to understand and gauge their needs/interest.

Trustees are hopeful that the facility will become fully functional in the latter part of the year; our services are open to all sections of communities living in the area and further afield.

We are also supporting the development of new Jamia Mosque in the remote village Douar Rhamma which is about 45 KM from Morocco's ancient city of Fez, and Meknas, it should be ready for public use in the near future. Likewise the trust has supported a village public library in Bathrui, Dadyal, AK, Pakistan, first of its kind in the area; and Amman Girls College in Mirpur, Pakistan, catering for young women from deprived families/neighbourhoods. The Trust has also been active and continues to address acute poverty issues in poor neglected neighbourhoods.

Finally the trustees would like to thank and pay special tribute to all those who have supported the programme in whatever shape or form during the fund raising exercises and the post asset acquisition without which the project would not have been possible.
